one of their own ports, to be
disposed of by a prize court.

That is slightly off color from
the standpoint of international
law (which, of course, is only a
sort of gentlemen's agreement, bas-
ed upon a long series of preced-
ents and open to the present
grave weakness that war is no
longer a gentlemanly business.)

The Germans can sneak through
the North sea blockade from time
to time with surface vessels, but
they are obviously afraid to try
to take a vessel seized as a prize
through the blockade.

THE really BIG POINT is that
America should refrain com-
pletely from becoming excited or an-
gry over the incident, which is
merely a part of the risk that must
be assumed by those who trade
with nations at war.

25 Years Ago Today

Bulletins in
ROSEBURG REVIEW

PARIS.—The French offensive
in the vicinity of Nancy has driven
the Germans across the frontier in
the direction of Metz, announced
the Bordeaux war office this af-
ternoon. That the Kaiser is
crumpling up the allies right be-
tween Toul and Verdun was de-
nied.

LONDON.—"It is reported from
Berlin that a new type of subma-
rine is being built at Eilbing and
Hamburg to be used only for the
transportation of troops, the ob-
ject being to reach a shore unnoti-
ced and land troops."

PARIS.—The west bank of the
river Yser, between Nieuport and
Dixmude, is literally an inferno.
Already across the stream the
Germans are hurling every ounce of
strength against the allies' front
in a determined effort to break
through toward Dinard and Cal-
ais.

NORFOLK.—The destroyer
Spaulding, with 60 men on board,
saw driven before two miles west
of Cape Henry in a 60-mile gale.
Lifelines are trying to reach them.

WALLACE CHIEF FOR 3RD TERM TALK

WASHINGTON, Oct. 26. (AP)—
A White House secretary said
today Secretary Wallace should
have consulted President Roose-
velt before advancing his candi-
dacy for a third term.

Informing of Wallace's statement
in San Francisco and asked for
comment, Stephen Early, press sec-
retary, said:
"It would have been kind and po-
lite of the speaker to have con-
sulted the victim before he spoke."
"Is the victim the president?"
a reporter asked.

"He the third term subject of the
statement," Early replied.
Told reaction to Wallace's re-
marks at the capitol had been
somewhat critical in view of ad-
ministration requests that politics
be adjourned during consideration
of neutrality legislation, Early
said:
"It could have been lined better
if he had had time at all."

Wallace said in an interview Eu-
rope's war had made plain the de-
sirability of a third term for Mr.
Roosevelt. He added the presi-
dent's background "seems to equip
him with exceptional qualifications
as a betman to steer the country
through both foreign and domestic
troubles to a safe harbor."

UTILITY ARRANGES FOR SALE OF BONDS

NEW YORK, Oct. 27. (AP)—
The Northwestern Electric Co.,
controlled by American Power &
Light Co., has arranged for private
sale to a group of insurance com-
panies \$5,000,000 of 4 per cent
bonds, it was announced today.

The proceeds, it was explained,
are to be used to pay arrears on
the company's 7 and 8 per cent pre-
ferred stock, amounting to \$1,057,
000, and for redeeming outstanding
6 per cent bonds.

It was announced the com-
pany had sold to American Power
& Light \$5,000,000 of 1 per cent
debentures to refund a \$500,000
demand loan of \$2,500,000.

The operating company serves a
large part of Portland, Oregon, and
Vancouver, Washington.

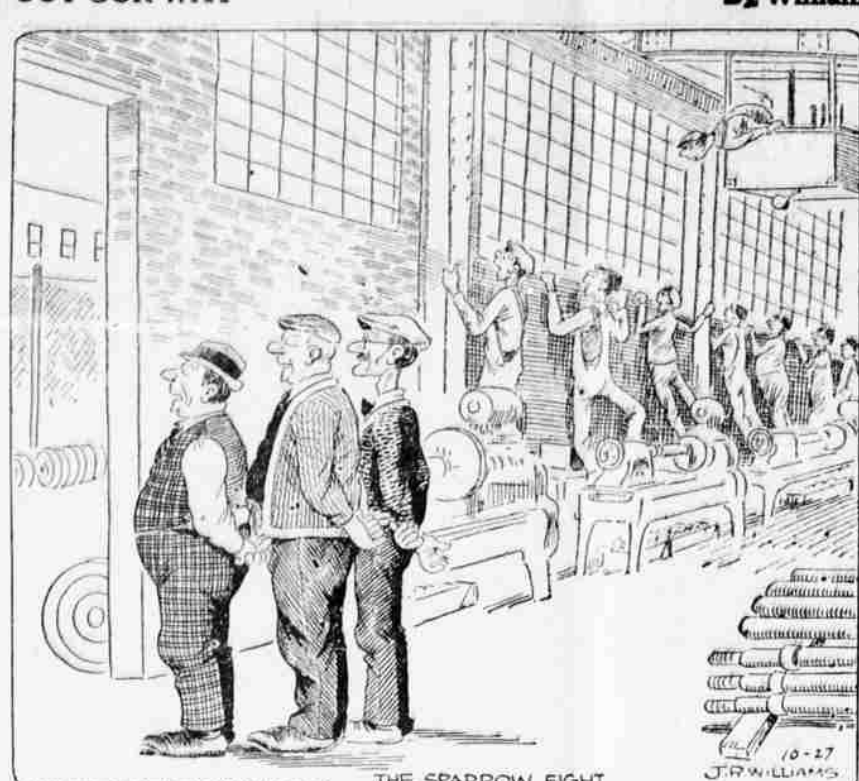
GIRL SCOUTS GET HELPFUL HINTS
