TOOTH EXTRACTION SUIT Won by Hospital Assn.

SALEM, June 18.—(AP)—The state supreme court today absolved the Industrial Hospital association of Portland from blame in a damage suit filed by James A. Feazle, Tillamook county logging operator, and it permanently disbarred William W. Harcombe, attorney who was sentenced to two and a half years in Lane county for forging an \$800 check.

Feazle, who had a contract with the hospital association for medical service for himself and his employees, sued the association, and Dr. William A. Roberts, Portland dentist, for damages in connection with a tooth extraction.

Feazle claimed he received improper treatment after the extraction and that an abscess on his left lung was the result.

Circuit Judge Pro Tem Walter L. Toole of Portland dismissed the suit against the association, and a jury in his court exonerated the dentist.

Toole then granted a new trial in the case against the association, but the high court, reversing Toole today, held that there should not be a new trial.

Russia Colonizing Near Alaska, Delegate Hears

WASHINGTON, June 17.—(AP)—Delegate Dimond of Alaska told reporters here he had been informed Russia was settling thousands of persons on Big Diomed Island in Bering strait, five miles from Little Diomed Island on the American side of the international line between Siberia and Alaska.

The delegate said his information was that the island formerly occupied only by Eskimos, was being colonized in a "big way" and added that the Eskimos were becoming alarmed at the influx of Russians.

Dimond said he had been informed by army officials that they intended to send to the Anchorage airbase, recently authorized by congress, an additional 3,100 troops of various types. The war department recently announced a battalion of 750 infantrymen had been ordered to Anchorage.

One Facility Entrance to Close During Road Work

The entrance to the U. S. veterans facility from the West Roseburg side of the river will be closed for one week, starting at noon, Wednesday, June 19, it was announced today. The closing is necessitated because of road improvements. A crew will start tomorrow to pave the road with an oil macadam surface. It is estimated that the work will be completed and the entrance from the Roseburg-Melrose road reopened Wednesday, June 26. During the ensuing week all cars entering the reservation will be required to use the entrance from the Garden valley road.

Condemned Murderer Refuses to Comment

PORTLAND, June 18.—(AP)—Clare E. Cline, 46, sentenced to die July 26 in Oregon's lethal gas chamber, refused to comment on his predicament in the Multnomah county jail yesterday.

"What's the use," he said, "I'm convicted of the first degree murder of my mining partner, George Chetty, 35, in Wheeler county's Spanish gulch mining district, was en route to the state penitentiary at Salem under guard. Circuit Judge Hendricks at Possil sentenced him yesterday."

Cardinals Rally Under New Boss

Five Victories in Row Posted Since Billy Southworth Took Charge of Team

The St. Louis Cardinals may not be going anywhere, but they're unquestionably going there fast.

Since Billy Southworth ascended the throne to the managerial post last week the club has won five games and hasn't been beaten. But the Cards were in such desperate circumstances to begin with that this spectacular streak hasn't been spectacular enough to get them out of the National league's second division and they'll have to keep going at a good clip to overtake the Chicago Cubs who are five games ahead of them.

The Cards created quite a bit of commotion yesterday by blockading the Brooklyn Dodgers 3-1 and enabling the Cincinnati Reds to regain first place.

While this was going on the Reds reaped a 6-2 triumph at Philadelphia to take a full game jump over the Dodgers and also shove the Phillies into the National league's cellar. Whitely Moore, reeling Vandermeer with two on and none out in the second inning and gave up only two hits in eight innings of excellent hurling.

Paul Dean Beats Cubs. The New York Giants got back on the winning track and moved within a game of second place when Paul Dean continued his mastery over the Chicago Cubs by a 2-1 score. The durable Dean, who held the Cubs to four hits in making his first start a week ago today, permitted no hits at all until the fifth yesterday and just six in the game. The Boston Braves benefited from two six-hit performances by Poseid and Plechota in sweeping a doubleheader from the Pittsburgh Pirates 5-3 and 5-1.

The stunt was sufficient to boost the Bees from eighth to sixth place in one hop. The American league had an idle day.

All Non-Citizens of U. S. Will Be Registered

WASHINGTON, June 17.—(AP)—Attorney General Jackson pledged "greater strictness" and "increased vigilance" in the treatment of aliens today, and called also for a registration "of all non-citizens who are in our midst."

Addressing the immigration and naturalization service employees, who come under the justice department's control today, Jackson said that the doctrine that any person may come to the United States "unless it is shown that he is a menace must at least temporarily yield to the policy that none shall be admitted unless it affirmatively appears to be for the American interest."

He cautioned, however, against "hateful or unjust treatment of loyal non-citizens" lest it have the result of making them the prey of those who would organize a "fifth column here."

Heretofore the immigration service has been in the labor department.
