MARKET REPORTS

WOOL. BOSTON, July 12.—(AP)—The Commercial Bulletin will say tomorrow: "The wool market has been well high stagnant this week. Sales have been few and far between and usually for off sorts or specialties, the sale of which did not typify the market but which evidently indicated a softer price basis, especially for the finer wools."

"Medium wools keep reasonably firm, although it is not easy to get 40 cents delivered for medium Ohio-Michigan or Missouri country packed. A bid of 38 cents, however, was rejected. Medium fine and half-blood average wools have been taken in Monday this week in the range of 75 to 80 cents, clean basis, at Boston, and some choice staple New Mexican at 80-82 cents, clean basis."

"Civilian goods trade is still disappointing and the mills with government orders appear to be well covered against current requirements."

"Offerings of South American wools are less produced, although a fair weight of various off types of wool have been bought for import at relatively low prices which usually go to European consumers."

"Mohair is a bit soft, too. Sales in Texas of 50,000 pounds are reported at 50 and 60 cents, respectively, for adult and kid and a like quantity at 21 cents less for each description."
