Every state, county and city
official or board that handles
public money should publish at
regular intervals an accounting
of it, showing where and how
each dollar is spent. This is a
fundamental principle of demo-
cratic government.

UNTIL only recently the problem
of defending the United
States from attack was never very
seriously considered. More particu-
larly, the problem of defending the
western portion of the country is
in the spotlight for just about the
first time.

Why should this be the case now
when we have had no such worry
before? There are two good an-
swers to that question. In the first
place, war is different now. Planes
and other mechanized units being
used change the picture from a
military point of view. Military
men are inclined to the thought
that a successful invasion of our
country west of the Rockies might
be made. Secondly, there is no tell-
ing what the axis powers may de-
cide to do if they get desperate
enough. One of their problems will
be to occupy our attention so that
we will not be able to render so
much aid to Britain. It seems that
could best be accomplished by at-
tacking through Mexico as was
planned during the former world
war, or an attack by Japan.

It may be said that neither of
these two attacks is likely at the
moment but we must admit that
either or both of them is definitely
possible.

For defense we are in the process
of building a great army. We are
manufacturing motorized equip-
ment. We are going to put the
army on wheels. Then what?

To defend the Pacific coast, army
units must be able to move rapidly.
So long as the two bad Pacific
highway bottle-necks—between
Roseburg and Grants Pass, and be-
tween Portland and Centralia,
exist, our army on wheels cannot
function.

For example, how could mechan-
ized troops, coming to the rescue
from posts in California, Utah and
the mid-western states, get them-
selves through the bottleneck that
blockade every section of the Pa-
cific northwest? They would be
completely bottled up before they
ever got within striking distance of
the enemy.

But from Washington, D. C.,
comes the report that defense
highway construction will all be
handled by the WPA.

We believe that the various
state highway commissions and the
Bureau of Public Roads, agencies
that have been cooperating for
many years, should continue in
charge of road problems and road
construction—not the WPA admin-
istration.

Be that as it may, one thing is
certain—however it is determined
by the administration that the de-
fense roadways will be built—
whether by WPA or otherwise, it is
not a project that should be under-
taken by hand labor for the pur-
pose of creating work first and for
defense second.

No matter how the job is done it
should be done in the most effi-
cient manner possible. Every
known road building device and
machine should be used and the
work should go forward with all
possible speed and efficiency so
that the Pacific coast will get the
most miles of defense highways for
the dollars spent.

First of Oregon Draftees to Come From 5 Counties

SALEM, Nov. 12.—(AP)—Five
counties will supply 10 volunteers
who will report in Portland Novem-
ber 18 to be inducted into the
army for a year's training. Lieut-
enant Colonel Elmer V. Wooton,
state director of selective service,
said today.

An additional 43 men also vol-
unteers from counties which have
not yet been announced, will re-
port to Portland two days later.
All Oregon men will be taken from
Portland to Fort Lewis, where
they will receive their army as-
signments.

The 53 men are the first instal-
ment of Oregon's quota of 2,896
men to be inducted within the
next year. However, since 399 of
the draftees in the state have volun-
teered, there will be no drafting
for some time.

The 19 men in the group to re-
port 18 were taken from counties
which reported first with the largest
number of volunteers.

The following local draft boards
will contribute five volunteers
each: Benton county, Klamath
county No. 1, Klamath county No. 2,
Lane county No. 1, Lane county
No. 2, Linn county and Multnomah
county No. 2.

Multnomah county board No. 1
will provide three men and Lane
county board No. 2 will contribute 2.
Each board contributing volun-
teers will receive credit toward
its quota for the next year. The
quota will be assigned soon by
Colonel Wooton.

U. S. Recognizes Camacho; Defense Pact to Follow

WASHINGTON, Nov. 13.—(AP)—
Formal recognition of Mexico's
new president-elect and reports of
intensified efforts for hemisphere
defense collaboration gave evidence
today of continuing administration
pre-occupation with matters per-
taining to pan-American solidarity.

The recognition of General Avila
Camacho as the Mexican president-
elect had an unusual aspect, for it
was accompanied last night by the
announcement that Henry A. Wal-
lace, vice-president-elect of the
United States, would represent this
country at the Camacho inaugura-
tion in Mexico City, December 1.

Mexico's presidential election
had been in dispute, and the an-
nouncement of Camacho's recogni-
tion was the first government ex-
pression here on the controversy.
In Mexico, the action of the United
States was received as welcome
news, with special gratification
manifested at the appointment of
Wallace.

Defense Pact Likely.
Mexico, however, apparently was
only one of the Latin-American na-
tions to figure in state department
consultations yesterday. Secretary
Hull, Secretary of War Stimson and
Secretary of Navy Knox conferred
for almost an hour and it was be-
lieved in well-informed quarters
that hemisphere defense provided
the major topic.

The progress of conversations
with Mexico on this subject was
indicated by the recent prediction
of responsible Mexican sources
that "in all probability" a mutual
defense agreement would be no-
tified with the United States
about January 1 along the lines of
the present U. S.-Canadian under-
standing.

The state department disclosed
that Mr. Roosevelt had invited
President Vargas of Brazil to visit
this country and that Vargas had
accepted tentatively.

Paul Prichard, president of the
Central Bank of Argentina, arrived
to open conversations with bank-
ing authorities here on the ques-
tion of a solution of Argentina's ex-
change problem.

PACIFIC COAST DEFENSE TOPIC OF CONFERENCE

SAN FRANCISCO, Nov. 12.—
(AP)—The Canada-United States
defense commission confers with
army and navy officers here today
on the problem of defending the
Pacific coast of North America.

Mayor F. H. LaGuardia of New
York City and seven other mem-
bers of the joint commission arrived
here last night by plane, joining
four other commissioners who came
Sunday and have been inspecting
defense installations in the bay re-
gion.

After a general survey of the
west coast defense problem, with
particular attention to situations
which may develop because of Ja-
pan's alliance with Germany and
Italy, the commission will proceed
to the state of Washington and British
Columbia to look over the de-
fense set-up in that region.

Speech of Willkie Evokes Approval

WASHINGTON, Nov. 12.—(AP)—
Wendell L. Willkie's declaration
that the republican party must func-
tion during the next four years as
the "loyal opposition" of President
Roosevelt's democratic adminis-
tration evoked expressions of ap-
proval today from many republicans
in congress.

Senators Taft (R., Ohio), Van-
denburg (R., Mich.), and Townsend
(R., Del.) all said they favored the
general principles enunciated for
the party by Willkie, its defeated
presidential nominee, in a broad-
cast speech last night.

"I think his statement of the gen-
eral position of the republican
party is excellent," Taft said, and
Vandenberg declared the speech
was "in accord" with Vandenberg's
own conception of his party's func-
tions.

Senator Minton of Indiana, the
senate's democratic whip, declared,
meanwhile, that Willkie's speech
in defeat was "the best one I've
ever heard him make."

"It was in good temper," he ad-
ded, and contained some good sug-
gestions."

Townsend said the address "was
very good."

None of the senators said they
regarded the speech as a bid for
the 1944 republican presidential
nomination.
