Return of Empty Bottles Needed to Get Milk Dictum

Roseburg milk dealers announced a new ruling on credits and return of empty containers today to conform to OPA regulations, the changes to be effective Monday, March 1.

Hereafter credit will not be extended for a period of more than 30 days following the date for which the statement of account is submitted. Milk deliveries will be halted immediately if bills are not paid within the prescribed period, it is stated.

The "no bottle no milk" rule also is to be rigidly enforced, the distributors state. Consumers must place out for collection an empty bottle or no full bottle will be left. If for any reason empty containers equal to the number of full bottles of milk cannot be set out, the distributor should be notified and advised when the containers will be obtainable for collection.

Distributors point out that these rules are necessitated by OPA regulations and must be strictly enforced.

Army Shotgun Buy Is Extended in Roseburg

The campaign to purchase 12-gauge shotguns for the army has been extended in Roseburg until March 2nd.

On that date T. A. Miller of the San Francisco ordinance district, will be in Roseburg and pick up the guns which have been turned in by hunters in this vicinity.

The army wants the guns, only the pump and automatic types, not double barrels, for use in guard duty in this country. For guard duty the sentry guns have proven superior to rifles, especially at night, and each shotgun purchased by the army will release a rifle for combat duty.

The army will pay up to \$30 for the guns and they may be turned in at any Western Auto Supply store or agency. There they will be appraised and the seller will be given a receipt. He will receive the money for the gun a few days after Miller picks them up.

Roosevelt III With Intestinal Upset

WASHINGTON, Feb. 26. (AP)—On his physician's advice, President Roosevelt remained in his White House quarters again today trying to shake off an intestinal upset.

"I'm glad to be able to tell you," said William D. Hassett, assistant presidential secretary, "that the president is somewhat better."

Hassett said he thought the president was not even doing any business over the telephone, because what Mr. Roosevelt needs is rest and relaxation.

Cunningham Home at Glendale Razed by Fire

GLENDAL, Ore., Feb. 26. A residence building, occupied for more than 20 years by Mr. and Mrs. Roy Cunningham, was destroyed by fire Wednesday evening. The fire, which started on the second floor of the building, was discovered about 5:45 p. m. Volunteer workers succeeded in removing the major portion of the household goods.

MARCH IS RED CROSS MONTH!

EDITORIAL

PRESIDENT ROOSEVELT has designated March as "Red Cross Month." During March the American Red Cross War Fund appeal will be conducted throughout the nation. Hundreds of volunteer workers in cities, towns, and crossroads hamlets will offer every American an opportunity to contribute to the Red Cross and its work.

In peacetime many persons have been satisfied to become members of the Red Cross by subscribing the minimum membership of one dollar. Surely, this year, few of us will be content to make such a contribution. Global war, which has made necessary the dispatch of a dozen A. E. F.'s to the far corners of the world, has multiplied many-fold the work of our American Red Cross.

Wherever United States fighting men go, there, also, the Red Cross goes.

It is our sincere belief that if the public realized the extent of the job being done by the Red Cross, it would not need to be asked for a contribution to this worthy cause. The greatest "selling point" for the Red Cross is the work it does.

Today the American Red Cross is the only non-military organization operating within military and naval reservations. It is the liaison between the people and the soldiers who fight to defend them.

Here are only a few of the things that the Red Cross is doing for the soldier who may be your husband, your son, or your neighbor:

At home and on foreign soil, Red Cross field directors—sometimes called "trouble busters"—are ever present, offering friendly counsel and assistance to servicemen in personal and family problems. For soldiers with our expeditionary forces, Red Cross overseas clubs for servicemen are a touch of the America they love so well transplanted to foreign soil. In the midst of the opening phases of the Battle of the Solomons, Red Cross personnel were with our marines, distributing cigarettes and comfort kits as a reminder that we, the American people, were there beside them. For more than one serviceman, the Red Cross has been the only means of communication between him and his family.

It has provided recreation for fighting men convalescing from sickness and the wounds of battle. Red Cross volunteers by the millions have produced surgical dressings by the tens of millions for our soldiers. In the form of food and medical supplies, the Red Cross has brought hope and succor to the victims of war and to our allies. Wherever disaster has struck within our own boundaries, it has extended its assistance, always without being asked to do so.

That is the American Red Cross—an organization of the people doing for the people what no other organization can do. It has been truly named "The Great Mother."

And that is why the Red Cross is worthy of your larger contribution in this second year of war.

Barney Ross Tells Of Heroic Battle On Guadalcanal

SAN DIEGO, Calif., Feb. 26. (AP)—Barney Ross came home from Guadalcanal the way he usually left the ring, on his own two feet—and with the dramatic story of the "toughest round I ever slugged through."

The fighting marine corporal recalled the floss of old as he stepped down the gangplank of a hospital ship yesterday. There was the famous smile he showed in winning three boxing titles. And the wave of hands as if to his fans at the fights.

He was, to put it mildly, glad to be back in the U. S. A. He showed it by kneeling down solemnly and kissing the ground. "This," he said, "I vowed to do if ever I saw American soil again. Sometimes out there we are not sure we shall."

"Out there" was the steaming, blood-covered battlefield of Guadalcanal where the 32-year old Chicago marine won high praise of his company commander, Capt. O. K. Le Blanc, and recom-

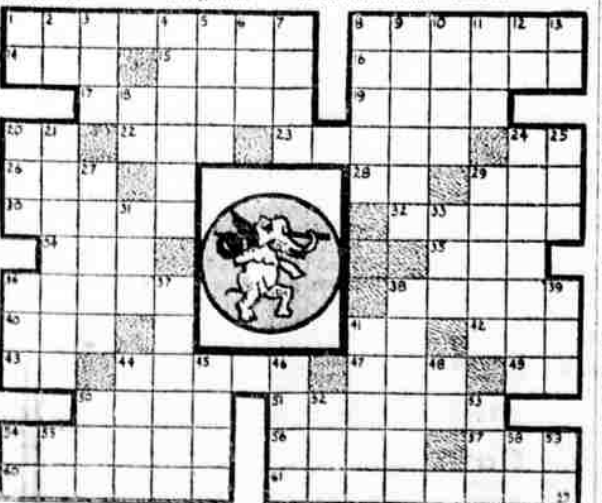

Concerning the NORTHWEST As Viewed at the National Capital By John W. Kelly

WASHINGTON, D. C., Feb. 26.

—Before congress knew anything about it a contract was awarded to the Everett-Pacific Co. of Everett, Wash., to build a floating drydock for an estimated cost of \$11,500,000, and another contract to the Pacific Bridge Co. to construct 18 floating drydocks of a smaller type at Alameda at a total estimated cost of \$54,000,000, and another contract to the Chicago Bridge & Iron Co. to build one of the \$11,300,000 type at Eureka, Calif. The navy department explained the need was urgent; that the president had said go ahead, so there was nothing for congress to do but make an appropriation for \$210,000,000 to expand ship repair facilities.

These drydocks (plan is for 48) are to be used all over the world and will be available to any ships of the united nations that require repairs after an engagement with the enemy. The largest drydocks will accommodate ships of the cruiser class; the job given to Pacific Bridge Co. is for the destroyers and vessels of smaller size. The smallest drydocks are for patrol craft. These will be built in Illinois, Florida, New Jersey and New York—none on the Pacific coast. When the fleet sails, a floating drydock will be part of it, the same as oil tankers, ready to reconition any warship that has been damaged. The British admiralty has been making urgent requests that the floating drydocks be provided. British warships have traveled from the Mediterranean to be repaired on Puget sound, others to San Francisco, and others in Columbia river. French ships came from west Africa to Atlantic ports because there were no docking facilities in the Dakar region.

The two score-plus drydocks are to be completed by December, 1944, by which time it is assumed most of the activities will be concentrated in the Pacific against the Japanese. All American cruisers thus far have been sunk or damaged in the Pacific. Some of the drydocks will be turned over to the allies, but title will be retained by the United States—a different arrangement from the lend-lease policy wherein the United States kisses goodbye to any materials sent to the united nations.

Farm Machinery Snag

Farmers will be requested to sign an application for farm machinery (announcement only recently made that machinery and parts could be had without strings) promising to permit other farmers to utilize the equipment, the desire being to spread the "good neighbor" policy and assure use of the implements. The mutual use of machinery by farmers is as common as the mutual use of lawnmowers in the city and already there is objection to signing such a pledge. The required promise may be canceled if the protest is sufficiently strong.

If the farmer does not live up to the terms of the application the local county farm rationing board can take the machinery away, and there is not one word in the form (Form MR-20, Dept. of Agric.) saying anything about reimbursing the farmer. The county board is, in effect, prosecutor, judge and jury. There are 13 questions, and after he has answered why he needs the machinery the

13th question asks for other reasons. Recently the master of the state grange of Oregon was advised that farm machinery could be had without difficulty. Form MR-20 says otherwise.

HOLC's Death Sought

Building and loan associations are determined to force the liquidation of home owners loan corporation and take over the assets. These building and loan companies are represented in the northwest and they are contributing to the pay of a lobbyist in the national capital, who is said to receive a salary of \$25,000 plus expenses.
