the end in Sicily.

In our hands, Sicily will become a base for further operations against Italy, if, as and when needed.

An interesting tale comes from Sweden.

Two correspondents of Swedish newspaper reported that the Germans are speeding evacuation civilians FROM BERLIN in anticipation that the capital will follow Hamburg on our total destruction list.

In other words, the Germans don't like to have that kind of news get out because it indicates that they're SCARED of allied air power.

Of course they're scared. If Sun Francisco (about the size of Hamburg) were totally destroyed by the Japs, we'd be scared. It isn't in human nature not to be.

The reason they're scared is that the Germans HAVEN'T BEEN ABLE TO STOP our air assault.

WHILE you're at it, keep your eye on the Italian fleet and what Badoglio does with it. If he hands it over to the Germans without a fight (or at least with only a "TOKEN fight") we'll have him pretty well pegged as a German tool.

THE Italian fleet hasn't amounted to much so far, but as long as it remains as a possible fighting entity we'll have to keep a lot of naval strength in the Mediterranean to offset it.

If we could FORGET the Italian fleet, we could put MORE naval strength into the Pacific to fight the Japs.

AT Munda, we've hacked our way slowly to the eastern edge of the Jap airfield, but Pacific headquarters dispatches say much bloody battling lies ahead. Each time we close in on the Japs, we have to KILL THEM ALL. That takes time. If we have to kill the whole 70 million of them, it will take a lot of time.

GEORGIA, by constitutional amendment, appears to have lowered the voting age from 21 to 18—the first state to do so. The votes aren't all counted as this is written but favorable sentiment is so far running about three to one.

This writer would say offhand that if men of 18 are old enough to FIGHT they're old enough to VOTE.

VOTING by 18-year-olds won't change things much—EXCEPT that younger people are more apt to HAVE IDEALS and voters with ideals are the hope of the world.

THE VEST GETS THE GRAVY

EDITORIAL

WE have been very interested recently in watching the development of sentiment concerning the United States relations with international affairs. A new school of thought is growing so rapidly it promises to create a major issue in the near future. Newspapers and magazines are more frequently and with increasing boldness expressing opinions that America should develop a more hard-headed and practical attitude in our association with other nations and cast off what some term a national inferiority complex.

In our present exalted idealism, our largess is bestowed with apology. We humble our deeds and our production records. We publicly abase ourselves before the sacrifices of our worthy allies.

Why not for a change frankly admit to ourselves and proclaim to the world in general that we have the best army and navy in existence? Why not remind ourselves and the world at large that the whole allied cause would long ago have been lost had it not been for the stupendous achievements of American industry? Why not pat ourselves on the back with the hands so cheerfully extended across the sea? Why not take a little credit for the fact we are helping to win the war?

Not that we would discredit for one instant the efficiency, the sacrifices, the brave deeds, and the glorious achievements of our allies. But we have nothing to be ashamed of and certainly we are entitled to do a little bragging on our own account.

Furthermore, we should be getting something in return for what we do. Something for nothing is seldom appreciated. The rich man usually is hated despite his philanthropies.

We build great air bases on soil belonging to allied nations. The day the war is over we will be kicked off many of these bases, which will then be used for cutting our throats in competition for aerial trade. We send abroad billions of dollars worth of lend-lease materiel. Yet our allies have to be prompted to tell their people the supplies were furnished by the United States.

Our idealism is a beautiful thing. It looks fine on paper. It stirs the emotions. But it is like the voice of the masterful orator, who, with honeyed words and golden phrases, says nothing; like the photographer's proof which, exposed to the light, loses its image; like the frosting on the cardboard cake in the baker's window.

As a nation, we have been very much like the rich old uncle whose relatives fawningly accept his benevolences, but wish the old codger would hurry and die so they can grab his riches.

We do not advocate the elimination of all idealism from our international participation, but we do believe there should be a little of the practical mixed in. The last war furnished us with ample proof that the other nations with whom we were allied were not neglecting their own post-war positions. We have no reason to expect conditions will be different this time. We were given a seat at the last peace conference, but we might as well have stayed at home.

We should begin now to assert ourselves. We should be in a position that we can have enough of a voice in forthcoming world adjustments to assure we shall not have to fight another war. We should, in return for all we are doing, insure ourselves that we will have equal rights and privileges with other nations in the development of international trade.

Our present position reminds us of the words of an old favorite of the barber shop quartets: "The coat and pants do all the work, but the vest gets all the gravy."

Dramatic Film, "Beyond The Rising Sun," Coming To Indian Theater, Aug. 11

"Beyond The Rising Sun," a story from inside Japan, is to be presented at Hunt's Indian Theater for four days, starting Aug. 11. Listed as one of the outstanding films of the year, it deals with racial characteristics, philosophies and sadistic cruelties of the Japanese.

It was a father and son story—a Japanese father who educated his son in an American university. But the son returns to Japan and reverts to racial customs and cruelties under the impact of war.

Aside from the plot, the film draws from the book of the same title, written by James R. Young, a news correspondent in Japan for 13 years. The motion picture rights to the book were purchased and Young was employed as a technical adviser when the picture went into production.

Navy's hospital corps are invited to review their opportunities with Yeoman Dorothy Duncan at the chamber of commerce office from 8 a. m. to 5 p. m. on Saturday, Aug. 7—or if they work during the day are invited to call for a night interview.
