gesting that the Germans are fleeing fast up the leg of the Italian boot.

At Marseilles, on the French Mediterranean coast, we hit German airfields. "Great fleets" of American bombers hit German airfields on the Atlantic side of France. (Airfields behind the enemy's lines are always the first objective of a big modern offensive.)

British bombers attack a German research establishment on the Baltic coast. British Mosquitos smack Berlin again. Our intruder planes range all over France, north-west Germany and the low countries.

THE very blurriness of this picture is suggestive. We're shadow boxing from the air over such a wide range that the Germans can't be sure where the Sunday punch is to come. (If it comes.)

THE Russians are needing us again for a second (or third) front.

Red Star (Russian army newspaper) says the allies (meaning the British and Americans) have failed to take advantage of the opportunities provided by the Russian summer offensive. It praises Sicily as a workmanlike job, but says it failed to DIVERT a single German plane or a single German division from the Russian front.

It says there are 211 German divisions in Russia and only 91 in ALL THE REST OF Europe. This disposition of forces, it adds, proves the Germans don't fear any large, serious allied operations on the continent.

THE Russians, with the weight of the German army on their necks, are naturally anxious for a move by us (British and Americans) that will TAKE OFF some of the German weight. (Our hard-fighting, relatively small forces in the South Pacific would like JUST AS WELL to see the Russians tear into the Japs from the rear.)

WE (again meaning British and Americans) have been spending all winter, spring and summer getting large forces into position ALL AROUND the perimeter of the German "fortress" of Europe.

All we outsiders can do is to guess, but it LOOKS as if we might now be in a position to STRIKE in the Balkans, in Italy, in Mediterranean France, in Atlantic France or in Norway.

That's a WIDE RANGE of choice, and its very wideness must worry the Germans greatly. The more places your enemy CAN hit you, the more nervous you're likely to be.

IT isn't certain (to us outsiders) that we WILL strike (on the ground) at any of these points where we COULD strike if a Sunday punch seemed advisable from the standpoint of overall strategy.

Our high-up leaders—whose information about the enemy's strength or weakness is reasonably accurate, whereas ours is merely guesswork—may decide to spend the long winter nights battering Germany from the air instead of wading in now for the kill.

WE on the outside just simply don't know enough to make predictions that are worth the paper they are written on.

WE have to take our guess out in guessing.

CONFERENCE CONJECTURE

EDITORIAL

NEWS commentators are having a great time with their speculations concerning the subjects of the Roosevelt-Churchill conferences. The public, denied official information, can have the benefit only of the conjecture and second-guessing of the so-called "experts." Some observers find significance in the lack of Russian representation. Others foresee the start of continental invasion. Still others would point the discussions into the Pacific area, while some are inclined to the belief that the Russian advances have upset the American-British time-table and that immediate invasion is necessary if we expect to share the victory melon with the Soviets.

One thing may well be realized—the conference is political. Because of the sequence of events which have followed previous Roosevelt-Churchill meetings, some people apparently have the belief that these two great political leaders are mapping war strategy.

Great fanfare followed the meeting at Casablanca, heralding the North African campaign. In fact the ballyhoo was tremendously overdone. The intimation was that Churchill and Roosevelt had a hand in the operations, but the whole effect was ruined when formal reports from military headquarters later announced the entire campaign had been planned and timed six months in advance of the meeting.

It is very probable that the time has been set for new offensive campaigns. Roosevelt and Churchill doubtless are hearing the reports of the military leaders and are placing their sanction and approval on plans. But military strategy is designed by men trained in the arts of war and not by politicians.

At least that conjecture would explain the absence of Stalin. The leader of Russia needs no political build-up. He does not have to be elected to office or keep the support of a divided parliament. He has a one-party rule. He can keep it a one-party government as long as he can find and purge dissenters.

Russia is pleading for a land front in Western Europe. The time would appear to be ripe. But we doubt very much if the secret conference has any major bearing on the details of such a campaign. If an invasion is planned, doubtless the plans were made months ago by military leaders and all details have been given the most careful and thorough scrutiny and participation by political leadership would be perfunctory only.

However, the conferences have a most important place in the war of nerves. Their effect on axis powers cannot help but be unnerving, in view of the fact that they have been followed previously by large scale offensive action.

We can remember when the shoe was on the other foot. Meetings of Hitler and Mussolini portended no good for the United Nations.

But now Hitler and Mussolini have only one more meeting in prospect and that will be on the way out.

lasts long will depend on whether the Germans crack up or have to be killed off.

This writer has a notion that the insiders don't know a lot more about that than we do. Psychological crack-ups are hard to predict.
