## Alleged Disorder Puts Four Youths In Clash With Law

Four youths were in custody here today on charges growing out of an automobile accident, an alleged drinking party and a free-for-all disturbance at the Rainbow rink at Winchester, local authorities announced.

A fine of \$50 and a 30-day sentence was imposed in Justice court Thursday upon Emerson S. Rohrbough, 19, Jack H. Lehn-her, 19, was fined \$100 today on a charge of failure to stop at the scene of an accident and was continued in custody in lieu of payment, Judge Thomas Hartfiel reported, while Bert Lehnher and Everett West, each 17, were held in lieu of \$500 bail on charges of aiding a prisoner to escape, with Lehnher also facing a separate charge of assault and battery.

Erwin Short, city chief of police, reported that Jack Lehnher was called to have been driving an automobile which was involved in an accident. Instead of stopping, Short said, Lehnher was reported to have left the scene and was later apprehended by Officer T. W. Thomason. Bert Lehnher and West aided Jack Lehnher in breaking away from the officer and all three escaped, Short reported.

Later in the evening, a state policeman was called to the skating rink at Winchester where a fight was reported in progress and he arrested Rohrbough, who pleaded guilty in justice court yesterday to being drunk and disorderly. The four had been traveling together prior to Rohrbough's arrests, the officers stated.

## Pacific War Vet Will Speak Here On Armistice Day

First Sergeant John Melsaac, now at Camp White, Medford, where he is recuperating from malaria and the effects of prolonged combat service in the Southwest Pacific, is to be the speaker at the Armistice day program in Roseburg. George Trapolis, chairman of the Armistice day program committee, reported today.

The committee is especially urging all parents of boys serving with the Roseburg National guard company to be in attendance at this program, as Sergeant Melsaac was in close contact with the Douglas county unit in combat and is expected to have some "off the record" information concerning the combat achievement of the local company.

He served throughout the entire Guadalcanal campaign, and saw action in other Southwestern Pacific engagements, his assignment permitting him to travel extensively to various United Nations front line posts.

Sergeant Melsaac was recommended to the local committee by the staff officers of Camp White, who report that he has been engaged in extensive speaking campaigns at hospitals, war production plants and before civic groups. He is reported to be a most interesting speaker and has a wealth of personal experience of the greatest interest to his listeners.

His address will be the feature of the morning program at the Armistice day celebration, the program being scheduled for 11 a. m. at Hunt's Indian theater.
