Headache Offered In New Federal Income Tax Forms

WASHINGTON, Jan. 8 (AP)—The new Federal Income Tax blanks are on their way to your mailbox.

Then you can start scratching your head over a long form that's twice as big as last year's and twice as complicated.

The internal revenue bureau, mindful of the millions who'll have to file returns, hopes you'll tackle the job as soon as you can, and not wait until the March 15 deadline. Internal Revenue Offices expect to be pretty busy about that time, whereas early comers may not have to stand in line to wait for help.

And you may need that help. The Bureau figures that it's done the best it could in arranging the blanks—the Tax Law being what it is—but internal revenue men aren't too hopeful about the task ahead.

There are, again, two available forms. You can use the short form if your 1943 income was \$3,000 or less and all of it came from wages, salary, dividends, interest and annuities. Otherwise, you must use the long form.

Not only are the blanks twice as involved, but the instructions are doubly long, too. That's because of the forgiveness feature and the Victory tax.

How's Your Arithmetic?

If you can do a problem in percentage up to four decimal places you probably can fix up the short form without too much trouble. As income tax blanks go, it's comparatively readable.

And the instruction sheet that comes with this form is a far cry from anything of the sort in the past. It practically violates all tradition by such straightforward notes as this:

"If you are not in this group, enter your 1942 (correct) tax in item 9 and you do not need to read the next five paragraphs."

The Revenuers did quite a bit of experimenting in trying to bring the Victory Tax down to earth—or at least part way. In planning the short form, they doped out two ways of figuring this tax and tried them out on some of the lowest paid clerks in the bureau.

The one finally used on the blank produced more correct answers and got the girls' vote of preference.

Two Choices Offered.

It brings the calculation of the Victory tax down to one multiplication. You take your choice of percentage according to your marital status and number of dependents. If you're single, you use 3.75 percent; or if, for example, you're married and have two children, you use 2.8 percent. That presents a problem like this: \$1500 times .0375.

If you can do that one, you can start from the top of the short form and go right down the list with confidence—that is, if you read every line carefully.

The long form presents its familiar challenge, calling for perseverance, at least four problems in percentages and a handful of additions and subtractions.

This time it provides space for calculating and deduction for medical and dental expenses—omitted a year ago.

All in all, it's an imposing document. If you want to know why it isn't simpler, the Revenuers will suggest you ask congress.

Troop Rotation Policy Adopted for Overseas Forces

WASHINGTON, Jan. 8 (AP)—The War department has adopted a troop rotation policy "which should assure" that by mid-1944 all soldiers in Alaska and the Caribbean areas with two years of overseas service will be returned to the United States, Senator Reynolds said today.

Reynolds, chairman of the Senate Military Committee, reported the rotation outlook in other areas as follows:

North Africa, plans have been instituted to return monthly a limited number of men with more than 18 months' overseas service.

South and Southwest Pacific: "It is anticipated that the present difficulties in returning men from these theaters of operation will be overcome in the spring of 1944, and that a system will be put into effect to return a certain number of men to the United States."

Europeans: "Up to the present time men in this theater, other than those in the air crews, have not been subject to combat fatigue and stress, and the climatic conditions do not necessitate a change, and therefore no system has been established for this theater for the rotation of troops to the homeland. As the situation changes in the European theater a system will be put into effect."

Air crew personnel: "The rotation of air crew personnel serving overseas in all theaters has been established and is functioning satisfactorily."

Apprentice Training Extension Discussed

Plans for extending the operation of the apprentice training service in Douglas county were discussed here Saturday by Norman O. Nilson, field representative of the apprentice and training department of the War Manpower commission, who conferred with G. E. Bloomquist, trades coordinator in the Roseburg schools, and members of the Roseburg apprentice commission. Due to rapid industrialization of Douglas county, there is ample opportunity for a considerable extension of the training program, Mr. Nilson stated.

Holman Fears Demos Would Kill Vote Right

PORTLAND, Jan. 8 (AP)—Senator Holman fears that the American voting system will come to an end if the Democratic party is returned to power next fall.

"There will not be a senate if we lose the next election," he told the Portland Women's Republican club. "The present administration has developed into a rule and if this personal rule is confirmed at the next election it will be the last opportunity the American people in our generation will have to vote."

PORTLAND, Jan. 8 (AP)—Walter Schubel, Gladstone, was killed and six other persons injured in an automobile accident late last night on the Pacific Highway a mile south of New Era.
