ish are pounding these rail lines, along with Danube river barges, continually from the air. For the first time since the war began, we're co-operating directly in a military way with the Russian armies.

WE'RE bombing again many of the places we've bombed already in Germany. The dispatches explain that these blows "are designed both to disrupt repairs and to inflict new damage."

THE German propagandists come up with a new "secret weapon" story. This time it's a projectile containing chemicals that will freeze everything within 500 yards and make steel and concrete so brittle they'll crumble at a touch.

THE general tone of the dispatches is to the effect that the Finns have AGAIN rejected the Russian peace terms. If so, it will be interesting to watch what the Russians will do.

MEANWHILE, as you must have noted, all the neutrals are still SITTING TIGHT and being extremely careful NOT to do anything the Germans might not like.

BE PREPARED TO VOTE

VOTERS in at least three parts of Douglas county will be called upon during the next few weeks to settle several very important issues.

All voters will decide whether the annual county fair is to be revived, as the issue will appear on the May 19 primary election ballot. At the same time, residents in the extreme western part of the county will vote on the proposal to join the Central Lincoln Public Utility district.

A special election will be held by the Roseburg school district April 26 to pass upon a proposed five-year tax to be levied annually at the rate of six mills to provide funds for expansion of school facilities.

Petitions are being circulated in the Myrtle Creek, Riddle, Canyonville and Days Creek areas, where consolidation is proposed to provide a standard high school. An early vote on the measure is anticipated.

Presentation of these issues to voters indicates a progressive trend in Douglas county and a will on the part of at least a portion of the population to make advances in keeping with the needs of the times.

Revival of the county fair is an issue long advocated by many persons. Leadership in the current move to bring the proposal before the voters has been assumed by the Douglas County Mounted Police Reserves. The men composing this unit are so sincere in their effort that they have levied a heavy assessment upon themselves to meet the cost of circulating petitions, advertising and publicity.

The measure they advocate, and which will be submitted, as a result of petitions filed with the county court, calls for a tax levy to raise \$30,000, but at a rate of not to exceed one-mill, to buy and improve land and erect buildings. Selection of a site would be left to the county court, which would also direct improvements and construction.

It is not anticipated by the sponsors that the initial investment will be sufficient to completely develop the property, nor is it expected that any major construction program can be undertaken until after the war.

There is believed, however, to be a great need toward a start for a fair grounds, coupled with a recreational site. The first step is the acquisition of grounds. The mounted police organization proposes, once the site has been chosen, to sponsor exhibitions, rodeos, etc., and will devote at least a portion of the proceeds to improvement of the fair grounds, with the expectation that income will meet the improvement cost after the first expense has been met.

The Roseburg school district proposal is also one which is of great importance. The already overburdened facilities will be forced within the next few years, it is expected, to provide accommodations for many additional pupils. At the present time it is impossible to tell just where the greatest demand will fall. New elementary school buildings are certain to be needed. Whether present high school facilities will be sufficient will depend upon a number of factors. Educational changes are towards trades instruction, which will necessitate shops, where courses in mechanics can be efficiently handled.

The board of school directors, we believe, has exercised good judgment in its proposal to levy a six-mill tax annually for five years. Thus the board will have funds with which to make expansions when and where needed, without the necessity of a bond issue, thereby saving interest charges.

The special election in the Roseburg school district will be held Wednesday, April 26, from 2 to 7 p. m., at the junior high school building. Persons over 21 years of age, who have been residents of the county for 30 days, and who own property upon which they have paid taxes or upon which they are subject to tax are qualified to vote. The voting privilege also is held by those who own stock in firms or co-partnerships which pay taxes within the district.

The election issues are important. They are deserving of study on the part of the voters, and every citizen should vote his opinion. The only way to maintain a democratic government is for every citizen to exercise the responsibility such type of government imposes upon him.
