that our MAIN ATTACK may be developing. When we defeat Germany's strategic reserves, we'll have the war pretty well won.

THE dispatches make it plain (as this is written) that the Jig German counter-attack hasn't yet begun. You may wonder why.

Keep this in mind: The Germans have to be sure it IS the real thing before they throw in large bodies of their not-too-plentiful reserves at any particular point. If they do that too soon, at the WRONG place, we may hit SOMEWHERE ELSE and catch them dangerously weak.

ON this point, there's an oddity interesting note in the dispatches. John Moroso, an AP correspondent, cables from London that in spite of all the talk of huge-scale invasion attack in its initial phases is NO LARGER than the attack on Sicily.

If that is true, we're still HOLDING BACK the bulk of our forces, to be used wherever WE need (or want) them most.

IN the invasion, our first job is to GET ASHORE on the enemy's coast. Our next job is to hang onto our toehold and land sufficient reinforcements and supplies ON THE BEACH.

It looks as this is written as if we may be aiming at the port of Cherbourg. We've cut the Cherbourg-Paris railroad at Bayeux and seem to be thrusting south-west from there. It's a fair guess that our purpose is to PINCH OFF the Cherbourg peninsula with its highly desirable port facilities.

WHY didn't we attack Cherbourg and Le Havre first? The answer is that there is where the enemy was strongest.

THE Germans report that the Russians have launched an offensive on a BROAD FRONT in Romania. The German broadcast says "heavy fighting" is in progress there. The Russians make no mention of it, but they usually delay their announcements until their offensives are well under way.

Watch it. Whatever develops on the Russian front now is immensely important.

THE Germans are retreating rapidly north of Rome. There is considerable evidence of de-

THE THREAT OF RABIES

Roseburg health and police authorities report an attack by a cat, a family pet, afflicted with rabies, upon a four-year old boy. Rabies is a dread disease, yet one which is easily controlled if public cooperation is obtained.

It is a disease quite prevalent among animals in southern states, and is believed to have been brought into Douglas county by a pet dog which has accompanied some family moving in from the South. Sufficient time has not elapsed to trace the source nor to determine how widely the disease has been spread.

As a result of this condition, every dog must be placed under suspicion until danger of further spread has passed. Cats can be infected if bitten by a dog suffering from rabies, the circumstance which led to the discovery of the disease in Roseburg.

There is one rule which MUST be immediately enforced. Dogs must not be permitted to run at large. City authorities should take steps without delay to arrest any person who does not keep his dog penned up and any stray animal should be impounded at once. Heavy fines should be imposed upon owners who violate this cardinal rule of safety during the period of the emergency.

If everyone would cooperate voluntarily, the disease could be stamped out definitely within a month. The disease develops in a bitten dog within a period of two weeks. Thus, if every animal could be kept in restraint and free from any possible source of infection for a period of four weeks there would be no further danger.

The great majority of dog owners doubtless will cooperate, for they value their own pets, but we may be sure that some will not take the matter seriously, and for that reason we urge strict enforcement and severe penalties.

Some people might be inclined to kill their dogs at once, particularly in the case of any illness. This, however, is not recommended by the state board of health. Health or police authorities, or a veterinarian should be notified in any case of doubt. It is not necessary to sacrifice a good dog when there is a possibility that few will actually contract the disease.

It is, however, wise precaution to keep all dogs penned away from contact with other animals. If the dog shows any signs of illness or a change in disposition, he should be chained (not tied with rope) and should be attended only by mature and responsible persons. Children should be kept away.

In the event it becomes necessary to destroy the animal, it should be killed by shooting through the body rather than the head. The head should be preserved intact and immediately turned over to proper authorities to be sent to the state board of health for examination, as it is only by locating affected animals that sources and contacts of the disease may be traced.

There is no need for alarm and there is little danger of any material spread of the disease if prompt and effective control measures are used. The control, to be effective, demands total cooperation on the part of dog owners, and strict enforcement by the police in the event of any failure to comply with the safety precautions.

We simply must remember that the enterprise we've embarked on is the greatest of its kind since history began. It won't be over in a week. It won't even be well started in a week. We mustn't jump to ANY conclusions now. It's too soon.

The best we can say is that a good start has been made.

A century and a quarter ago Napoleon sat on these channel shores with a great invasion fleet and muttered in his beard for months about what he was going to do to the wicked English, but he never got his nerve up to the point of trying—and Napoleon loved bold enterprises.

A few days less than four years ago, Hitler was doing the same thing. He, too, failed to get his nerve up to the point of trying it.

We're TRYING IT—and seem to have made an auspicious start. That's all we're justified in saying at this moment.

Beavers, Angelenos Stage Hectic Game That Ends in Tie

(By the Associated Press) Portland baseball fans saw a lot of baseball last night and early this morning—thirteen innings, 100 batters at the plate, fourteen runs, 31 basehits off six pitchers and one error—but all for nothing.

The game ended in a tie—Portland 7 and Los Angeles 7—called because of a loop time limit and will not count in Pacific coast league standings until played out at a later date.

San Francisco gained a half game on league leading Portland and jumped into second place beating Sacramento 3 to 2.

Seattle slumped to third place, losing to Oakland, 2 to 1, and Hollywood won its first game in four starts from San Diego, 6 to 5.

A 10th inning riot saw Portland Manager Owen run out of the game for the first time in 15 years of baseball. Fernandez also was sent to the bench.

Softball Season Opens in Roseburg Monday Night

The Roseburg softball season will open Monday night at Finlay field with two games, the first starting at 7:15 o'clock. The board of school directors recently purchased 22 new lighting fixtures which are now being installed at the ball park, the fixtures having been obtained from Klamath Falls, where the lighting equipment was dismantled when a recreation field was taken over for military purposes.

Heretofore it has been necessary to switch lights each year from the football field to the baseball park, but enough fixtures have now been secured to provide permanent installations for each field.

Five teams have been entered in the league, these representing the Young's Bay Lumber company, Roseburg Lumber company, Roseburg Transfer, Roseburg Bowling alleys and Olympia Supply company. It had been expected to have a combined Oakland-Sutherland team in the league, but the players from that district are handicapped by lack of travel facilities and have not yet posted their entry fee.

Starting with Monday night's games, the league will offer games each Monday, Wednesday and Friday, with a doubleheader each night.
