A beautiful gift was presented from the members and friends of the church to Rev. and Mrs. Needham for their work in the church during the past years.

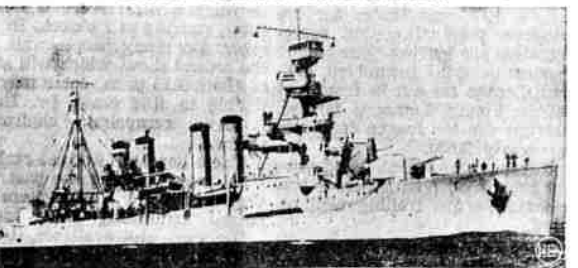

Bridges Loses Round in Fight Against Deportation

SAN FRANCISCO, June 27.—(AP) Harry Bridges, west coast CIO labor leader, has lost another round in his sustained legal fight against deportation to his native Australia.

The U. S. ninth circuit court of appeals yesterday upheld by a 3 to 2 decision Federal Judge Martin J. Welsh's denial to Bridges of a writ of habeas corpus. The longshoremen's executive, whose attorneys said they would appeal to the U. S. supreme court, seeks the writ to block U. S. Attorney General Eddies' deportation order.

The circuit court in its decision said it "has no power to review the truth of the charge nor the manner in which the decision was reached," that it was called upon only to determine whether "the alien, Bridges," had a fair hearing and whether his constitutional privileges were violated. The opinion rejected Bridge's claim he had been placed in double jeopardy and cited that at his original hearing he was represented by counsel and took the stand on his own behalf.
