

NOTICE OF 1944-45 BUDGET MEETING

In accordance with the provisions of the "Local Budget Law" (Sections 110-1201 to 110-1215 O. C. L. A., as amended) notice is hereby given that the Budget Committee of Douglas County, Oregon, has prepared in compliance with the "Local Budget Law" Budget Estimates for the fiscal year July 1, 1944, to June 30, 1945.

All persons are hereby notified that on Monday, the 24th day of July, 1944, at the hour of 10:00 o'clock A. M., in the Circuit Court room in the Court House in Roseburg, Oregon, the following Budget Estimates for the ensuing fiscal year ending June 30, 1945, for Douglas County, Oregon, may be discussed with the County Court, the levying board for said Douglas County, Oregon, and any person subject to the proposed tax levy or tax levies will be heard in favor of or against said proposed tax levy or tax levies or any part thereof. The estimates of expenditures to be required, the miscellaneous revenues to be received and the taxes on the property to be levied as prepared by the Budget Committee, and adopted June 20th, 1944, are as set forth in the accompanying statements, and said statements show a summary of indebtedness, if any, as of April 1, 1944.

The original estimates sheets as required by Section 110-1204 O. C. L. A., have been placed on file in the office of the County Clerk of Douglas County, Oregon, at Roseburg, in said county.
