THE SIXTH WAR LOAN

NEXT week we will start the Sixth War Loan campaign. We have successfully met our quotas in the five preceding efforts, but those in charge of the forthcoming campaign feel it will be more difficult to reach the mark this time than in any drive held previously.

Sports fans know full well that many a baseball game has been lost in the ninth inning when the leading team began to relax. We have seen many football games lost or tied in the last period due to over confidence.

There is not much danger that we will lose the war, but victory can be delayed, lives can be lost unnecessarily and billions of dollars can be added to the cost of the war. Every moment peace is delayed means expenditures of lives and money. The quicker we end the struggle, the fewer will be the sacrifices of life, the less will be the cost.

We should strive for an early knockout, rather than let our opponent stay in the ring a moment longer than it takes us to dispose of him.

Advertising in this Sixth War Loan drive will appeal to our sense of responsibility; to our duty as American citizens. Unfortunately, many people do not take this matter of responsibility too seriously. Too many people are willing to let the other fellow assume their share of the burden.

The flow of workers from vital industries is a case in point. Military authorities tell us our reserve supply of munitions is getting low; but we still read of the exodus of workers from our war plants, strikes in vital industries, and a general slackening of the speed of production.

It seems to us that if we expect to make a success of this Sixth War Loan campaign, advertising should appeal to the selfish and mercenary aspects. There are plenty of reasons why we should buy bonds, not alone to aid the war effort but purely for our own interests.

Most of us are wasting money. Few people today are barely making a living. Nearly all of us have more money than we need for the bare essentials of life. We are buying more luxury goods than ever before.

We cannot expect prosperity resulting from war inflation to continue indefinitely. While a depression very probably can be avoided by careful management, we must realize that we face a return to normal conditions at some date not too far in the future.

Now is the time to be saving for that period when jobs and money will not be as free as at present. A nest egg of war bonds is the finest type of security against that day.

We are piling up a huge debt in this country. Many people fail to realize that their present prosperity is false economy and that they are simply enjoying a splurge on borrowed money. The national debt amounts to around \$2,000 for every man, woman and child in these United States.

By purchasing War Bonds we not only contribute to speedy victory but we are aiding to prevent inflation, we are assuring a back log of savings that will hold up prosperity for coming years, and at the same time we are protecting our own future. The Sixth War Loan should be our biggest and easiest campaign.

AT A 12th AAF B-25 BASE—Award of the air medal "for meritorious achievement while participating as a pilot in an attack upon a viaduct near Pistoia, Italy," has been made to First Lieutenant Lewis E. Insley, 24, above, of Akron, Ohio, it is announced from 12th air force headquarters in Italy.

Insley is the husband of Mrs. Jean A. Insley, Akron, and the son of Mr. and Mrs. Charles W. Insley, of Roseburg, Ore. A former student of Oregon State college, Lieutenant Insley has been overseas since May, 1944.

A veteran of more than 38 combat missions, Lieutenant Insley is assigned to a B-25 Mitchell bomber group that helped open the beachhead in southern France on D-day. The group entered combat in April, 1943, with attacks on Rommel's Mareth line in Tunisia.
