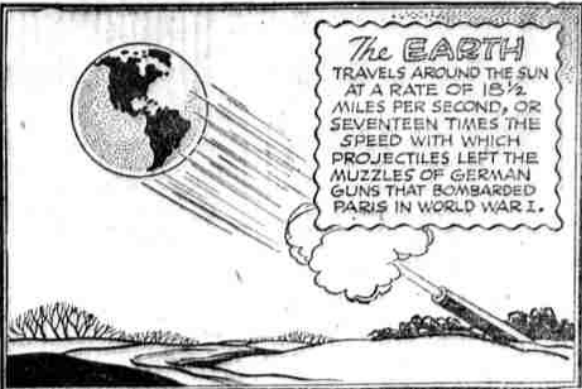

Britain Aids U. S.

865,000 American troops transported by British ships. 133 air fields in the British Isles. 2 portable harbors used in Normandy invasion. Petroleum products \$235,528,000. Aircraft \$43,000,000. Ammunition and guns \$29,196,000. Food \$32,000,000.

Great Britain's aid to the U. S.—reverse lend-lease—has totaled nearly \$2,440,000,000, according to a report given Congress by President Roosevelt. Outstanding items cited in the report are shown on above chart, with transportation of American troops in British vessels leading the parade. The food, incidentally, was for American troops stationed in the United Kingdom. U. S. lend-lease to the British totals \$1,900,000,000.
