Truman Sets Broadcast On Wage-Price Policy

WASHINGTON, Oct. 29.—(AP)—President Truman is drafting an important administration pronouncement on wage-price policy for disclosure to the nation in a major radio broadcast at 7 P. M. (PST) tomorrow.

This will be the fourth in a series of moves "high associates" say reflect a new effort to resuscitate his stalemate postwar program by a course of more firm administration and party leadership.

His directive to departmental and agency heads to submit semi-monthly reports on the progress of legislation for which he is holding them responsible was an early step. The others, these sources say, were his call for a universal training program and his Navy day speech in New York outlining a 12-point foreign policy.

Furlough Prior to Discharge Urged For War Veterans

A proposal made by the Disabled American Veterans early in the war that overseas veterans be given a 30-day furlough at home prior to discharge may become law in the near future.

Orlie A. Kennerly, Jr., of Roseburg, National Service Office candidate at the American university, Washington, D. C., pointed out that one of the best ways to help an overseas veteran readjust himself would be to give him a 30-day furlough at home just before his discharge.

"This would permit him," Kennerly said, "while still in uniform and receiving his military pay, to renew acquaintances back home, make business contacts and find out what conditions are in his own community."

"After the furlough he would return to a discharge center and receive his formal discharge in far better position to step into normal civilian life than if he were then going home for the first time."

Mr. Kennerly said that Admiral William H. Standley, former chief of naval operations and former ambassador to Russia, advocated the DAV furlough plan in recent issue of the Army and Navy Journal. In supporting the idea, Admiral Standley wrote: "A month's leave at home while still in uniform will not only help them toward a realistic adjustment, but will prevent them from squandering whatever bonus they may receive on discharge."

The trouble had started when the local freight crew had kicked a loaded car from the train onto the siding on which the extra gang cars were located. It was late at night and the Greeks were all in their cars asleep. The brake on the shunted car had failed to work and the shunted car smashed into the work cars with considerable force and the angry Greeks piled out of their cars and attacked the brakeman, beating him quite badly.

Some of the more impulsive Greeks had sought their firearms and several shots were fired in the darkness.

Brakeman Suffers Attack
The Greek interpreter was a valuable witness for the state, confirming the fact that the Greek workmen had attacked the brakeman and that they would have probably killed him in their madness had he not slipped away in the darkness. He also stated that the Greeks had fired several shots at the engine and the crew of the freight train and that they had also fired on the house of the section foreman from whose yard the shot came that killed the wife of the gang foreman.

The grand jury exonerated the brakeman who killed the woman, as an accidental shot fired while he was being attacked, but on the evidence of the Greek interpreter, several of the Greek workmen were indicted for inciting a riot and were sentenced to prison.

It was a rather exciting two weeks in Roseburg while this trial was in progress and a rather profitable time for me, as I drew down double pay for the time, acting both as court bailiff and night sergeant of the guard.

Early-Day Riot at Dillard of Railroad Section Gang, Busy Trial Recalled by Resident

As I have stated before, my historical narratives are written from memory; therefore I do not attempt to supply dates, so those who remember the following incident will probably call to mind it occurred while the circuit court of Douglas county was in session and that the writer was acting as bailiff for that court under the late Judge J. W. Hamilton.

As I remember, it was quite early in the morning when Company D, Oregon National Guard, of which the writer was a regimental quartermaster sergeant, attached to the headquarters company at Eugene but acting and reporting to the local company, was summoned under an emergency riot call for duty in Douglas county. Frank B. Hamlin, county school superintendent, was captain of the local company. Harry Stum was first lieutenant. Fred Stewart second lieutenant; both attached to the county sheriff's office under Harry McCallen. Percy Webb was the first sergeant of the company.

Called to Riot Duty
I was called for active duty with the company and was excused as jury bailiff by Judge Hamilton, with instructions to report back for duty as soon as received. The company was mustered for service by Capt. Hamlin at the armory, which at that time was the lower floor of the Elks' building. We were informed that a group of Greek railroad workers, who were laying heavy steel for the S. F. railroad, stationed in company work cars on the siding at Dillard, had created a riot when a freight train, while switching at Dillard had bumped into the work train cars on the siding, and that while they were attacking the train crew, a woman, the wife of the crew superintendent, an American, had been shot and fatally wounded.

Prisoners Debarred
The company fell in and marched to the depot to meet the special train bringing in the Greek prisoners, who had been placed under arrest by the sheriff and his deputies. While we were lined up awaiting the train, Dr. Eugene Dufas, who was an elderly practicing physician and who for some unknown reason had been enlisted as a private in the military company, joined us and stepped into the rear ranks carrying a surgical case. This was rather fortunate as he was able to take care of the Greeks who had received minor cuts and bruises.

The train, which consisted of the construction cars of the Greek gang, arrived at about 9:30 A. M. and was immediately guarded by the members of the military company and shunted upon the side track just west of the depot building and adjoining a warehouse which had been commandeered as a guard house. The prisoners were let out of the cars and searched one-by-one under my charge as they entered the guard room. A large number of knives, razors, iron or "brass" knuckles, as well as old rusted pistols and some ammunition, were removed from the persons of the prisoners. Very few of them had any money but those who had were allowed to retain it.

Extra Job Assigned
After all were checked, searched and registered, it was afternoon so I sought out Capt. Hamlin and asked to be relieved so that I might return to my duty as bailiff at the court house. Capt. Hamlin at once consented to this arrangement if I would take charge of the night guard duty and this was the arrangement for the next week, when the trial of the Greeks got under way. During this time I held under two jobs, bailiff of the circuit court and grand jury and night sergeant of the guard at the prison guard house. I had attempted to be relieved of the guard duty job but George M. Brown, who was at that time district attorney, insisted that I remain in charge of the night guard and work under his direction.

The first instructions given me by the district attorney were to watch closely and keep under guard and separate from the rest of the men a certain Greek interpreter who was to be a material witness for the state. So I had a special guard tent pitched and a cot put therein for this particular person. When I called him from the group of prisoners and assigned him to this tent he was so overjoyed that he insisted on tipping me \$5. While imprisoned with the rest of the men he was apparently afraid for his life.

Mistake Prove Fatal
The hearing before the grand jury immediately got under way and I was kept busy escorting witnesses from the guard house to the court house. Evidence developed that the woman was not shot by one of the Greek rioters but mistakenly by one of the brakemen, who during the riot had gotten through the crowd and to the house of the local section foreman where he secured a gun, and while still in the section house yard had fired at a person standing in the light of the open door of the gang superintendent's house car. The person shot proved to be the wife of the gang superintendent, who was watching for her husband, who had gone forward to pacify
