**Rainfall in December 3 Inches Above Normal**  
The Roseburg area received 8.33 inches of rainfall during the month of December, as compared with a normal of 5.34 inches, according to the monthly meteorological summary compiled by J. C. McCallister, head of the U. S. Weather Bureau office in Roseburg. Precipitation totaling 3.76 inches was reported for the three days of December 26, 27 and 28. Although considerably above average, the December rainfall was far from a record, as more than 12 inches has been recorded in two previous years, and December, 1943, had 11.95 inches of rainfall.
