IF WE had been told about this agreement at the time of the Potsdam conference, we would have accepted it as a perfectly reasonable arrangement.

THE campaign now being waged for INTERNATIONAL freedom of the press is intended to prevent just such things as this secret Potsdam agreement on the Kuriles.

But, coming with a jolt, as a DISCLOSED SECRET, it upsets us.

THAT is what honest newspapers mean when they talk about freedom of the press. Freedom of the press isn't just a racket for newspapers.

THERE are still jitters in the China news, where both factions (the Chungking government and the communists) are accusing each other of bad faith in the keeping of the stop-shooting truce.

As nearly as can be guessed from hints in the news, we have apparently COMMITTED ourselves to a policy in China that involves the use or the threat of FORCE if necessary to bring about certain objectives.

It is obvious that in carrying such a policy through to accomplishment we SIMPLY MUST have at our command the POWER to make it work.

BUT again, following the traditional methods of diplomacy, we kept at least the details of the commitment secret.

As a result, hundreds of thousands of American GIs—NOT UNDERSTANDING the situation, not knowing what it was all about, feeling that their job was DONE, kept in ignorance of their country's commitments—have become restive almost to the point of insubordination.

Now that the harm has been done, there is a lot of explaining. The harm could have been avoided by greater frankness at the beginning—by telling the people, including those still in the armed forces, what our commitments are and WHY we shall continue to need a large military force.

COMPLETE international freedom of the press, with reporters present at all these conferences and free to tell the public all that was going on, would have avoided this situation by making it plain from the start what our obligations and our commitments are and WHY we must have the power to carry them through.

Situations such as these help to explain why complete international freedom of the press is an important step in making wars less likely.

SHOULD BE CONTAGIOUS

The Oregon Coast Association is reported to have approved expenditure of \$11,800 to promote tourist travel to the coastal area. Part of the money is to be spent in preparing a sports fishing guide.

But the association is to be commended for its aggressive approach to what promises to be one of Oregon's greatest opportunities.

Wm. G. Oves, president of the Northwest Tourist Association, predicts expenditures amounting to \$15 billion by tourists in 1946. If his estimate is correct, it would average out at about \$312 million per state.

Yet 1946 should not be the banner tourist year. The great majority of motor vehicle owners will be driving old cars. Many persons will not have tires adequate for long trips.

The answer is obvious. We can't expect our proportion until we go after it. California and Washington have promoted tourist travel and, as a result, are getting the lion's share of benefits.

A great part of California's tourist income is realized from winter vacationists who seek the sunshine of the southern portion of that state.

Our coastal streams are, at the present time, experiencing the annual run of winter steelheads. The season will continue through February and into March.

We have been reading in a popular outdoor magazine how plans are being made to expend millions of dollars in an effort to restore fishing to Atlantic coast streams, where fishlife has been destroyed by commercialism and pollution.

We are aiming at \$100 million out of an estimated \$15 billion tourist expenditure. Our aim is low. There is no reason why Oregon shouldn't top the state average by a large margin, except for the fact that we haven't the vision, or lack ambition, to make the required effort for protection, development and promotion.

The Oregon Coast Association seems to have both vision and ambition. We hope the spirit is contagious.

Jas. E. Slattery Named Forester in O. & C. Office Here

W. H. Herlihy, chief forester of the O. & C. Administration, today announced the appointment of James E. Slattery as district forecaster for the Roseburg area.

Mr. Slattery received his original appointment with the O. & C. in November, 1938, and was assigned to the Roseburg office as district ranger. An office was secured in the Post Office building, adjacent to the U. S. Land office, and a new organization was gradually developed for the district.

Boxing Bout Honors Taken By Roseburg

Indians Gain 5 Verdicts, Springfield Awarded 4; Two Draws Are Declared

Roseburg leather pushers took the honors last night in the smelter with Springfield, after five of the bouts ended in favor of the Indians, two ended in draws, and four decisions went to the visiting boxers.

Another who took a count was Roseburg's Maynard Tally, 117, who was knocked flat in the third round by Hughes, 119, Tally managed to rise to his knees, finally to his feet, but he staggered, and the fight went to Hughes. Tally had shown himself to be light-stepping and a good feinter and ducked many of the punches thrown at him.

Other Results: Ted Whitworth, 116, of Springfield, took the first bout of the evening by pummeling 113-pound Earl Oden's head with well-aimed blows.

Clair Von Schultz, 125, knocked his Springfield opponent, Cooper, 128, ragged in two rounds. Dale Guse, 125, threw his gloves savagely at Bible, 121. At one point they locked arms and Bible was helpless against the ropes. Guse took the fight.

Bob Hatcher, 142, fought well against Meter, 139, and took the decision. But the fight might have gone the other way, and Springfield's coach had a brief conference with Referee Dick Gilman and Orle Kennardine, Jr. The referee's decision was final, however.

Bill Anderson, 147, won over Spuskowski, 152, who was tall and rangy and might better have been a basketball player. Al Morissette, 147, took more blows than he delivered and lost the fight to Akers, 150, of Springfield.

An unofficial fight, which had no effect on scoring, was fought by Bob Howard, 164, taller than his opponent, but otherwise evenly matched with Bode, 162. Howard was winner, for Roseburg.

Red-haired Wes Ashworth, 137, the "Roseburg Killer," fought to a draw with Stacy, 134. Ashworth managed to land some trip-hammer punches.

Bob Wilhite, 147, was somewhat shorter than his Springfield opponent, Raugh, 152. Raugh was winner and gave more than he received.

Lloyd Mayborn, 134, and Adams, 134, fought to a draw. Diversionary interest was provided last night by a wrestling match between Croucher and Pettit, both of Roseburg. Although Pettit won, Croucher gamely stuck and didn't give up until the final gong.
