that prices would jump alarmingly? Still, we mustn't lose sight of the fundamental fact that in the long pull ONLY FULL PRODUCTION CAN CURE INFLATION.

THERE are disturbing indications that present price policies are holding down production. That seems to be the NUB of our labor troubles.

It doesn't seem smart to take off all controls suddenly, in one brush sweep. But we certainly won't be smart if we permit price controls to hold down production.

THERE is something else that ought to be better understood than it is—why is government SO SLOW in putting military surpluses of consumer goods on the market?

There are unsettling stories about the amount of such goods held in storage. We hear of warehouses simply bursting with Army and Navy consumer goods.

But the rumors are so persistent that we can't help wondering if there isn't something back of them.

DESERVED ADVANCEMENT

The Denver Post, one of the nation's outstanding newspapers, has announced election of E. Palmer (Ep) Hoyt to become its publisher. Mr. Hoyt has been connected with The Oregonian, Portland, for the past 20 years and has been its publisher since 1938.

A native of Illinois, and reared in Vermont and Montana, Hoyt attended McMinnville College, now known as Linfield College. His education was interrupted by the First World War, in which he served for more than two years, spending 18 months overseas.

He has accomplished far more than simply editing and publishing a good newspaper. His high ethical standards have had a pronounced effect in the entire field of newspaper publication. He has been most exacting in demands for factual reporting of news and distinct separation between news and editorial comment.

Perhaps one of his greatest contributions has been in his determined and continuing fight for a free press. He was called to Washington in 1943 to serve as domestic director of the Office of War Information.

The Denver Post is to be congratulated on securing the acceptance of "Ep" Hoyt as its future publisher. He follows a great man, 70-year-old W. C. Shepherd, in the important post. Editor Shepherd has been a man of power and influence, and Hoyt will inherit an editorial position which has few parallels in modern newspaper history.

Sportsmen Face Nester-Hermit Ban On Rogue River

Oregon's Rogue River country has become the stronghold of a hardy group of nesters and hermits preparing, according to a current (Feb. 5) Saturday Evening Post article, for a last ditch stand against invasion by summer sportsmen and Hollywood stars.

"All they do is sit down and hate people," a resident is quoted in an article, "The Hermits Who Hate Hollywood."

"I remember an old man stopped me once on the trail and asked who was President. I told him Franklin D. Roosevelt. 'How long's he been in?' he asked, and I told him eleven years. He just gave me a hurt look and faded away among the trees. Figure I was kidding him, see?"

Now, writes Jean Muir, Hollywood stars, including Clark Gable and Jimmy Rogers, have established themselves on the upper Rogue near Grants Pass and Medford, while a similar invasion is taking place along the lower part of the river.

"The coming of the summer sportsmen has been marked by the sudden appearance of fences and no-trespass signs," Miss Muir's article continues. "Old timers claim the river is a navigable stream and its meander line a public thoroughfare."

"The discussion erupted last winter into the legislature. One bill was backed by the riverfront owners... another by the landless. Both bills were thrown out."

Then meetings were held to discuss a projected road along the river which would make the interior Rogue one of the scenic delights of Oregon. The project, writes the article, was discussed at length and quietly abandoned.

Oregon Veterans Offered Advice on Income Tax Filing

Although a \$3000 deduction for any part of each year in service will extend the majority of men paying an income tax, Oregon's returning servicemen were reminded today that they must file a state income tax return, the same as civilians, by the April 15 deadline.

Details of income tax obligations and exemptions pertaining to Oregon veterans as passed by the 1943 legislature were simplified by state income tax commission officials at the request of Hugh E. Rosson, state veterans' affairs director, and were released as follows:

1. The veteran must file a report on his 1945 earnings. 2. He is allowed a deduction of \$3000 from his net income for any part of each year in active service, for the years 1942 through 1945. This means that veterans who served as enlisted personnel or in the lower ranks of commissioned officers, and who had little or no income other

than service pay, will have no tax liability in most cases for the years of service. 3. In such cases, a letter should be sent to the tax commission, setting out income received in each year for which a return has not been filed, and no further return will be required.

4. The \$3000 deduction is for each year, from 1942 on, that the man was in active service for one day. For example, if he was discharged on Jan. 1, 1945, he can claim a \$3000 deduction on his earnings for 1945.

5. This deduction is in addition to the regular exemption allowed all persons. For single men, an income of less than \$800 for the year 1942, 1943 or 1944, and less than \$750 for 1945, is tax-exempt. For a married man living with his wife, less than \$1500 in any one year is tax-exempt, and an additional \$300 exemption is allowed for each additional dependent.

6. Where a veteran was granted a deferment of income tax payments when he entered service, or can show that he was absent from the United States in the armed forces when a return became due, he will not be penalized if it is filed within a reasonable time after his return to this country.

7. He may save money by filing a joint income tax return with his wife. By so doing, if his \$3000 deduction was not used up, the remainder of this deduction can be applied to his wife's deductible income. What this does, in effect, is to give his wife a greater deduction than she would otherwise have.

8. To take advantage of the \$3000 deduction, veterans must file on the "long term" tax table. 9. Service pay, overseas pay, flight pay and retirement pay are taxable for state purposes. Not taxable are maintenance allowances, the government's share of dependency allotments, disability pay and pensions, and payments received under the GI bill for education or apprentice training jobs.

maximum employment a government responsibility. The bill was a substitute for the so-called "full employment" bill recommended by President Truman. Chairman Cochran of the accounts committee predicted Mr. Truman will sign it.
