NEWS-REVIEW PRODUCTION

Having previously discussed the problem of national production in an attempt to deflate the idea that simply because production is far ahead of the 1939 level it is adequate for current needs, we decided to do a little research into our own particular field.

After all, if a formula will work on a small scale it will ordinarily work on a large scale, and vice versa.

We have been contending the federal government has nothing to brag about, simply because production is 164 per cent of the 1939 level, to use Regional OPA Director McDannell Brown's figures.

But let's see what has happened to the News-Review. A comparison between the first week of April, 1939, and the first week of April 1946 shows, first, that the News-Review is serving approximately 1,500 additional subscribers.

We learn, by comparing those same two periods, that in the first week of April 1939 we carried 158 display advertising units, while for the same period in 1946 display advertising units totaled 489.

It will be noted that we use the term "advertising units" rather than the amount of display space in inches, thus denoting the number of advertisers served rather than the amount of space used.

Despite this tremendous increase in number of advertising units, the News-Review has maintained comparative news coverage.

We note that McDannell Brown reports a production increase of 164 per cent over 1939, due to confidence "inspired by the OPA." We wonder of what this increased production consists. even greeting cards. This stuff is high priced, and possibly accounts for the increased "rate of spending" reported by Mr. Brown as 94 per cent above the 1939 rate. At least, this stuff does cost plenty, and has been produced during the days of Mr. Brown's "lack of manpower."

We contend that OPA is less concerned with controlling prices than with controlling profits. Which explains why it is easier to find a \$10 pair of trousers than a pair of overalls. But we think OPA is more concerned with perpetuation OPA than with "holding the line" of prices.

Cost of living is steadily rising. Partly due to authorized increases in prices by OPA; more by black markets, a racket that makes the bootleg racket look like kindergarten days; and mostly due to increased cost of government, including subsidies and salaries to an army of federal employees holding down jobs in OPA and other federal bureaus.

We even wonder often where the real power of government lies these days. Is it Chester Bowles, who forced Sec. Anderson to sign the cotton order? Is it the OPA who made this statement: "The OPA policy in reference to tie-in sales remains the same as previously. AND THE RECENT RULING BY THE U. S. SUPREME COURT WAS CONSIDERED AN EXCEPTIONAL CASE?" Is OPA more powerful than the Supreme Court?

Who believes the country would go to the dogs if OPA were liquidated? We hear it so often, and see it in the daily papers so often that nearly everybody believes we must continue OPA until its final liquidation would not seriously endanger the country. Hitler said that a lie, if big enough, or propaganda repeated long enough becomes accepted as truth. Our bureaucrats seem to believe that Hitler was right.

For thirteen years we have had a policy of scarcity. We plowed under pigs while widows begged; we plowed under cotton while kids froze. Then we created bureaus to "divide and pro-rate equitably" the articles which had deliberately been made scarce. Even while producers were being paid for not producing.

This policy of scarcity still prevails. This year, in the face of hunger in many lands, American farmers are prohibited by a directive of a federal bureau from "purchasing grain for feeding chickens, turkeys, ducks or other poultry in excess of 80 per cent of last April 1 to Sept. 30th." What will it be next?

This policy of scarcity is continuing daily. Strike after strike is cutting down on the production that would solve all our difficulties. Even OPA admits that full production of essentials would eliminate the necessity for "price controls," which would automatically eliminate any argument for continuance of OPA. This in turn would mean that thousands of well paid OPA employees would be looking for different jobs.

With OPA, scarcity is the key word. The manufacturer has to go of Washington to get his "share" of the scarce items he needs for carrying on his business; the lady

who wants nylons demands that Washington do something about it, and cries her gratitude if she gets a pair; the farmer's wife is with fruit wasting on the tree, goes to Washington for canning sugar, and doesn't always get enough. And so it goes, for that's what Washington wants. That proves the need for OPA.

About the only over-production we can recall now is that of federal employees. Every three or four taxpayers, (we forget the exact number, because it changes so often), have to support one of these gentlemen. Many of these employees are needed and are doing splendid work, but several hundred thousand could be dispensed with, and nobody would be hurt.

Among the good ones are Harria Ellsworth and Guv Cordon. Ellsworth is up for re-election this year, but will probably be too busy trying to help his country to do any electioneering. He has done a wonderfully good job, and deserves re-election. We, whom he has so ably served, can best show our gratitude by voting for him.

A primary election is coming up May 17th. The last day for registering for this election is April 16th. In foreign countries, the people consider it a great "privilege" to vote. In America, we should consider it not only that, but also a duty. If we are to preserve our liberties, we must exercise our right of franchise. To exercise it, we must register.

Let every opponent of the bureaucratic government, government by directive instead of government by the President, the Congress and the Supreme Court, every opponent of final and complete registration, register and vote at every election where he is privileged to vote. Let the Republican party organization and every lover of liberty urge thinking citizens to register and vote.

Above all, let us hope and pray that enough friends of liberty will be elected to the Congress and Senate next fall that Abraham Lincoln's dream of "Government of the people, by the people, for the people" will again become a reality instead of a memory.
