We are getting a faint inkling of the great truth that periods of SURPLUS, when there is FLENTY of everything, are the real periods of prosperity.

That THINGS, not MONEY, constitute wealth.

EATING is still something of a problem in San Francisco. Unless, that is, you are merely seeking to satiate your hunger. In that event, you can go out to one of the mass production eateries, where the food will be reasonably good, moderately abundant, not too long in coming to your table and the check will be something less than the latest guess at the total of the national debt.

IN San Francisco, however, one seldom does that. The idea here is to go out to one of THE places. (THE places are apt to be down on Fisherman's wharf, or out around the foot of Telegraph hill. Contrary to most other cities, there won't be much in the way of bright lights and glitter. San Franciscans still cling to the naive notion that FOOD is what one goes out to find—that surroundings are incidental.)

At these places, you're still almost certain to have to wait. While you wait, you look hungrily at the lucky devils who got there earlier than you. The hungrier you look, the longer they eat. Even after the bill comes, they'll glance up and see you with your mouth watering all over your necktie and your tongue licking your lips with anticipation and then will think of something else they could have eaten and ORDER it as a post-script.

BUT, eventually, a table will become empty. It is one of the immutable laws of nature that there is a limit to what can be put in the human stomach. When that limit arrives, somebody will get out and let you in.

Whereupon, YOU eat as slowly and as deliberately as theavenous state of your appetite will permit, and the hungrier the waiting line looks the more delicious the food will taste and the longer you will linger over it.

FISHING SEASON TO OPEN

Fishing season opens Saturday and we have just about given up the idea of trying to do any more work until next week.

Not that we plan to celebrate opening day, although we may break down when the date rolls around. But we'll probably be stuck in this misty old office, trying to wrestle a 10-page paper into the six or eight pages to which we're limited because of the newsprint shortage.

But how can a person be expected to keep his mind on his work, when someone constantly is breaking in to talk about fishing?

In fact, we will be pleased, and somewhat surprised, if we succeed in getting Saturday's edition off the press, what with Louis Reizenstein, telegraph editor; Walt Fredrickson, foreman; Herb Brown, linotype operator, and Paul Jenkins, photographer and engraver, all on the mark and ready to sprint the moment the press starts to roll—or before.

And who wouldn't be overpowered by the fishing bug? If Jack McCallister, chief of the weather bureau station, can be prevailed upon to dish out some favorable weather for the balance of the week, we, too, may cast our good resolutions into the waste basket and join the trek.

Sports fishermen who live in Douglas County, or who come to fish our waters, should, weather permitting, enjoy an exceptionally fine opening day. Water conditions are reported excellent. Although snow is melting out of the mountains, keeping stream levels high, water is fairly clear and trout are reported raising to flies. An early hatch of March Browns is reported.

Small streams, which normally yield best early-season fishing, are clearer than usual. Loon Lake doubtless will be crowded, as it is being reopened this season following closure and is said to have greatly increased its trout population. Smith River also is said to be in top condition for opening day, although fishermen will have to hike, because the road is blocked by slides.

The North and South Forks of the Umpqua, streams of the Coast Range, together with Cow Creek, Calapoia, Elk Creek and other favored waters are beckoning.

North Umpqua observers report an exceptional number of large trout. The counting station at Winchester has observed great numbers of ocean-run cutthroats going through the fishway. Brood stock from the Utah Rainbow holding ponds at the Game Commission hatchery at Rock Creek recently were distributed throughout the county. These are big trout—three, four and five pounds—and a fisherman lucky enough to tackle one of these babies will enjoy some real sport.

Although the winter steelhead run has tapered off, the counting station reports a few fish still coming, while, at the same time, spawners are on their way back to salt water.

The Chinook salmon run is under way, although the peak will not be reached for another week or two. Cold water has slowed migration. As water temperatures rise, the salmon run should improve.

Altogether it looks like a most auspicious season opening, given a break in the weather.

Maybe we'd better take another look at our tackle, just in case.

\$70,000 Hidden in Auto Is Reported Stolen

Abandoned CCC Camp at Elkton Brings Top Price

PORTLAND, April 18.—Sale of the abandoned Elkton CCC camp 14 miles west of Drain to ten bidders for a total of \$9819.29, regarded as the highest price ever paid for an abandoned CCC camp, was announced Wednesday by W. H. Horning, administrator for the Oregon and California lands administration.

With interest high in the project, 28 bidders submitted offers Tuesday for the 20 buildings contained in the camp, and most bids were over the government's appraisals. Only one, a blacksmith shop, drew no bids.

Following were the high bidders: Orville S. Beckley, Elkton, recreation hall and maintenance shop; J. W. Suter, Roseburg, education building, three barracks, mess hall and kitchen; Marion Mooney, Eugene, two shower-latrines; R. L. Bridges, Drain, infirmary, two garages, lumber lots; R. J. Hillstrom, Coos Bay, foremen's quarters, heater house; Lloyd D. Young, Roseburg, officers' quarters; J. H. Stoop and M. H. Winn, Roseburg, fuel and oil house; Robert D. Gwynny, Drain, garage; Doyle's Auto Wreckers, Roseburg, tractor parts; Withram's Auto Service, Seaside, two generators.

World Bank Grips Idle German Gold

BASLE, Switzerland.—A large sum of German money which the Allies have so far been unable to touch is on deposit in the Bank of International Settlements in Basle.

The bank's general secretary, Raffaele Piolotti, refuses to say how much German gold and assets the bank now holds and Allied diplomats said they haven't yet been able to find out.

However, figures published in the bank's annual report indicate that it has a very minimum \$50,000,000 belonging to Germany and probably considerable more in accounts which the report does not specify according to countries.

The bank holds a special, though somewhat precarious international position, under the 1930 Hague agreement which set it up to facilitate World War I reparations payments. It is immune from freezing regulations and outside officials interpret its charter as exempting it from being liable to confiscation of funds for reparations in the new peace settlement.

Japan was an active member of the bank. The First National Bank of New York City is the American member.

Allied diplomats say the bank will have to be dissolved eventually because its functions are in a large part duplicated by the new Bretton Woods fund. They predict a tough international wrangle when liquidation begins.

Favorable Outlook Seen For Oregon Fruit Crops

CORVALLIS, Ore., April 18.—(AP)—A favorable outlook for Oregon's local fruit crops is reported by the Oregon State College Extension Service.

Trees came through the winter in good condition, the report said, and later blooming than normal promised less danger from late frosts.

Rogue River Valley anticipated a larger crop of Anjou and a decline in Bosc, Bartlett and Comice pears.

OSC reported western Oregon orchards receiving better care than in other years, due to higher fruit prices. The sweet cherry crop was expected to be good, as were prunes.

Boy Slays Father Who Had Deserted Him, 2 Sisters

MURRAY, Ky., April 16.—(AP)—A 16-year-old farm boy who said he made a home for two younger sisters and a brother when their parents deserted them over a year ago, today awaited juvenile court hearing on June 3, charged with fatally shooting his father.

Acting Juvenile Judge Weldon Rayburn of Calloway county said the youth, Leonard Manning, told him at his arraignment here yesterday he killed his father, Gerwin Manning, Sr., 50, with a shotgun last Wednesday when the elder Manning came to the farm home near here with the expressed intention of removing the household goods.

Gas Chamber Death of Oregon Murderer Set

PORTLAND, Ore., April 16.—(AP)—Execution in the state penitentiary gas chamber of Wardell H. Henderson, 27, convicted of the Christmas eve killing of Walter Howard Poole, 29, Vancouver, Wash., has been set for June 28 by circuit court here.

Poole's body was found in a Vanport City street where he had been shot and stabbed after leaving a Jantzen beach store where he worked late Christmas eve.
