by Curran and Harry Bridges, head of the CIO longshoremen. There was some difference of opinion as to whether the union had rejected a fact-finding board's recommendation for a 22-cent-an-hour raise for West Coast longshoremen.

A turn-down by Bridges was reported yesterday by Frank P. Folsie, spokesman for West Coast waterfront employers.

Union leaders said Folsie had broken a pledge not to discuss negotiations publicly. Edgar L. Warren, director of the Labor Department's conciliation service, said that Bridges had not made a final rejection.

Parley Privilege Won
The AFL has maritime unions, too, and they have asserted themselves.

AFL seaman on the West Coast, headed by Harry Lundberg, apparently won their fight to force an immediate start of their own negotiations with the Pacific American Shipowners Association. They won it by voting to take no more ships to sea for that group until negotiations were arranged.

A session accordingly was scheduled today in San Francisco, though not with the two main spokesmen for the shipowners' association. Those men, President John B. Bryan and Attorney Gregory Harrison, were still in Washington for the negotiations with the Committee for Maritime Unity.

Bryan told a reporter here: "Lundberg thinks his problem is paramount, and the CIO leaders think their problem is paramount."

Bryan was asked which problem he put first.

"I think they are of equal importance," he replied. "If we don't square the two of them together, we're in the soup."

Other officers of the shipowners' association were to deal with the AFL men until Bryan and Harrison could get back home.

West Coast operators submitted a proposal last night, government conciliators reported, for applying, with some modifications, whatever east coast agreement is eventually reached to the various disputes between West Coast unions and Pacific operators.

Details of this proposal were not made public.

Congress Plans Industry Aid For Areas to be Faced With Off-the-Farm Worker Influx

WASHINGTON.—Main street's opportunity for industrial development is knocking at the door of Congress.

The Department of Agriculture estimated that within 10 years—if the cotton picker, flame cultivator and other machines now becoming available find quick acceptance—perhaps one of every four farmers and farm workers in the south will be without work.

According to department estimates, 4,000,000 to 7,000,000 new jobs will be required off the farm in the next 10 years to provide for displaced farm workers, increased population and pre-war unemployment in the south.

To Avert Ghost Towns
Many communities which mushroomed with "war baby" industries that may be the difference between prosperity and ghost towns.

Senator Bailey (D., N. C.), and Representative Hays (D., Ark.) have started the ball rolling by introduction of identical bills in the Senate and House "to provide for aid in industrialization of underdeveloped areas."

The legislation avoids any mention of "decentralization" of industry. The sponsors say "Let us help the people find opportunities where they are—not to become industrially prosperous by taking away opportunities at the expense of other regions."

Nevertheless, a major portion of opposition to the bill probably will pivot on the decentralization issue.

Five-Point Program
Under the legislation, funds would be authorized for the Commerce, Agriculture and Labor departments to encourage private enterprise, in cooperation with state and other agencies, in under-industrialized areas by:

1. Providing technical aid for farmers, businessmen, workers, cooperatives, civic organizations, clubs and committees, community study groups and local and state governmental agencies.
2. Preparing and distributing technical and economic information on opportunities in private enterprise in various industries and regions.
3. Providing assistance to authorized federal, state, local and private agencies engaged in training of returning servicemen, war workers, farmers and other workers to fit the needs of new or expanding industries.
4. Giving advice to expanding or new enterprises in finding adequate financing.
5. Cooperating with public utilities, transportation systems and other enterprises in making provisions to improve or enlarge their facilities.

Commerce Secretary Wallace and Agriculture Secretary Anderson already have endorsed the bill. However, a rocky road lies ahead.

Representative Hays has heard that not all rural communities want industries.

King of Greece, Exiled Three Years Ago, Expects Nation to Summon Him Back to Throne

LONDON.—Greeks who know King George II, who has been exiled from Greece three times in less than 30 years, are confident he will return once more to his throne in Athens.

King George has maintained a discreet silence on political events in civil war-torn Greece but he has sent Col. Dimitrios Lavidis, master of the royal household, back to Athens and informed sources said the monarch was expecting to be recalled by the new pro-royalist government before many months have passed.

Only last fall many Greek political observers gave the king less than a 50-50 chance of regaining power. But the Populist (monarchist) party victory in the March elections brought a new air of optimism to the book-lined suite at Claridge's Hotel where George has held informal "court" during much of the Nazi occupation and succeeding liberation.

Maintained Prerogatives
King George has kept closely informed on Greek developments since he went into virtual seclusion after the 1944 civil war and his appointment of Archbishop Damaskinos as regent.

His last public statement was in November 1945 when he issued a strong protest against the regent's ostensions of a plebiscite on the monarchy in 1948. Post-election statements of Populist leaders indicate they also favor an immediate poll on restoration of the king.

The spruce-dressed, balding king often strolled unnoticed along Mayfair streets as he lived the quiet life of hundreds of others who took refuge in Britain.

Today, informed sources said, King George II of the Hellenes is more of a force in Greek politics than at any time since the German invasion in April 1941.

Diplomatic couriers travel between Athens and London on the king's errands and he is reported in close contact with the new government leaders.

Indian Receives Second Term From Same Judge

KLAMATH FALLS, Ore., June 8.—(P)—Willard Williams, 30-year-old Klamath Indian, was sentenced to spend the remainder of his natural life in a federal penitentiary yesterday by Federal Judge Fee in federal district court here. It was the second time Judge Fee has sent Williams up for a killing.

The Indian was convicted by a jury in Portland a month ago on a second degree murder charge in the slaying of Egbert Hugo Smith, young Klamath Indian, at the climax of a New Year's Day celebration at Beatty on the reservation.

In 1934, when Williams was only 19 years old, he was involved in the stabbing death of Charlie Cowan, a Modoc Indian, and was sentenced by Judge Fee to seven years in prison after conviction on a manslaughter count.

Albert Preston Talkington, 69, retired automobile dealer of Blackwell, Okla., died after a short illness in Roseburg yesterday afternoon. He was born Jan. 27, 1877, in South Haven, Kas. He had come to Roseburg several months ago to visit with relatives and friends. His son, Ralph, arrived by plane Wednesday to be with his father at the hospital.

Surviving are three sons: Cecil R., Houston, Texas; Willie B., Kansas City, Mo.; Ralph F., River side, Calif.; one brother, Roy, Oklahoma City, Okla.; two sisters: Mrs. Minnie Thompson, Oklahoma City, Mrs. Ella Morris, Olympia, Wash., two grandchildren and one great-grandchild.

The body is being shipped by the Roseburg Funeral Home to Caldwell, Kas., for funeral services and interment.

Chief Justice Stone's Estate Nearly \$900,000

WASHINGTON, June 8.—(P)—The estate of the late Chief Justice Harlan Fiske Stone was valued at nearly \$900,000 in a petition for probate of his will filed yesterday in circuit court.

Personal property, including stocks, bonds and cash, was listed at \$800,517, and the remainder was in real estate.

Under the will, his widow, Mrs. Agnes Harvey Stone, was left a life interest in the family home here, and a life income from the residuary estate, in trust, after certain bequests are taken care of.

gent who, officials had said earlier were implicated, have not yet been taken into custody.

A polygraph, or "lie detector" apparatus "very definitely" played a part in obtaining confessions from the Durants, who were flown here this morning.

The Durants were married May 28 by a justice of the peace at Chicago. They had obtained a new Hudson automobile. In the period from their marriage until they were apprehended early Monday morning at the LaSalle Hotel in Chicago, they were traced by Army investigators to Hudson, Wis., Minneapolis and St. Paul, and probably visited other places, Pierce stated.

Whether all the jewels and valuables have been recovered will not be determined pending a detailed inventory.

Pierce said that whether others than the unidentified major and technical sergeant are involved in the case will be "up to the courts to decide."

Priceless Relics Included

Aside from the jewels, Pierce said, items recovered at Hudson, Wis., included such relics as bound volumes of correspondence of Britain's Queen Victoria, and an autographed book with

paintings dating from the year 1611.

All had been removed last year from Kronberg Castle, near Frankfurt, the seat of the royal house of Hesse-Darmstadt, when the 100-room castle was used as a rest house for American Army personnel stationed at Army headquarters at Frankfurt, he said.

The valuables recovered at Hudson, Wis., Pierce reported, were "just hidden in the house, a little here and a little there."

Escaped Hotel Tragedy

Col. C. A. Miller of the provost marshal general's office, said yesterday the Durants' arrest in the LaSalle Hotel occurred less than 48 hours before the hostelry was swept by fire that cost 60 lives.

"We probably saved their lives," Miller remarked. "They were on one of the floors that were burned out."

Relating the story of the jewel theft, Miller said:

"Very heavy air raids in 1944 convinced the members of the royal house of Hesse that it would be wise to remove their jewels and heirlooms from banks and hide them in the old castle.

"They took with them a native German workman, and selected an isolated spot in the cellar.

"They put the jewels in a lead-lined casket. This they put in a wooden box. It was buried.

"Then the mason replaced the key stone and fixed up the floor. At the same time they also concealed in the sub-cellar 1600 bottles of wine of ancient vintage."

The jewels consisted, he said, of a magnificent array of necklaces, rings and diadems.

Continuing his story, Col. Miller said that in April of 1945, the family was forced to flee the castle because American troops were drawing near.

Wine Arouses Suspicion

"The Americans moved in and found certain trinkets, and went on scouting expeditions through the castle, primarily for something to drink," he went on.

"They found about 1800 bottles that had not been very carefully concealed. Searching further they found the choice wine that had been hidden.

"Since it was so carefully secreted," continued the colonel, "one of the soldiers felt there must be something else hidden. They continued their search and finally suspected a certain spot."

"They got a local workman to help them. They had to blast open the box."

The jewels were turned over to the custody of the WAC captain who was then in charge of the rest home. Col. Miller said, but she never made a formal report to military authorities that she had them.

Morse Asks Full Probe Of 'Ham Acting' Charge

PORTLAND, June 8.—(P)—Sen. Wayne Morse issued here briefly today en route to Eugene and said:

Relative to his statement in the Senate that the president was guilty of "ham acting" in his rail strike message, he has asked for a full investigation, with testimony under oath, of the time agreement was reached with the rail brotherhoods; that Congress must have a foundation of facts before it can build other than a patch-work labor law; that he has asked for early consideration of Lanham act extension to provide funds for schools.

Republic of Italy May Be Proclaimed Today

ROME, June 8.—(P)—Ceremonies formally proclaiming the Italian Republic may be held in Rome late today, after which King Umberto II. will leave Italy for voluntary exile in Portugal.

There were no reports of new rioting this morning, following yesterday's monarchist demonstrations in Rome and Naples in which police said two persons were killed. About 20 persons were reported injured in the outbursts by which royalists expressed their dissatisfaction with the results of the plebiscite.
