In the Day's News

The big job of the future will be to keep wars from starting. That is what Mr. Byrnes is trying to do now.

THE shooting of four Negroes in Georgia the other day is a terrible thing—both in itself and in the ammunition it gives to Russia in her campaign to prove that America is insincere in her professed ideals.

Still, along with Bilbo and Talmadge, it goes to show that the race problem in this country can't be solved by the kind of political hocus-pocus we have been employing in the past.

The solution will have to come out of the slow process of education, enlightenment and tolerance of the rights of others.

ONE of our national scandals has been the more or less annual rumpus in Washington over the anti-lynching law—which for years has been used by conscienceless demagogues as a sounding board for appealing to INTOLERANT voters.

You can't solve race problems that way.

SPEAKING of politics, movements are under way in various parts of the country to organize consumers into leagues, committees, etc., to fight for OPA as a sacred cause.

If you are wise, you will stay out of such organizations—which are being promoted largely because of the ease with which they can be used as a tail to political kites.

If the price of luxuries, semi-luxuries and non-necessities of life gets too steep for you, DO WITHOUT. (It won't be much harder to do without because the price is too high than it has been to do without because they are not available.)

Doing without because the price is too high is a sound and logical working out of the law of supply and demand. It always has been effective in bringing demand into balance with supply, and it always will be.

ALONG that line, the Department of Agriculture's production and marketing administration reports that wheat prices have been declining sharply on the Portland market throughout the past week.

The principal factors in the decline, the report says, have been: 1. Satisfaction of the feed trade's demands.

2. Unwillingness of millers to compete for grain at the HIGH-ER PRICES.

3. Pressure of new crop wheat (the new wheat crop is expected to break ALL records).

THUS we see the law of supply and demand in actual operation and WORKING.

OPA or no OPA, prices will come down whenever more of any commodity is being offered for sale than buyers are willing to take at the offered price.

Ship Laden With Relief Food Sunk in Collision

NEW YORK, Aug. 1.—(AP)—The new 8,258-ton freighter, American Farmer, carrying six passengers, 51 crew members and 8,500 tons of vitally needed food for Great Britain, sank last night about 400 miles west of the English coast after being in collision with the cattle ship William J. Riddle.

The Riddle radioed that she had rescued all aboard the farmer. A London dispatch said none was injured.

HIGHER CLOTHING COSTS

The OPA has authorized a general price increase of 11 per cent on men's and boys' shirts, shorts and pajamas, with an extra 10 per cent on dress shirts and boys' sport shirts. Additional price hikes of 15 to 20 per cent are anticipated on other clothing items.

Can you imagine the furore which would have resulted had clothing prices been upped 11 per cent during the OPA holiday?

Press services would have furnished lurid accounts of "soaring" prices. OPA propagandists would have wrung their hands in holy horror. Trade unions, veterans organizations, buyers' councils would have organized picket lines, demonstrations and boycotts. Petite movie stars would have paraded in barrels to secure cheesecake publicity. Public resistance to increased clothing prices would have swept the country.

But now that the OPA has officially authorized the boost, the new prices probably will be accepted without protest.

We have no doubt that higher prices are necessary in the clothing industry. The cost of raw material is up, workers in the garment industry, notoriously underpaid in past years, have received justifiable wage increases, while OPA ceilings have held prices to a point where many types of clothing, particularly in the lower price range, were forced out of manufacture, causing inferior quality, subterfuge and even black market practices to be invoked to maintain even limited production. The OPA's claim of "holding the line" is not justified when consumers, unable to find the type of garment desired, even at advanced prices, must buy another type of garment in a much higher price range.

But we are not as much interested in price statistics as in the frame of public mind, which permits us to kid ourselves into the belief we are being afforded protection, when, in fact, we are being gloriously hoodwinked in a game of political strategy, and made to like it through propaganda based on fright psychology.

During the OPA holiday, propagandists strove mightily to create mass hysteria. Price increases, many of which merely offset withdrawn subsidies, particularly on dairy products and meat, were used to foment fear of galloping inflation. But in spite of propagandists, aided and abetted by communistic organizations, the effort to incite mass hysteria failed.

Instead, buyers' resistance quickly developed. This resistance, intolerant in many respects, succeeded in breaking some prices even below justifiable levels. It would have gained order, discipline, and understanding in time, and would have served as an effective brake on inflation, while, at the same time, production would have been stimulated.

But now we are back under OPA, which, in one of its first moves, has authorized increased clothing prices, an action which if attempted during the holiday would have created a storm of public protest, even though higher prices were justified.

It is our opinion that living costs will be higher under OPA, hamstrung though it may be by the crazy quilt authorization under which it now operates, than had we scrapped price controls once and for all.

Comment on Congress

Highlights of Weekly Proceedings Related by Analytical Lawmaker

NEW OPA LAW Considerable space has been taken in my weekly letter in the discussion of OPA legislation. This will be my last comment on the subject for quite some time.

The price control holiday, brought about by the President's veto, is ended. OPA goes back into action.

The principal difference between the new law and the one which expired June 30th is that there will be a super-board of three with power over the administrator. The record of the past several years proves that our difficulties have only been increased and confusion achieved by the administrative practice of setting up a new board, committee or single executive on top of other authorities.

There is no reason I can think of to believe that this practice, which has been unsuccessful before, will work this time. The OPA bill vetoed by the President was a reasonable and workable piece of legislation. I do not think the new OPA bill is, but I sincerely hope I am wrong.

SESSION ENDING This session of Congress is about to end. In fact, it may have ended by the time these words appear in print. It has been a long and difficult session. The transition of our country from war to peace has all of the difficulties and more than the development of a peaceful country into a winning fighting machine. The difficulties of the transition to peace are the more complex, because this transition is without the appealing influence of the urgency of war. Quite possibly mistakes have been made by Congress, but it is my observation that sincere effort and hard work have been devoted to the many difficult problems.

HOME SOON I shall leave for Oregon shortly after the first of August and hope to spend several months in my congressional district. This, therefore, is my last weekly letter for this session of Congress.

Cardinals Even Series by Victory Over Dodgers, 10-3

The best laid plans of mice and men go astray now and then, as Leo Durocher, mastermind manager of the Brooklyn Dodgers, is ready to admit today.

Leo saw his latest bit of strategy backfire on him yesterday as the second place St. Louis Cardinals belabored Southpaw Batten and two successors for 15 hits and a 10-3 victory over the National League leaders.

The Card triumph evened the "crucial" series between the two contenders and once again the Brooks lead stands at two and a half games with the rubber contest to be played today.

Before the important three-game tussle, Durocher announced he would switch from his original pitching nominee, Hatten, to Melton, a non-winner up to then, to work the opener if Eddie Dyer's selection was Pollet, the Card's ace.

Leo's luck appeared more pronounced than ever when Melton, having one of his rare good days, outpitched Pollet Tuesday night and with Hatten, fully rested, on tap, the experts were ready to award Durocher another "E" for efficiency.

So what happened? Hatten got his ears pinned back, and Murry Mason, recently elevated from relief roles, held the Brooklyn at bay while the Red Birds pounded out their biggest hit total in four weeks.

Feller Humbles Bosox The Card-Dodger tussle partly overshadowed Bobby Feller's scintillating one-hit pitching exhibition against the Boston Red Sox as he registered his 20th victory by twirling the Cleveland Indians to a 4-1 victory.

The triumph gave Feller another line in the record books as it tied Abbie Joss' Major League standard of seven one-hit games. Joss also hurled for the Indians. Oddly enough, it was Bobby Doerr, who once before on May 25, 1939, spoiled Feller's bid for a no-hitter, who got Boston's only hit, a single in the second inning. Feller already owns two no-hitters. The fireball king fanned nine to increase his season total to 220.

DETROIT Displaces Yanks The Detroit Tigers replaced the New York Yankees as Boston's closest rival by defeating the Bronxites 6-0 to wrest second place from their victims by one percentage point.

Passau, recuperating from an ailing back which had sidelined him for almost two weeks, pitched the third place Chicago Cubs to an 8-1 victory over the New York Giants.

A triple by Connie Ryan scored Fernandez from first base with the winning run in the ninth inning as the Boston Braves edged out the card-dwelling Pittsburgh Pirates 2-1.

After dropping six straight in Shibe Park, the Cincinnati Reds turned about and downed the Philadelphia Phillies twice, 4-3 and 2-0, the opener in the 11th inning.

Helped by Bob Kennedy's fourth home run, the Chicago White Sox scored three times in the ninth inning to come from behind and defeat the Philadelphia Athletics 3-2. Four hits and an error produced four runs in the eighth inning for the St. Louis Browns, enough to beat the Washington Senators 6-2. Nelson Potter yielded six hits to earn his seventh success.

Seals Again Down Oaks, Bolstering Coast Loop Lead

The San Francisco Seals today hopefully ogled the Pacific Coast League pennant after their second successive blasting of the suddenly puncheon Oakland Aces.

By humiliating the Acons 9-2 last night, the Seals grabbed a three-game advantage over the Oaklanders in the flag race. Melton chalked up his 16th victory for the Seals against eight losses, although he was removed in the sixth inning with an elbow pain. Matthewson finished, and between the two the Acons got seven hits, while San Francisco batsmen pounded Speer for 12.
