House Votes Two-Cent Tax on Cigarettes

Unexpectedly made their first appearance on the floor of the 60-day-old legislature today, with the Senate Labor and Industries committee recommending passage of measures to ban secondary boycotts and provide for secret elections to determine if labor disputes exist.

The measure probably will be debated by the Senate Friday. The committee voted 4 to 2 against reporting out a third bill. It would let courts issue injunctions in labor disputes.

If the Senate passes the two bills, they will go to the House to be considered along with proposed constitutional amendments to ban the closed shop and require labor unions to incorporate. Several members of the House Labor and Industries committee are critical of the Senate bills, asserting they will need several amendments to make them work.

The House assessment and taxation committee today tabled a proposal to levy a 30 per cent tax on gross receipts of slot machines, pinball games and punchboards, regardless of their legality.

The bill, by Rep. Giles L. French, Moro, would give 60 per cent of the revenue to the state general fund, and 40 per cent to counties and cities.

Milk Bill Shelved Possibility of a milk fight disappeared when the Senate rules committee voted against introducing the bill, sponsored by Portland chain stores and club women, to pave the way to permit stores to sell milk more cheaply than home-delivered milk. The committee said it is too late in the session to act on such a controversial question.

Governor Snell signed a bill requiring doctors to report to the secretary of state all epileptics and other persons subject to unconsciousness. The information would be used as a basis on which to deny applications for motor vehicle drivers' licenses.

Rep. Wilson, Newport, sponsored a memorial asking congress to prevent the importing of foreign crab meat into the United States.

The House sent to the Senate a bill taxing pleasure boats and personal property, and sent to the governor a bill providing for joint use of utility poles along highways.

The Senate defeated, 19 to 9, a bill to extend the unemployment compensation law to all employers. The law now applies to employers of four or more persons, but other employers may come under the act if they wish.

The House adopted and sent to the Senate a bill suspending operation of state educational loans for veterans between next July 1 and July 1, 1949. The sponsors said the law would not be needed during that period because federal loans will be available, and that the state law might be placed into operation again after the federal government stops its educational loans to veterans.

The chairman said the equipment, mostly pipelines, was obtained for shipment to Russia under lend-lease agreement but had not been transported prior to last Dec. 31.

A provision in a 1946 lend-lease appropriation prohibited use of any administrative funds for shipments after that date. Taber said the State Department asked authority to complete the transaction anyway.

The president's declaration, the premier added, marked the end of any American isolation by espousing that opinion of security, and thus gave to all nations the hope for freedom within their own borders.
