

## NOTICE OF 1947-1948 BUDGET MEETING, DOUGLAS COUNTY, OREGON

Pursuant to the provisions of the "Local Budget Law," being sections 110-1201 to 110-1215 O.C.L.A. as amended, notice is hereby given that the Budget Committee for Douglas County, Oregon, has prepared, in compliance with said "Local Budget Law," budget estimates for said county for the fiscal year beginning July 1, 1947 and ending June 30, 1948.

All persons are hereby notified that on Saturday the 12th day of July, 1947, commencing at the hour of 10 o'clock in the forenoon of said day, in the Court House in Roseburg, Douglas County, Oregon, the following budget estimates for the fiscal year ending June 30, 1948, for Douglas County, Oregon, may be discussed with the County Clerk, the levying board for said county, and any person subject to the proposed tax levy or tax levies will be heard in favor of or against said proposed tax levy or tax levies on the part thereof. The estimates of the expenditures to be required, the miscellaneous revenue to be received and the taxes on the property to be levied, as prepared by the said budget committee and adopted June 12, 1947, are as set forth in the accompanying statements and said statements show a summary of indebtedness, if any, as of April 1, 1947.

The original estimate sheets, as required by Section 110-1204 O.C.L.A. have been placed on file in the office of the county clerk of Douglas County, Oregon, at Roseburg in said county, and may be inspected by any person or persons interested therein.
