voted to pass it over the President's veto knew all that in advance. They knew what they would have of face. They are among the shrewdest judges of public opinion we have. If they hadn't believed there is strong public demand for what they have done, they wouldn't have done it.

So we may assume that there are TWO sides to the political issue that is involved.

KEEP this fact also in mind: Basically, the new law amends the Wagner act. The Wagner act put too much power in too few hands. That was its greatest fault.

Collective bargaining is merely collective BARGAINING. If you and I sit down at a table to make a bargain and I have TOO MUCH POWER, the contract we make is pretty likely to be badly one-sided. All business men know that a contract (which is simply the written memorandum of a bargain that has been made) is pretty likely to be unprofitable if it is badly one-sided—that is to say, if it gives the bulk of the benefits to one side.

Hard experience has taught us that very, very many of these bargains (with their accompanying contracts) have worked out unsatisfactorily in practice. That is why the demand has arisen for amendment of the Wagner act.

ALWAYS, in the past, our labor laws have been one-sided. For generations, business had too much power. This power was abused. Then came the Wagner act, with its grant of too much power to the unions. That power has likewise been abused.

What we must have, if there is to be industrial peace and the great prosperity we all want and can have if we go about it right, is a balanced law that gives NEITHER SIDE too much power. That, and only that, can insure the cooperation we must have if we are to get where we want to get.

Cooperation AMONG EQUALS works. There is seldom much cooperation between a big man with a club and a little man with a toothpick.

WHAT the public wants is a law that will be fair to both sides. The Wagner act wasn't fair. The labor laws in the old days weren't fair. The fact is generally recognized that we need to make a new start.

If this new law proves to be unfair to labor, as its political enemies assert, we can amend it. The unprejudiced, non-political public will DEMAND amendment if it turns out that all we have done is to put too much power back into another set of hands. The thing to do is to see if we can make it work. If, in practice, we find sections that are unworkable (because they put too much power in too few hands) we can amend these sections so that they will work.

Making our industrial system work is the goal that all good citizens want to reach.

PROOF BY DEFIANCE

Although it is as yet too early to know the policy of organized labor as a whole in counterattacking the Taft-Hartley labor control law, there is evidence that some segments at least threaten strikes, work stoppages and slowdowns as demonstrations of defiance. There is no better way for organized labor to show NEED for the control bill than to fight it with the strike weapon.

When any organization becomes so strong that it feels it can defy the law of the land — even though the law may have serious faults — there is obviously ample evidence that curbing is necessary.

Labor has every right to act through legitimate channels against the measure. It has every right to use influence to beat the act and those who endorsed it. That is an American privilege which should not be abridged.

But the Taft-Hartley act was and is a remonstrance against excesses and abuses by radical labor leadership. If it is combatted by further excesses, then the method of attack will serve only to prove necessity of and for the legislation.

The labor control law is neither as bad as some labor spokesmen would have the public believe, nor is it as good as some of its sponsors and backers claim. It offers many complications serving only to create confusion. It is not as clearly cut nor as well defined as it should be. It contains many political compromises. Too much politics went into its composition. Yet it proposes controls over radical abuse of power and affords a measure of protection against continued harassment of public interest.

For many years our national legislation has favored organized labor. Enormous gains have been made. Had these gains been respectfully treated, there would be no need to-day for the Taft-Hartley act.

But because increasing power encouraged ambition for still more power, many abuses of legislative privilege resulted. Numerous instances of radical leadership occurred. The national interest was critically affected by continued interference with productive capacity, resulting in wastage of many millions of dollars in potential purchasing power.

General dissatisfaction with these conditions caused demands for curbing labor excesses, and the Taft-Hartley act was passed despite presidential veto.

Labor, which has had all advantages in legislation over a period of many years, naturally is aggrieved. A setback after a long chain of successes is hard to take. Loss of gains achieved through years of effort cannot help but produce anger.

There is no reason, however, why labor should lose permanently any legitimate benefits. Some of these gains, claimed as benefits, such as the closed shop, privilege of jurisdictional strikes, secondary boycotts, etc., are controversial issues. Whether they are good for unions or only for radical leadership is open to dispute.

But if the labor control bill is proved erroneous in part, it is subject to amendment. If certain benefits to which labor is rightfully entitled have been unfairly destroyed, then their restoration can be obtained when it can be shown that public interest will be better served.

It is seldom that any piece of large-scale legislation is ever perfect in original form. Perhaps no more controversial act was ever passed than the Wagner act — Labor's Bill of Rights. But the Wagner act, which greatly advanced the cause of organized labor, had many admitted faults.

Doubtless there are similar faults in the Taft-Hartley law, but these can be corrected as amendment is indicated.

Nothing is to be gained, however, by name-calling, charges and countercharges, extravagant claims and accusations. Labor's right to contest, through established channels, any injustices contained in the act should be protected. But labor will alienate much public support if it adopts a policy of defiance and indulges in further excesses as an expression of its anger.

Slugging Trio of N. Y. Giants Keeps Team in Top Spot

Johnny Mize, Walker Cooper and Willard Marshall, the thumping trio of the New York Giants, have been slugging enemy pitchers at such a terrific rate that veteran observers have begun to compare them with the famous old murderers' row of the New York Yankees.

But even the Yankee wrecking crew of Babe Ruth, Lou Gehrig and Tony Lazzeri, despite its tremendous slugging prowess, could not accomplish what the 1947 Giant trio is heading for. At their current pace, Mize, Cooper and Marshall may finish one, two, three in the National League home run and runs batted in championship race. No other trio ever achieved such a feat.

Mize, Cooper and Marshall drove in all the Giants' runs yesterday in their 9-3 victory over the Cubs in Chicago. Each walked a home run, with Cooper knocking in four runs, Mize three and Marshall two.

The win moved the Giants a game away from the front running Boston Braves and a half game back of the second place Brooklyn Dodgers.

Rookies Harry Taylor and Johnny Jorgensen starred for the Dodgers, who defeated the Pirates 6-2 in Pittsburgh for the 21st setback in the Bucs' last 26 games. Taylor limited the Pirates to seven hits in gaining his fifth victory while Jorgensen drove home five runs with a single, double and triple against his former mate, Higbee.

Shea, Blanks Cleveland
Shea, the Yankees' sensational righthander spun his third

shutout of the season when he limited the Cleveland Indians to three hits as the Yankees won 3-0. The win increased the Yankees' first place lead in the American League to two and a half games.

Scoring four runs in the last half of the ninth, the Cincinnati Reds came from behind to nip the Phillies, 9-8, in a thriller at Cincinnati.

Detroit's slugging Tigers snapped a 10-game losing streak by scoring a 4-2 victory over the second place Boston Red Sox, but reverted to their losing ways as the Sox took the second game of the doubleheader, 4-3.

The third place Athletics turned back the St. Louis Browns, 4-2. Washington and Chicago in the American League and Boston and St. Louis in the National were not scheduled.

Jimmy Doyle Dies After K. O. Blow

CLEVELAND, June 26. — (P) — Declaring he did not want "a cloud on Ohio boxing," Coroner Samuel J. Gerber today promised a complete investigation of the death of Jimmy Doyle, 22-year-old Californian who never regained consciousness after being knocked out by welterweight Champion Ray (Sugar) Robinson in the eighth round of a title fight at the arena here Tuesday night.

Doyle was knocked out when he stepped into a stiff left hook and died of a brain injury 17 hours later in a hospital.

The old wounds in his brain tissue were inflicted March 11, 1946, when Middleweight Artie Levine's blows sent the plucky Los Angeles boxer to the same hospital.

Dr. Gerber reported "Doyle died from a cerebral hemorrhage. There was general hemorrhage in the brain. There was concussion also.

"His head striking the ring floor may have added to the damage. But the blow to the jaw or face was the cause of the injury to the brain. The evidence of the old brain injuries are there."
