HE concludes: "So long as Communists are out in the open in our country, they will never have a chance. I want to keep them in the open."

STATEMENTS like that take courage, for at the moment our fear of Communism is so great that a lot of our people are beginning to say "there ought to be a law ag'in it."

We have plenty of proof in America that merely passing a law can't cure evils. Passing a law against Communism won't stop Communism. It will take more than that.

We'd better meet the Communists out in the open, and lick them there. The more we know about Communism, the less we shall like it.

Give Dewey credit for willingness to take a stand on an issue of fundamental importance.

THE Supreme Court of the United States moves into the troubled question involved when colored people start to move into residential neighborhoods that are predominantly white.

You can't do it by law, the high court says. But at the same time it adds that it CAN be done by voluntary means. The court says:

1. White owners of property can get together AMONG THEMSELVES and make all the PRIVATE restrictive agreements they wish so long as the purposes are carried out by voluntary means alone.

2. No matter how discriminatory or wrongful such private agreements may be, those excluded because of them can expect to find no redress in the 14th amendment to the constitution.

THIS writer doesn't know much about law, but that sounds like good common sense. We'll never get far toward a solution of our race problem by FORCING people to live together when they don't want to live together.

COLOMBIA severs diplomatic relations with Russia. Bogota, you will remember, is the capital of Colombia, and it was in Bogota where the bloody and not at all usual revolt of a few weeks ago occurred. There has been strong suspicion that the revolt was started or at least aided by Communists.

Meanwhile, it would be interesting to know who shot Galtan, whose assassination touched off the uprising. Somebody must know who did it.

MORE JOBS PER TREE

The Western Forest Industries Association is conducting a series of meetings in Douglas County this week to tighten its organization created primarily to oppose the cooperative contract program of sustained yield forest management.

The WFIA claims it does not oppose sustained yield, and, in fact, declares itself in favor of sustained yield management. It does, however, oppose cooperative contracts, insisting that sales of federally-owned timber be exclusively on a competitive basis.

This writer is an earnest advocate of the sustained yield program. The form as currently proposed needs minor revisions, in our opinion, but, according to our beliefs, is the most workable so far proposed.

The Simpson Logging Co. at Shelton, Wash., has just completed its first year under a contract with the U. S. Forest Service. Far from being a "big" operator, the Simpson company's Shelton plant is geared to local requirements of approximately 100 million board feet annually.

The company at the time of its contract a year ago owned about one billion feet of merchantable timber on 20,000 acres of land and, in addition, had 138,000 acres of land supporting reproduction of various ages from 70 years down to recent cutovers.

Without National Forest timber, the company would have cleaned up its supply of merchantable timber in about 10 years, leaving a ghost town. Had the National Forest timber been offered on a competitive basis, and had the Simpson Co. purchased all of it, production could have been maintained at present capacity for a period of about 19 years.

But here is the payoff: Employment during the year jumped from 1,350 to 1,800 persons. This, of course, includes other operations than the Shelton plant alone.

Hollywood Film Writer Convicted On Contempt Count

WASHINGTON, May 6.—(AP)—A federal court jury yesterday convicted movie writer Dalton Trumbo of contempt of Congress.

The jury took two hours to reach its verdict of guilty on these two charges: (1) That the Hollywood writer refused to tell the House Committee on Un-American Activities if he was, or ever had been, a Communist; and (2) that he refused to tell the committee if he was a member of the Screen Writers Guild.

Both questions were asked during a committee investigation last fall into Communist influences in movie land. Trumbo is the second of ten Hollywood figures to be convicted of contempt.

John Howard Lawson, another film writer, was convicted on one count two weeks ago. He has not been sentenced.

A third Hollywood writer, Albert Maltz, is due to go on trial today on a similar contempt charge.

All ten are accused of failing to tell the committee if they were Communists.

Trumbo can be sentenced to a year in jail and \$1,000 fine on each of the two counts of which he was convicted.

Lawson is appealing his conviction and Trumbo is also expected to appeal.

Trumbo wrote the film stories for such pictures as "Our Vines Have Tender Grapes" and "Thirty Seconds Over Tokyo."
