

Bad Road Offers Problem in School Bus Contract

Transportation of high school students living on Cow Creek in the Anchor and Galesville Districts to Glendale High School, because of alleged poor road conditions is a problem confronting the Non-High School District Board.

The board is meeting with the

Douglas County Court Wednesday at 3 p.m. to discuss the road problems.

According to County School Superintendent Mrs. Lulu C. Gorrill, Azalea Grange has complained of hazards of the road, and indications are many parents in that vicinity are refusing to send their children by bus over the present road unless improvements are made.

They charge that the road is dangerous because it is narrow with sharp turns, and that at the present time dust constitutes a hazard.

Last year Glendale district contracted to haul the children, but has refused to do so this year. It is now up to the Non-High School Board to provide transportation, but the members have expressed unwillingness to assume the responsibility until further investigation is made.

There are 13 high school children at Anchor and several more from Galesville who require transportation to Glendale.

County Judge D. N. Busenbark stated that the county court had granted the Non-High Board a hearing but that he was not prepared to discuss the road problem until more fully informed.

Johnson Lumber Mill Strike Brought to End

TOLEDO, Ore., Aug. 31.—(P)—The C. D. Johnson lumber mill resumed operations yesterday after a two-week shutdown in a dispute with AFL workers.

About 600 men were involved in the work stoppage.

A spokesman for the AFL Lumber and Sawmill Workers Union Local 2720 reported members voted Saturday to accept a contract previously approved by the union's negotiators.

The work stoppage stemmed from disagreement on payment of overtime on overtime. Terms of the settlement were not disclosed.

Labor Press Editor Beats Ouster Attempt

PORTLAND, Aug. 31.—(P)—S. Eugene Allen will remain editor of the Oregon Labor Press, despite the appeal of S. P. Stevens, vice-president of the International Association of Fire-Fighters, for Allen's ouster.

The AFL newspaper's board of directors upheld Allen in a special hearing, saying that his paper followed the official stand of the state AFL.

Allen criticized Stevens editorially. Stevens responded by charging Allen with "Red-baiting."

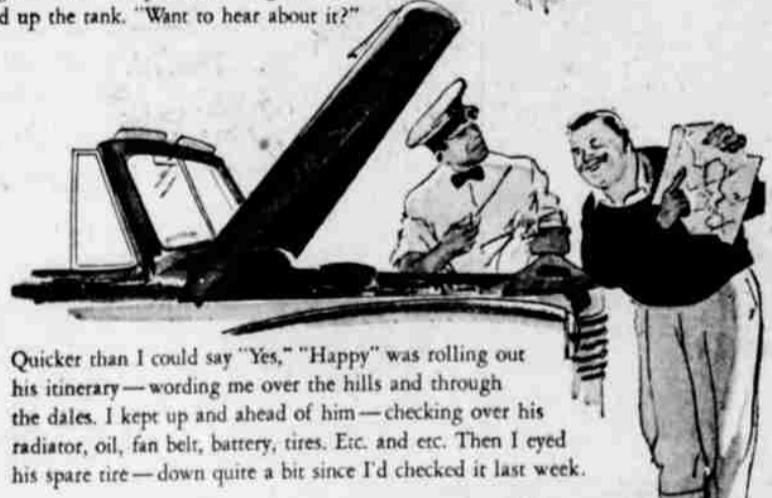
