Education Bill Compromise Reported Reached

WASHINGTON, Aug. 12.—(AP)—Rep. Powell (D-N.Y.) said Thursday 13 members—a majority of the House Labor committee—have agreed tentatively to a compromise aid to education bill.

Other committee members termed Powell's announcement "premature" but said the compromise has strong support. As proposed by Rep. Burke (D-Ohio), it would limit the use of federal money to pay salaries of public school teachers.

Burke's bill would trim the amount of money from the \$300,000,000 provided in a Senate-passed measure to \$20,000,000 by eliminating any funds for textbooks, transportation and other non-teaching services.
