### NLRB Counsel Acts To Restore 5-Day Mine Job

WASHINGTON, Jan. 18. — (AP) — Robert N. Denham, general counsel of the National Labor Relations board, said today he is applying for a court order to put coal miners back on a normal five-day work week.

Denham said a complaint charging John L. Lewis and his miners union with unfair labor practices is the basis for the court action.

This type of application calls for a hearing to be set by the court before any injunction order is issued.

Conceivably, it might be weeks before the court would act. Denham's complaint charges that Lewis has been failing to bargain in good faith with the coal operators.

The Taft-Hartley law requires bargaining in good faith and also permits the NLRB counsel to seek court orders barring "unfair practices" by management or a union. Whatever may come of it, it was clear that Denham's move was pushing the coal situation along to some break in the present stalemate.

Pressure is growing, too, for President Truman to step in under the T-H law and ask the courts to halt a strike.

### Truman Voices Hopes For Peace, Prosperity

WASHINGTON, Jan. 19. — (AP) — President Truman says that when he leaves the White House, he hopes the country will be "on the road to accomplishing" world peace and prosperity and welfare for all.

In stating this goal, at a dinner of representatives of the Federal Reserve system, he did not say when he expects to quit as "head of the greatest government in the history of the world."

Nor did Mr. Truman touch on the subject of his proposed new taxes, an item of particular interest to financial circles.

He did tell the members of the banking fraternity that one reason he appeared at their dinner was to show that "that I do not wear horns and I haven't a tail—I am just an ordinary citizen of this great republic of ours who has the greatest responsibility in the world."

MEDFORD — (AP) — Production workers of Bear creek orchards and Southern Oregon Sales Corp. will vote Jan. 26 on whether they want the Teamsters, Cannery and

Fruit Packing Workers union as a bargaining agent.

The union seeks to represent the year-around employees of both plants, but not office personnel.

Balloting will be under supervision of the National Labor Relations board.

### Supreme Court Hears Portland Business Tax Plan

SALEM, Jan. 18 — (AP) — The State Supreme court Wednesday heard arguments in two suits to determine whether Portland's new Business tax is unconstitutional.

The suits attack the annual tax of \$25 a year plus \$1 for each \$1,000 of gross sales over \$24,000 a year. It affects every retailer in the city.

Circuit Judge James W. Crawford of Portland ruled the tax is valid. The case was appealed.

One suit was brought by Ted Garbade and Fred Boynton, both retailers. The other one was filed by six automobile dealers.

They claim the tax is not uniform, thus violating the constitution.

The Supreme court upheld the

dismissal of a \$54,000 damage suit of Frances C. Wilder against Dr. Wallace Haworth, Portland. She claimed Dr. Haworth burned her with X-rays. Circuit Judge James R. Bain, Portland, threw the case out of court. The Supreme court, in any opinion by Justice Arthur D. Hay, upheld him.

### FIRE DAMAGE LIGHT

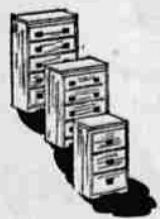

## Hungarian Water Rolls

(Kipfel) Adapted by Mary Mills



NOW—you can make "FLOAT DOH" Hungarian Water Rolls. Here is Mary Mills' modern version of "kipfel" . . . a treasured Old Country "Float Doh" recipe, sent in by a long-time friend and user of Fisher's Blend Flour. First—mix sugar, yeast and water. Let stand until light and fluffy. Then rub butter, flour and salt together until crumbly like coarse corn meal.

Beat eggs well. Add milk, scalded and cooled, extracts and yeast mixture. Stir this into flour mixture until smooth. It will be a VERY SOFT DOUGH. Do not knead this dough.



Take a clean flour sack free from holes. Dip it in cold water and wring out dry. Lay it flat on table and dust with flour. Put dough in center, bring corners of sack up and tie loosely. Leave plenty of room for dough to expand.

Fill a good-sized container with about 3 quarts of water COOL to the hand. Drop dough in carefully. Set aside to raise. It will float when ready. Lift dough out of water carefully and turn it into a bowl. You will have to scrape dough from cloth. In another flat bowl, have ¾ cup sugar and 2 tablespoons of cinnamon well mixed. With a spoon, take dough about size of an egg and press it flat in sugar mixture. Take this dough

and twist it once or twice to make a roll about wiener size. Shape into a horseshoe . . . and lay carefully in well-buttered pan about 1 inch apart. This will make 25 or 30 rolls. Sprinkle remaining sugar over tops.

Set aside in warm place to raise . . . about 1 hour . . . or until double in size.

Bake at 350 degrees for 30 minutes, or until nicely browned. For variation, sprinkle with chopped walnut meats . . . almonds cut in slivers . . . or mix 2 tablespoons poppy seeds with sugar and cinnamon . . . and you will have 3 different kinds of roll in one batch of dough.

These are true Hungarian Rolls, or Kipfel, and are very rich. They should have a crisp, sugary glazed crust when baked. This is truly a holiday bread that can be served on any occasion.
