

### Priest Balks At Altar On Being Raised To Bishop

VIENNA, Austria, April 24.—A Roman Catholic priest cried he was "unworthy" yesterday and abruptly walked out on church services at which he was to be elevated to the rank of bishop.

Thousands of spectators, including Austrian Chancellor Leopold Figl, gaped as Msgr. Franz Jachym stopped short before the altar of St. Stephen's church and declined to take the oath.

Cardinal Innitzer, head of the Roman Catholic church in Austria, commented after the service he was at an "absolute loss for an explanation of Dr. Jachym's strange behavior."

Other church officials, however, recalled Msgr. Jachym's pale appearance and were inclined to attribute his action to overwork.

Msgr. Karl Dorr, pastor of St. Stephen's, said "we are just to honor the decision of a brave and humble conscience."

Msgr. Dorr recalled that Saint Ambrosius and Saint Gregor had resisted the appointment as bishops of the church because of their humility and added:

"This office, especially in the present time, burdens the one who holds it with a responsibility that at the decisive moment Dr. Jachym did not consider himself up to the task. Nobody but the Lord knows what is happening in a person's soul at such a moment."

### Oregon Dreaming Of Track Crown

The University of Oregon had dreams of a possible northern division track and field championship today after blasting Washington State college's string of dual meet victories.

The Ducks trumped on the Cougars 75 to 55 at Eugene Saturday while Oregon State measured Idaho 76 to 55 at Corvallis.

Oregon's victory over WSC was its first over the Cougars since 1943 and snapped a string of 19 straight dual meet victories for the inland empire school.

Best efforts of the weekend was the 14-foot pole vault of Oregon's George Rasmussen, the 15.1 time ran by Oregon's Jack Douie in upsetting WSC's high hurdler Fran Polesoff, and the 6-foot, 4 inch high jump of OSC's Ken Elliot.

### Billion Cut In Foreign Aid Aim Of Republicans

WASHINGTON, April 24.—Senate Republicans today lined up a series of amendments to cut the \$3,722,000,000 foreign aid bill by as much as \$1,000,000,000.

While they were pressing their drive on one side of Capitol Hill, a faltering economy campaign seemed slated for a sidetrack in the House, at least temporarily.

In the foreign aid debate, Senator Kem (R-Mo.) proposed the billion-dollar slash, saying in a week-end statement that it would be "folly for us to continue to throw our money around like drunken sailors."

Senator Hickenlooper (R-Iowa) proposed a \$600,000,000 cut, telling reporters that red-ink spending at home is increasing and "we've just got to stop spending more than we take in."

Senator Tydings (D-Md.) made it clear that the administration is counting on the world threat of Communism to speed approval of a full foreign aid authorization.

Republicans have called for reductions of at least a billion dollars in the appropriation measure but their drive for cuts has been unable to get up steam.

The House thus far has made reductions totaling \$8,700,000, or less than one per cent of the amount of the items considered.

### Portland Orchestra On Concert Assn. Listing

Two "group" attractions and two individual musicians will be offered local members of the Community Concert association, Gladys Strong, president, said today.

In addition to the previously-announced DePaul Infantry chorus, Miss Strong said the Portland Symphony orchestra will appear in Roseburg during the coming concert season. Also scheduled are James Pease, American bass-baritone, and Constance Kenne, attractive young American pianist.

Announcement of the four attractions came today, following the close of what Miss Strong termed "a very successful membership drive."

### Miner Apologizes For Remark About Lewis

PITTSBURGH, April 24.—Joe Dickson, who was expelled from the United Mine workers last January after he called John L. Lewis a dictator, has apologized.

Dickson, a miner living at Liberty, Pa., hasn't been able to dig coal since his suspension from the union.

At a hearing before the executive board of the UMW's district five on Saturday, the 31-year-old Dickson told UMW district leader John Busarello "common sense" showed him he was wrong in criticizing Lewis in a letter published in a Pittsburgh newspaper.

Yesterday, Dickson said he hopes as a result of his apology that he will be permitted to return to work at the Mautour No. 10 mine of the Pittsburgh Consolidation coal company at Liberty.

### White Minister Raps Dynamiting Of Negro Homes

BIRMINGHAM, Ala., April 24.—An angry white pastor says federal help should be requested, if necessary, to catch the "criminals" responsible for dynamite attacks on Birmingham Negro homes.

Dr. John H. Buchanan issued the statement yesterday while city and county officers staged an all-out investigation of the second dynamiting in 10 days. Four city detectives were assigned full-time to the case.

Six bombings, most of them violent blasts that alarmed a wide area, have gone untraced since the first occurred 13 months ago.

Dr. Buchanan, a Baptist minister, said in part: "I think it's time for the right-thinking citizenship of Birmingham to begin to mobilize sentiment again behind the forces of decency and law and order, to bring justice to these irresponsible criminals."

"The safety and on-time performance of diesel electric locomotives operated under current rules have been notably good...  
"Upon careful analysis of the data submitted on safety, we have concluded that no valid reasons have been shown as a support for the Brotherhood proposal under which a fireman would be required to be at all times continuously in the cab of road diesels. The proposal must be rejected."  
The real reason behind these demands is that the union leaders are trying to make jobs where there is no work. In other words, a plain case of "feather-bedding."  
"The railroads have no intention of yielding to these wasteful make-work demands."
