

## Truman To Climax Western Tour With Speech At Party Jubilee In Chicago Tonight

A Democratic jubilee in Chicago tonight and a Republican primary in Pennsylvania tomorrow make this an important week in 1950 politics.

The Democratic gathering, at which President Truman will make an outright political speech, is the climax to his western tour. Party supporters say it will be the biggest political affair ever held outside a national convention.

## Hoffman Urges Cold War Fight On Four Fronts

NEW YORK. — (AP) — Paul G. Hoffman, head of the Economic Cooperation Administration, says that Communism will prove to be nothing but a "passing storm" if America wages a "four-front cold war" against it.

The ECA chief told the U. S. conference of mayors that 90 per cent of the people of Poland and Czechoslovakia "detest the system under which they are forced to live." And, he added, if given a reasonable chance of success, they will break away from Communism.

Hoffman addressed the closing session of the three-day conference attended by 250 mayors, including a sprinkling of officials from foreign cities.

David L. Lawrence, mayor of Pittsburgh, was elected president of the conference for the coming year to succeed Mayor W. Cooper Green of Birmingham. Mayor Martin H. Kennedy of Chicago was elected vice-president, succeeding Lawrence.

"This is a cold war, not a shooting war," Hoffman said. "Yet no shooting war in history has ever brought so much territory or so many people under the yoke of a conqueror as these cold wars have for Russia within five years."

Russia, he said, was waging its cold war on four fronts: Military, economic, political and informational.

America must carry on its own cold war on these same fronts but must not adopt Russia's methods, Hoffman said, adding:

"In waging this four-front cold war our military has a vital role. It's task is to see that the Red army does not march against its neighbors."
