## **Drunken Driving Convictions In Oregon Increase**

Drunken driving convictions in Oregon during the first six months of 1950 increased 22 percent over last year at the same time, accord-ing to figures released by Secre-tary of State Newbry.

Newbry said that for the first six months of this year, 1,103 Oregonians had licenses revoked for driving while intoxicated. Last year during the same period 907 revocations were handed out for drunken driving.

A total of 19,168 traffic viola-tion convictions, resulting in revo-cation of 1,340 licenses and sus-pension of 252 other licenses, were recorded for the January through June period.

Reckless driving, violation of the basic rule and other serious traf-fic offenses resulted in 248 of the suspensions. These suspen-sions, Newbry said, were issued upon recommendation of the


