Milk Control Act Upheld in Senate; Foes Not to Quit

By PAUL W. HARVEY JR. SALEM — (AP) — Milk control foes said they would carry their battle to the people as the Senate overwhelmingly approved a bill to require more accurate cost accounting by distributors...

Neuberger said the Dairy Cooperative association "has its hands in the housewife's pocketbook" and Mahoney says "milk prices are getting tired of getting rooked" to the point where they can't afford to buy milk for their kids.

The Senate deferred 15 to 14 a bill to have the Senate confirm appointments to the state highway and liquor commissions. But this issue isn't dead, because Sen. Russell Gardner, Newport, who opposed the bill, said he would move later to reconsider it.
