

### National Capital Visit Delights Shirley Helweg

Shaking hands with President Truman and Secretary of State Dean Acheson were outstanding experiences in her first week in Washington, D. C., according to word received by her parents, Mr. and Mrs. Paul Helweg of Roseburg. She is a delegate to the Washington Student Citizenship seminar, sponsored by YMCA and YWCA, and is doing secretarial work for the Housing and Home Financing agency in the Pentagon building there.

Following a tour of the New England states, she arrived in Washington June 24 to begin her week of sightseeing. The first two days were spent getting acquainted with the rest of the delegates to the seminar.

All of one day was spent on Capitol Hill, where Miss Helweg was able to talk to the House of Representatives and to the Senate.

The group of delegates attended a hearing of the un-American activities committee, during the time they were trying to decide whether a Hollywood producer-writer-director was a Communist.

The group was present at the house ways and means committee hearing when Acheson made several important statements about foreign policy, which were later heard on the radio. It was here that the group shook Acheson's hand and he said that he was very glad to see them.

They then attended the hearing on "dope" in the state office building. Miss Helweg wrote, "The bright lights were on and television cameras were going. Former addicts were testifying about how they got started and how bad it was."

The delegates were then taken to the White House, where the guards checked off their names and where they stood on the White House lawn and listened to a few words on good government spoken by President Truman. Mr. Truman urged them, "to find out how it is operated, and be in a position to operate it when the time comes for you to do it."

"I have been trying to find out all about it for 60 years — and I still have a lot to learn." Each one told Truman his name and shook his hand.

Other Departments Visited  
The day following the delegates went to the State department and listened to a speech on foreign policy and one on far-eastern policy.

They heard Oscar S. Chapman, secretary of the Interior, speak on the main functions of his department. They were taken on an extensive tour of the museum at the department of the Interior.

There were little models of the big dams and pictures of the national parks and "I even saw Roseburg on a map showing the land offices of the United States."

They went back to the un-American activities committee in the Senate, where they were trying to pass the price bill. The committee is reported to be having all-night sessions.

The next day was a special tour of the Library of Congress. Written by Miss Helweg, "It's a beautiful building inside—huge dome, paintings, statues, mosaics, etc. We saw the original Declaration of Independence, Constitution, Bill of Rights, etc."

They then toured the supreme court building which Miss Helweg considered "the most beautiful structure in Washington. It is marble and brass. They saw the chamber and the conference room. On a trip to Dumbarton Oaks, they saw the music room, where the United Nations was founded in 1944."

Miss Helweg will remain in Washington, D. C., for the rest of the summer and return to Oregon in the fall to continue her studies as a junior at Willamette university.

#### New Trial In Award On Condemnation Asked

### June This Year Driest In Bureau's Records

Last month was the driest June recorded in the 74-year history of the weather bureau in Roseburg, the U. S. weather bureau reports.

There were a few traces of rainfall, but not enough to be measured. The previous low June was .01 of an inch of rain which fell in 1883. Average rainfall for the month is 1.09 inches.

In contrast to the lack of rain, the amount of sunshine received during the month was the second highest recorded. For the thirty-day period, 460 hours of sunshine were possible and 418 hours were received, which is 91 percent. In August 1932 a record was set when 53 percent of the possible sunshine was received.

The average monthly temperature of 67 degrees has been exceeded only twice. In 1918 the average was 67.4 and in 1926 it reached 68.2 degrees.

to appear again in court are Abner Green and W. Alpheus Hutton. Green is secretary of the American Committee for the Protection of the Foreign Born, also cited as a subversive organization by the attorney general's office.

A subpoena issued Tuesday for trustee Dashiell Hammett, mystery-story writer, has not yet been served. The fifth trustee of the fund, Robert W. Dunn, has been reported ill in a hospital.

For many years, Field has been regarded as a wealthy "angel" of Communist causes in the U. S. In 1928, he broke with his wealthy family and became a member of the Socialist party.

Field was acquitted last March of a contempt of Congress citation for refusing to answer questions of a senate committee.

The Justice department announced on Oct. 2, 1950, that Field was registered in the United States as an agent for Communist Chinese interests. The department said he had registered as "attorney in fact" for the Bank of China, the China National Aviation corporation and two other Red Chinese concerns.

Police reported he captured the animal and had it in a pen as the pet. Waybrant, who lives at the power house camp, Toketee Falls, is to appear before District Judge A. J. Geddes Saturday.

### Inventory In Estate Of Lumberman Filed

The estate of Charles A. Manschreck, Reedsport lumberman who died March 7, 1951, has been appraised at \$229,149.49, according to an inventory filed Thursday.

Included in the estate are several timber contracts, one of them valued at \$60,000 and a 39 percent interest, amounting to some \$75,000, in the Reedsport Lumber company.

Manschreck died at North Bend. His estate was admitted to probate April 16.

The estate was appraised by William Eaststrom, Nelson and Willis Erblad. The First National bank of Portland is executor of the estate.

### Liquor Charges, Fight Draw Fines, Jail Sentences

Wayne Douglas Musgrove, 20, Sutherlin, illegal possession of liquor, 30 days and \$75.

Victor Frank Masiello, 25, Sutherlin, assault and battery, fined \$100.

Lawrence Edward Ford, 20, illegal possession of liquor, 30 days and \$50.

Donna Louise Darrah, 18, Sutherlin, 30 days and \$50, suspended, and paroled to parents.

### Winchester Bay Search For Lost Anglers Still On

Patrols are still being made today in an effort to locate the bodies of two fishermen from Riddle, presumably drowned on the Umpqua bay Thursday morning, the coast guard at Winchester Bay reports.

The men are listed as Alvis Hendrick and his uncle, Harry King.

The two were members of a party vacationing at Winchester Bay. The identity of the two missing men was made by members of the party and by the keeper of the boat stand where the boat had been rented a short time earlier.

The coast guard had reported that at 7:45 a. m. a skiff was observed capsized at the mouth of the river. Two men were observed swimming nearby, but there was no sign of life when a lifeboat and two commercial vessels arrived on the scene. The boat was upside down and one life jacket was inside.

The coast guard indicated it would probably be 10 or 12 days before the bodies would be washed ashore.

Hendrick, about 25, leaves a wife, Hilda, and son, Alvie Lee. He is the son of William McKinley Hendrick, and had lived in Riddle most of his life, attending the Riddle schools.

King is described as in his late 30's. His wife's name is Sylvia Joan, and his two daughters are Ellaroe and Faye Marie. He has lived several years in Riddle.

On the fishing party were the families of the two men: King's brother, Fred, and his family, and King's wife's brothers, Edgar and Edward Weekly, and their families, and her nephew, Hubert Weekly, and his family.

### Fireworks Task On 4th Attended By Bruises, Cuts

The men who fired the fireworks at the display Wednesday are sporting cuts and bruises this week—but not particularly because of any fireworks mishap.

Ken Garey and Wayne Crooch, who fired the mortars from the river bed during the display, have bruised arms. Sid Moon, relief man on the firing line, has a cut knee.

These injuries they picked up from flinging themselves headlong into the gravel after lighting the fuse on each mortar shell—a precautionary measure just in case one of the huge shells, some weighing ten pounds, should explode prematurely.

Fortunately, however, everything went along pretty much according to plan and no mishaps occurred.

#### Draws Record Crowd

The fireworks show drew the largest crowd ever to attend any function at the fairgrounds grandstand, according to George H. Caskey, head of the sheriff's reserves, the reserves, which had about 25 men on the job Wednesday, were swamped with traffic.

Across the river, cars lined the highway in a solid line for more than a mile. Attendance estimates in the grandstand ran at more than 8,000.

Seventeen mortars were set up in the firing area on the river bed. Besides Garey, Crooch and Moon, Jim Steele and George McIntosh assisted in cleaning out 10 mortar tubes after each shell had been fired. Leo Sevy fired the set pieces inside the arena.

The largest mortar shells fired Wednesday cost \$27.25, were 18 inches long and seven inches in diameter and weighed about ten pounds.

Closest thing to a mishap on the firing line was a mortar which exploded after it had gone only 50 feet in the air instead of the normal 300 to 400 feet. This particular shell was designed to fire six explosions, called salutes, after the initial aerial burst. Five salutes, each considerably more powerful than its larger firecrackers, were heard.

The sixth did not explode until after it had landed on the ground—just three feet from where Garey was standing.

nesota next year with "who planted that one?"

G. Youngdahl said he had not consulted state or national Republican party colleagues including Senator Thye (R-Minn.), whom he succeeded as governor, or Lt. Gov. C. Elmer Anderson, slated to succeed Youngdahl.

Thye's office aides telephoned to Minnesota to tell him the news. He authorized this comment.

"Governor Youngdahl is qualified for any judicial appointment that is offered to him."

Youngdahl said he had resigned from the Minnesota supreme court to run for governor and now wanted to step back to the bench from "the active political field."

He headed the Minnesota delegation to the last Republican presidential nominating convention.

If Youngdahl's nomination is confirmed by the Senate he will fill the District of Columbia judgeship made vacant by the recent death of Judge T. Alan Goldsborough, a former Maryland representative in Congress.

A federal district judge is appointed for life and the salary is \$15,000 a year. As governor, Youngdahl's salary recently was increased from \$12,000 to \$15,000 a year.

Youngdahl said he would not resign as governor until confirmed for the judgeship and even then not before Sept. 1.
