Aluminum Plant Settles Damage Suit Of Farmers

PORTLAND — Farmers who started a three million dollar damage suit against the Reynolds Metals Co. Aluminum plant at Troutdale, Ore., got a \$76,225 settlement Wednesday. One only-fifth of the 98 farmers who filed the damage suit in Federal Court 2 1/2 years ago shared in the payments ordered by Federal Judge James Alger Fee. He said they were the only ones who proved fumes from the plant had damaged their crops and livestock. He ordered the aluminum company to pay \$20,500 to five prune growers in Washington, across the Columbia River from the Troutdale plant. Twelve Oregon bulb growers were awarded \$52,225. Two Oregon stockmen won a total of \$5,500. Since the suits were filed, the plant has installed fume collecting devices.

Perjury Denied In Case Involving RFC Loan

WASHINGTON — Joseph H. Rosenbaum, Washington attorney, appeared in court Friday and pleaded innocent to a perjury indictment growing out of the Reconstruction Finance Corporation loan investigations. E. Merl Young and his brother Herschel Young, also facing perjury charges, failed to answer when their names were called in the courtroom of U.S. District Judge James Kirkland. Rosenbaum also failed to answer when his name was first called, but he came into the courtroom, accompanied by his attorney more than two hours later. At Homestead, Fla., Merl Young's wife, Loretta, expressed astonishment when told her husband had not appeared; she said "I'm sure that Mr. Young didn't know about it, for he would have told me."
