Mystery Voice Being Broadcast For Polio Drive

Another novel method has been devised to raise money for the March of Dimes fund.

This time it is a Voice of Mystery program being sponsored by the Roseburg Lions Club.

Here is the way it works. A person familiar to Roseburg and Douglas County residents began making frequent broadcasts over KRNR and KRXL Friday. It is up to listeners to identify him. Clues will be given to aid in the identification.

Persons entering the contest may submit as many guesses as they want—as long as they are accompanied by 10 cents per guess to be added to the polio fund.

Entry blanks will begin appearing in the News-Review today, but in their absence a plain piece of paper will serve. The guess is to be written on one side, and the name and address on the other. All entries submitted become the property of the March of Dimes, and none will be returned.

Guesses are to be mailed to the Voice of Mystery, care of KRNR or KRXL. They must be postmarked before Jan. 31, the contest's closing date.

The Lions Club and local merchants will award a mystery jackpot totaling about \$100 to the person submitting the correct guess. The voice will be identified about 4 p.m. Feb. 1.

A joint broadcast by both local stations from contest headquarters will terminate the program. Everyone is eligible to enter the contest except the following: Lions Club members, staff members of the News-Review, KRNR and KRXL, and their families.

Todd Duncan's Program Lists Gems Of Songs

Great as is his success on the operatic and dramatic stage, Todd Duncan prefers the world of songs—the world of Handel and Brahms and Schubert, as well as of George Gershwin and Kurt Weill.

This is reflected in the program he has chosen for presentation in his Roseburg Community Concert Association sponsored appearance tonight at 8:15, at the Junior High School Auditorium.

Duncan, famed baritone and star of "Lost in the Stars," Broadway musical hit, will open with singing of "O Sleep, Why Dost Thou Leave Me," from "Samuel" by Handel; "O Let Us Praise the Lord," Franck, and "Where I Am Laid in Earth," from "Dido and Aeneas," by Purcell.

His second group of selections are all Schubert's. They include "Der Wanderer," three songs from "Die Schone Mullerin," and "Der Erlkonig." This will be followed by "Life and Death," Cole-ridge-Taylor; "Over the Moon," Roger Quilter, and soliloquy from "Lost in the Stars," Kurt Weill.

After intermission he will sing Bizet's aria: "O Nadir, tendre ami de mon jeune age," from "The Pearl Fishers"; "Emil Paladine's 'Psyche,'" and Gabriel Pierné's "Le Moulin."

The final group of selections will include three Negro spirituals, "Oh Glory," "New Born Again," and "Ride on, King Jesus," with two popular numbers, "Old Mother Hubbard," by Hutchinson, and "I Got Plenty of Nuttin'," from "Porgy and Bess."

Pulpwood Industry Fights Price Ceilings

WASHINGTON (U.S.)—Lumber state congressmen have protested the timing by the Office of Price Stabilization of its order putting price ceilings on pulpwood.

The ceilings, setting maximum prices of \$10 to \$30 a cord on various types of pulpwood, went into effect Dec. 24.

This was right in the middle of the season after contracts already had been made on the basis of pre-ceiling costs, Rep. Potter (R-Mich.) said at a meeting in his office Wednesday.

Rep. Bennett (R-Mich.) said "hundreds of small pulpwood operators in my district are threatened with bankruptcy because of this situation."

Mothers' March On Polio Set For An Hour Jan. 31

Porch lights will be burning for an hour in Roseburg the night of Jan. 31 when the "Mothers' March on Polio" will be launched as the climax of the 1952 March of Dimes, it was announced yesterday by Mrs. O. J. Felt, chairman.

The burning lights in thousands of homes will be the signal to an army of volunteer mothers that they will be welcomed to receive contributions to the March of Dimes.

The Roseburg March of Dimes committee has designated the hour between 6:30 and 7:30 p.m. as the time for this dramatic windup of the campaign against infantile paralysis, Mrs. Felt declared. The local "Mothers' March on Polio," is part of an identical nationwide movement in which hundreds of thousands of mothers will participate.

"Turn on your porch light to fight polio" is the theme of this special appeal by the mothers of the nation on behalf of the men, women and children who have suffered from infantile paralysis. The lights of American homes will serve as a symbol of hope to those who may be stricken in the future.

"Here's the way the Mothers' March will work," said Mrs. Felt. Between the hours designated, every resident in Roseburg will be asked to turn on his porch light or to burn a light in his window—if he wishes to make a contribution to the March of Dimes.

Then the mothers will march, street by street, road by road, block by block, house to house receiving contributions of this year's campaign against polio.

The basic organizational plan for the "Mothers' March on Polio," calls for captains or district leaders, lieutenants who will lead sections of the community, and mothers who make direct contact with ten or twelve houses each.

Mrs. Felt will welcome help from all sections of the city by mothers who can give some time on the evening of January 31. Roseburg Jaycees are sponsoring the drive, but hundreds of mothers will be needed to cover the city. Mrs. Felt's phone number is 3-5379.

He is Donald A. Wallace, who has fallen on darker days since he sprang along a railroad track to snatch the girl almost from under the wheels of an onrushing train.

That was on Feb. 19, 1950, when he rescued Susan G. Goss, 10. Since Wallace's back was injured in an accident, and his arms and legs are sometimes immobilized now, he is taking business training in hopes of finding a job where his affliction will be no hindrance.

Wallace was 20 and an automobile parts clerk when he made the rescue at Multnomah Falls. It was dusk when he noticed the girl, who had wandered away from her grandmother and was walking along the railroad track, oblivious of the oncoming train.

Wallace jumped onto the track and ran 25 feet to the girl. When he reached her, the train was within 200 feet of them.

He grabbed the girl by the arm, but she jerked backward, and Wallace almost lost his footing. He managed to keep hold of the girl. "Stepping over the rail," the Carnegie citation said, "Wallace grasped the railing of a retaining wall and pulled Susan from the track, barely clearing the train. With clearance of 18 inches, Wallace held her against the ailing as the train passed at undiminished speed."

Wallace left without reporting his name, but onlookers did.

Convicted Abortionist Loses Medical License

PORTLAND (U.S.) — Dr. George H. Buck, convicted abortionist, lost his license to practice medicine Friday.

Circuit Judge Charles H. Combs upheld revocation of the license by the state board of medical examiners.

The board revoked the license in May, 1947. Judge Combs overruled the board and ordered the license restored. The board then appealed the case to the State Supreme Court.

That court ruled that Judge Combs had erred and sent the case back to the state board to reverse his earlier decision.

Six Convicts Eat Seventh In Their Jungle Flight

BOGOTA, Columbia (U.S.) — Six wild and bearded convicts who escaped a tropical jungle prison camp said Thursday they killed, broiled and ate a seventh companion—the fattest one—and were planning to eat another when they stumbled into a settlement and surrendered.

Their confession was reported by Horacio Resoro Caicedo, director of the National Territories Department of the Interior Ministry.

The men wandered 38 days through treacherous swamps and jungle inhabited almost solely by snakes, beasts and wild natives. They covered a cross-flight distance of about 250 miles before they reached Puerto Umbria, a river village in an Andean valley, and gave themselves up.

Some were ill with malaria. All were clothed in rotted tatters. Eating their plumpest companion, they said, was the only way they could get strength to escape the jungle.

Lane County Worker Found Dead In Water

EUGENE (U.S.) — The findings of an autopsy were awaited Thursday to determine the cause of death of Julian Francis Morfitt's death.

Morfitt, 56, an employee of the Blachly-Lane County electric cooperative, was found dead in a pool of water at Blachly Wednesday. He wore night clothes, covered by an overcoat. Footprints led from the Blachly substation, where he slept, to the pool.

John A. Sutter, on whose property gold was first discovered in California, was a Swiss immigrant.

Nomination Of New RFC Head Blocked

WASHINGTON (U.S.) — The Senate Banking Committee Friday refused to approve the nomination of Harry A. McDonald to head the Reconstruction Finance Corporation pending further study.

It sent word of its decision to President Truman.

McDonald now is chairman of the Securities and Exchange Commission, which is under investigation of a House commerce subcommittee.

Sen. Douglas (D-Ill.) told a news conference he moved to delay a vote on the confirmation of McDonald until he receives information concerning the relations of former SEC officials with that agency.

U. Of O. Backs Protest On Dime Phone Rate

EUGENE (U.S.) — A student request to the State Public Utilities Commission to order 10-cent pay phones removed from University of Oregon fraternity and sorority houses has been approved by the university administration.

PORTLAND (U.S.) — The third recall attempt against Portland City Commissioner Jake Bennett was filed Wednesday. To be successful, this one first needs 25,770 signatures of registered voters, then needs a favorable majority at the May 16 election.

Neither of the other recall attempts reached the ballot. The first was several years ago and the second was some two months ago.

This one was filed by Dave Goldman, publisher of the Portland Statesman, an East Side Portland newspaper.
