

School Addition Plans Accepted By Dist. Board

The District 4 School Board Wednesday accepted plans for the Fullerton School addition and the Riverside School multi-purpose room in a special meeting at the Junior High School.

The Board authorized the advertisement for bids, which will be received until May 15 when they will be opened. Bidders may tender bids for the construction of both jobs or either, separately. Construction will begin immediately after the acceptance of a bid. Although no contract time for completion of the projects was immediately known, hopes are the Fullerton addition will be ready by September and the Riverside multi-purpose room by the first of 1953.

The Board also authorized C. N. Freeman, who attended the meeting as a representative of Architects Freeman, Hayslip and Tufts, to proceed in drawing working plans for the Senior High School shops.

Meanwhile, additional investigation will continue on plans for the Roseburg High School gym and Fruitvale Elementary school.

Oregon Liquor Prices Too High, OPS Declares

PORTLAND — Oregon's liquor prices are above legal ceiling levels. The Office of Price Stabilization (OPS) has told the State Liquor Commission that prices since Dec. 1 violate OPS regulations.

W. A. Spangler of Klamath Falls, a member of the commission, confirmed that OPS had filed a complaint with the commission.

But, he said: "We think our prices are all right. If the government thinks we are overcharging, it can do as it sees fit." He added that the commission, meeting in Medford Wednesday, probably would discuss the complaint but would not take any action.

Liquor prices were increased about 24 cents a fifth last Dec. 1. The increase was made without the approval of OPS.

The commission said at the time, however, that if thought the increase would be permitted under OPS regulations.

The commission cited a \$1.50 per gallon federal tax which could be passed on to the consumer. Also the commission said it had not marked up liquor prices to the maximum permitted by OPS. These two items accounted for the 24 cent increase, officials said.

The commission said it was complying with a request from the 1951 Legislature when it marked up the liquor prices. The additional revenue went into the state's general fund.

Answers "Hokey" Spread

Coming down to more recent events, the President said there has been what he called a lot of hokey about seizure of the press and radio as a result of his last news conference.

On last Thursday, Truman was asked this question: "Mr. President, if you can seize the steel mills under your inherent powers, can you, in your opinion, also seize the newspapers or the radio stations?"

The President replied that under similar circumstances, the President of the United States has to act for whatever is for the best of the country. That's the answer to your question, he added.

In reverting to the matter Thursday, Truman said the thought of seizing the press and radio never occurred to him.

He went on to say he seized the steel industry because this country is in the midst of the greatest emergency it has ever had.

Steel Industry Goes To Court For Injunction

the House to institute impeachment proceedings against him, replied at his news conference Thursday that these efforts are political.

Truman had other things to say about the steel situation. Among them:

1. He twice asked Congress to give him advice on how to meet the issue but the only advice he got was that he had done wrong and ought to be impeached.

2. He did not invoke the Taft-Hartley laws 80-day cooling off period in the steel dispute because the union had delayed its strike for 99 days previously at his request. This was during contract negotiations.

Truman declined comment on a pending bill by Sen. Morse (R-Ore.), that would give congressional sanction to the seizure.

Another Strike Called

On other strike fronts the CIO Communications Workers Union has called a strike of 5,000 members employed by Western Electric in North Carolina for Friday. The strike was ordered at Winston-Salem, Greensboro and Burlington.

The union is reported to be seeking a wage increase of 14 cents an hour while the company offered seven to ten cents.

Mediators in New York arranged another session aimed at settling the 18-day-old strike of 6,000 sales, distributing and warehouse employees of Western Electric, manufacturing subsidiary of the Bell Telephone System. This strike is in effect in 25 cities.
