Swim Pool's Opening Draws 570 Bathers

A balmy June day, a gently warming sun and clean, sparkling water lured 570 first day swimmers to the Roseburg municipal pool Monday as the long-awaited 1952 season got underway at Rose School grounds.

Among the goose-pimpled youngsters to emerge after their first dip were Delores Isaacson and Lester Coy, both students at Riverside School. They admitted that the water was a little chilly.

Now in its fourth season of operation, the \$68,000 swimming plant, boasting a larger-than-regulation pool, underwater and over-water lighting and ample exhibition bleachers, is the site of the Red Cross-sponsored swimming classes—to start June 16—as well as tournaments sponsored by the Junior Chamber of Commerce.

On hand to supervise proceedings were Lifeguards Floyd Williams and Ronald Louis McAmenny. Ronald said the opening day's figure was excellent considering the mild weather. Although the water was cool, it would warm up in a week or two, depending on the weather, he said.

Another official witnessing the opener was Harry Isbell, city park superintendent. He inspected the plant, including scientific machinery that keeps fresh water flowing 24 hours a day, filters the water and provides the proper amount of chlorination. He stated that the water is not heated because the pool operates only during warm summer months when water becomes naturally warm.

Wading pools at Rose School and at E. Commercial, off N. Jackson St., are expected to be in operation by Tuesday evening, June 3, Isbell said.

Two Bicycles Stolen — Misfortune befell two of the last swimmers out of the pool at the 9 p.m. closing time. They were David Milsten and Robert Hultman, with their companion, Eddie Anderson, all students at Junior High.

David, a News-Review carrier, and Robert discovered that their bicycles had been stolen while swimming. They left them at the foot of the concrete stairway leading to the pool. David, who uses his bicycle to deliver papers, said his was a '51 model Swinn. Robert said he owned a '48 red Hawthorne.

Although Eddie lost a bicycle last year in similar circumstances, he eventually recovered it, he stated. Anderson said it is common to lose bicycles in such a manner. David said he would report the losses to police. They believed that some swimmers were implicated.

Swimming will continue daily from 1 to 9 p.m. Starting June 16 closing time will be extended to 10 p.m.

Selection of Dillard was made unanimously by the board of directors of the Douglas Community Hospital.

Following the announcement of his appointment, Dillard said, "Having confidence and faith in the people of Roseburg and Douglas County, I gratefully accept the post of general chairman for the expansion fund campaign. With the hospital maintaining an average of almost 100 per cent occupancy since opening its doors in February, 1951, and with the past month of March having a rate of occupancy of 110.6 per cent, it is necessary to provide more bed space at our Community Hospital.

"The hospital has become a major factor in the health and welfare of our community, and in order for it to maintain its high record of service, we are undertaking this \$100,000 campaign for the addition of a 21-bed ward. The people of Roseburg and its dependent area deserve the finest hospital care that can be provided, and I know we will have the whole-hearted cooperation of the entire community in this project."

the same time. The general expressed doubt liberally provoked war—and he said that the Russians will start a de-said this country certainly won't start one.

But he warned that "powder keg" wars may develop among industrial countries, and he declared: "We should be highly alert and mobilized."

Truman in 1949 impounded 615 million dollars voted by Congress to build the Air Force up to 58 groups.

Again in 1950, when the question of expanding the Air Force to 70 groups was before Congress, Truman said the nation could afford only a 48-group force.

Recalls Billy Mitchell Eisenhower led up to his statement on the importance of air power with a remark about the late Brig. Gen. William Mitchell, World War I air commander, who later was "broken" for urging a separate air force over the objections of his military superiors.

"There was a man named Billy Mitchell," he recalled, who agitated after World War I for a separate air force.

Gen. Carl A. Spaatz, retired Air Force leader, "was my companion and associate" and "I stood with him on 70 (Air Force) groups," Eisenhower continued, adding that "we were whittled down."

T. M. Gerow, Grants Pass, district sanitary engineer, "will be pleased to discuss the matter of installing adequate sewers to serve Miller's Addition."

At the May 19 council meeting I. O. Bishop, 1211 Icabod Lane, asserted the sanitary authority had threatened the injunction in a letter addressed to Peck.

Peck appeared before the council earlier in the evening with a request that the council look into the lack of water pressure in Miller's Addition. The council promised it would ask the Oregon Water Corp. what future plans it has for the area.

The council approved plans and specifications for North Roseburg and West Roseburg storm sewer projects, and authorized City Manager W. A. Gilchrist to advertise for bids.

The two projects are expected to cost in the neighborhood of \$65,000.

In other action the council: 1. Received a petition signed by five property owners on North Jackson St. for widening, surfacing, installing curb gutters and other improvements on North Jackson between East Second Ave. N. and East Third Ave. N.

2. Authorized the city manager to have permanent no-parking signs placed on the Stephens-Oak and Stephens-Cass intersections.

3. Accepted the report of a special airport management investigation committee headed by Councilman Harrison Winston. The report recommended the addition of an outside telephone at the field, that the operator render more service to landing planes such as parking and cleaning windshields, and that transient aircraft be registered.

4. Approved change of name of street from Moore Street to South Chadwick.

5. Granted waiver of bond for new business, "Rose Parking Lot."

T. he will deliver a speech to be radio-broadcast and televised nationwide.
