

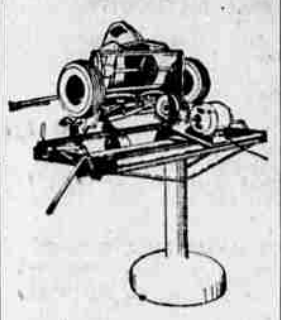
Second GI Sentenced To Death For Slaying
 NUERNBERG, Germany (AP) — Pvt. Richard A. Haeberberger, 19, was sentenced to death by a U.S. Army Court Martial Thursday for the carbine slaying of two German civilians last April.
 The young soldier's buddy Pvt. John F. Vigneault, of Goffs Falls, N.H., had previously been sentenced to death for his part in the slaying on a road near Neustadt; two Germans who gave them a ride after the soldiers had spent the evening drinking beer in a tavern.

Illegal Taking Of Fees Charged To Federal Men

WASHINGTON (AP) — A federal grand jury Tuesday indicted Charles E. Shaver on charges of accepting \$3,100 in fees to push cases before government agencies while he was counsel for the Senate small business subcommittee.
 Winding up an investigation which started last February, the grand jury also indicted three associates of Shaver. They were accused of aiding the allegedly unlawful deals.
 Shaver was charged, on 11 counts in three indictments, with violating a federal law which prohibits any government employe from accepting compensation to represent outside parties before government agencies in any matter in which the government is interested.
 Shaver faces a total of possible maximum penalty of 28 years in prison and \$110,000 in fines, or both, if convicted. However, maximum sentences are rarely imposed.
 Others indicted along with Shaver were Leonard H. Cooper of Miami, Jerome H. Weinkle, Miami attorney, and Raymond W. Lopaika, Chicago attorney.
 Assistant District Attorney John W. Fihelly said the investigation cleared F.O. Bratton, a secretary to Vice President Barkley, who was linked with reports of influence attempts at the time the cases were first made public last year.
 Last fall a Senate committee looked into reports that Mrs. Bratton and Shaver helped swing a \$1,100,000 government loan sought to build a Florida luxury hotel.
 Altogether, five alleged attempts at influence were cited in the indictments.
