CHEER FOR STEVENSON

Aides Forecast Victory, Claiming Democrats Have Gen. Eisenhower 'On Run'

SPRINGFIELD, Ill. (AP) — Associates of Gov. Adlai E. Stevenson believe the Democrats have Gen. Dwight D. Eisenhower on the run and will win next month's election with a great surge of support from the independent voters.

This view, sketched publicly by Campaign Manager Wilson Wyatt at a news conference yesterday, is shared privately by almost all of the Democratic presidential nominee's advisers. A number of Democrats have publicly voiced their optimism. Sen. William Fulbright of Arkansas has predicted that the Illinois governor will carry the South and the border states.

Secretary of Labor Tobin said yesterday Eisenhower will pay the price of losing New York for embracing Sen. Joseph R. McCarthy of Wisconsin and William E. Jenner of Indiana, detractors of Eisenhower's old friends and military preceptor, Gen. George C. Marshall.

Former Sen. Francis J. Myers reported that "things look pretty good" for Stevenson in vital Pennsylvania.

Wyatt made it plain he thinks the Democrats are beginning to harvest "extremely substantial" support from the independent vote.

He told reporters that National Committee members and volunteer workers indicate there is a wave of defections from Eisenhower's cause.

He said that "I Used to Like Ike" groups were being formed because of "disillusionment" with the general's campaign tactics. This "disillusionment," he said, is based on the compromises, the shifts of position and the abandonment of principles that they felt before were emphatically held by him.

Costs Worry Adlai
Gov. Stevenson, in a radio speech sponsored by volunteers seeking \$5 contributions for his campaign, said he is deeply concerned over the high costs of campaigning.

"The financial requirements are entirely too large," he said over

In Korea: For the seventh time in 24 hours, savage hand-to-hand fighting is going on at the very top of White Horse hill. The fighting there began more than four days ago and has gone through daylight and dark. In fact, it didn't stop last night even when it became so pitch dark that the South Koreans couldn't see their enemies and identified them as Chinese by FEELING THEIR SHAVED HEADS.

Still in Korea: An American jet bomber pilot on his 93rd mission was hit by enemy flak as he roared in on his target. With his left wing in flames and his tail badly shot up, he completed his pass and dropped his bombs.

As he pulled out of his dive, the flames of his wing went out, so he headed for home base, realizing that he was on his way. It was dark, but they put out flares for him and he came whirling in at 225 MPH (his dive brakes were shot away) and by the grace of God and the skill

Russians Attack Another U. S. Plane

Note Claims Fire Opened On Red Craft

U.S. Plane Apparently Destroyed; Frontier Violated, Soviet Says

MOSCOW (AP) — Russia has charged that a U.S. B-29 bomber shot at Soviet fighter planes over Russian Far Eastern territory Tuesday and said the Red pilots returned the fire. The incident occurred the same day the U.S. Air Force reported one of its Superforts missing off Japan.

A Soviet note to the United States, formally protesting the alleged border violation, said the American plane "disappeared in the direction of the sea" after the Russians shot back.

In Tokyo, U. S. Air Force spokesman said the missing American plane "carried no guns and no gunners" among its crew of eight. The Air Force previously had announced the bomber, flying a training trip, was last seen on a radar screen within Japanese waters. It disappeared from the screen when its path crossed that of an unidentified plane approaching from the Russian-occupied Kurile Islands, officers said.

Soviet Version Received
The Soviet note charged that the U.S. Bomber "violated the Soviet state frontier Oct. 7 in the 'area of the island of Yuri.' Yuri is one of the Kurile Islands, 18 miles from the northernmost Japanese island of Hokkaido.

The American craft fired on two Soviet fighter planes that ordered it to land, the note continued, and "when the Soviet fighters returned the fire, the American plane disappeared in the direction of the sea."

The note concluded: "The Soviet government lodges a determined protest against the new case of violation of the Soviet state frontier by American military aircraft and demands that the government of the USA adopt measures to prevent violation of

IKE HEADS FOR TEXAS

General Invades State On Heels Of Jack Garner's Entry In Stevenson Camp

DALLAS (AP) — A pencil-scratched note from rugged old John N. (Cactus) Jack Garner today bolstered Texas Democrats battling to keep the state in line for Adlai Stevenson.

The former vice president, one-time power in national and state politics, wrote House Speaker Sam Rayburn here that he would vote the Democratic ticket Nov. 4 from top to bottom. It was Garner's first public dip into politics since he retired as vice president more than a decade ago.

Rayburn released Garner's scribbled announcement one day ahead of Dwight D. Eisenhower's invasion of this Democratic stronghold.

Tomorrow, Eisenhower pushes into Texas, where rebellious Democrats led by Gov. Allen Shivers have pledged their support in a move that has placed the Lone Star State among the doubtful states. Shivers is expected to introduce Eisenhower at some of his stops.

Opposes Break With Russia
Eisenhower said he is not in favor of breaking diplomatic relations with the Soviet Union.

This was one of the subjects discussed with him a week ago by correspondents in a conversation which he put off the record.

"There is an old Army axiom," he said, "Never lose contact with your enemy. I don't believe that it would serve any purpose to break relations at this time."

Stevenson follows Eisenhower to Texas with speeches at Ft. Worth and Dallas Friday and in San Antonio and Houston Saturday.

Rayburn came back to Texas to ramrod the Democratic battle after the party's state convention under Gov. Shivers' leadership repudiated Stevenson and urged all Democrats to work and vote for Eisenhower.

Plane Hits Copco Line; Flier Safe
A Portland aviator narrowly escaped mishap Sunday afternoon when his light plane struck a Copco power line running across the South Umpqua near Myrtle Creek, setting a small grass fire and disrupting service.

Wallace Miles, 41, of Portland was circling for a landing on the farm of his brother-in-law and sister, Mr. and Mrs. Edmond Houns, at Round Prairie, just across the river from the Myrtle Grove Camp, when the craft hit and broke a power line, dropping it into dry grass.

Not even realizing he'd struck the line, Miles circled again and landed, Mrs. Houns said. However, he and his passenger, Ted Hanson of Portland, recalled a slight bump while circling.

The grass fire was quickly extinguished about 1 p.m., Douglas Forest Protective Association men reported.

The power line runs across the South Umpqua River, serving the auto court. Service to the court was disrupted.

Camas Valley Area Fire Believed Incendiarism
A 40-acre forest fire, apparently of incendiary origin, was brought under control about 5 p.m. Saturday on Camas Mountain about four miles north of the Camas Valley, Douglas Forest Protective Association men said.

The blaze was apparently started in the old Welty and Rainbath sawmill, which is not in use, DFFPA men reported. It was reported to the DFFPA at 11:30 a.m. Saturday.

Little Worry Seen If Next President Battles Reds As Well As Truman Has, Intelligence Agency Chief Declares

PHILADELPHIA (AP) — Gen. Walter Bedell Smith, head of the Central Intelligence Agency, said Monday if the next president, whether Democratic or Republican, "does as well as President Truman" in fighting communism in the federal government the American people "have little to worry about."

The general made the statement as a witness before an open hearing of the House Un-American Activities Committee which had subpoenaed him to explain testimony he gave on Sept. 29 at the McCarthy-Benton slander and libel hearing that he believed Communists "are so adroit and adept they have infiltrated every security agency of the government."

Smith said Monday that his statement was "predicted on pure theory and past performance." He added under cross-examination by committee counsel: "I would be extremely complacent if I believed that there was

no Communist infiltration in the government."

"I have no political leanings or affiliations. Any future president, Republican or Democrat, is going to have to work with the same security agencies now in existence. Both will have the same difficulties that we now encounter today. If either one of them, the Democrat or the Republican, does as well as President Truman in cooperation with the security agencies in ferreting out subversives, the American people can congratulate each other and will have little to worry about."

Suicide Unit Of Chinese Slaughtered

SEOUL, Korea (AP) — Frenzied Chinese suicide troops with demolition charges tried to blow a hole in the Allied defenses on White Horse Mountain Monday night. South Korean gunfire mowed them down short of their target.

A front line Allied officer said about half a dozen fanatical Reds with satchel charges and Bangalore torpedoes charged up the north slope in complete disregard of their own lives.

They fell with their charges unexploded. Satchel charges are bundles of explosives packed in a satchel-like bundle. Some are covered with a sticky substance so they can be quickly stuck to the target. Bangalore torpedoes are lengths of pipe packed with explosives.

At the same time two Chinese platoons jumped off in a futile attack. The South Koreans drove them back, then launched an assault of their own. At last report they were pushing up the slope of one of three knobs the Reds captured earlier in the day.

As the savage battle for White Horse entered its eighth day the South Koreans were in firm control of the commanding crest.

S. Korean Valor Praised
South Koreans estimate the Reds have lost more than 10,000 killed or wounded. Elements of three Chinese divisions have been used in the bitter struggle.

Van Fleet praised the South Korean troops and said they had done "a beautiful job" against "about the best" Chinese army on the front.

Twenty-six B-29 Superforts from Japan and Okinawa last night pounded a concentration of more than 3,000 Red soldiers, poised for possible front-line duty. The troops were massed on the Haju Peninsula on Korea's West Coast.

Swift F86 Sabre jets tangled with Communist MIG15s near the Yalu River Sunday. The Air Force reported four Red warplanes destroyed and two damaged. That brought the two-day toll to 10 destroyed and two damaged.

Polio Strikes Minister, His Wife, Their Baby
MILTON, W. Va. — Polio has hit hard at the family of a young Presbyterian minister.

The Rev. Meade F. Degges, 26, his wife and their 22-month-old son all became victims of the disease within a few days. The baby, Francis, was rushed from his home in Greenvale a week ago yesterday. Last Friday, Mrs. Elizabeth Degges, 28, came down with the disease.

And on Saturday pastor Degges was taken to Morris Memorial hospital here with the worst form, bulbo-sacral polio.

He was put in an iron lung and a doctor said his condition was critical. Mrs. Degges and the baby were reported in good condition and improving.

CAR PLUNGE FATAL
EUGENE — Henry L. Pleitner, 37, Hayward, Calif., died here Saturday night of injuries suffered the previous night as his automobile plunged off a road 60 miles southeast of Eugene.

The widow, Gladys, 36, is recovering from injuries suffered in the crash.

Fire Death In Bed Blamed On Cigaret
MEDFORD — A fire that destroyed a cabin killed Lonnie Morgan, about 30, near Central Point Sunday. Firemen blamed the death on a cigarette, which Morgan apparently had been smoking in bed. The cabin burned to the ground before firemen arrived.

It was the second weekend fatality in this area. Rudolph George Guiricks, 56, a transient from the Sacramento area, was killed by a freight train Saturday. He was lying on the tracks in Medford when struck.

Poisoning Hits Scores After Republican Rally
LANDER, Wyo. — Seven persons are in three hospitals and scores of others were taken ill with what doctors said was a form of "ptomaine poisoning" following a Republican rally Sunday.

Some 2,500 persons attended the rally and were addressed by Sen. Joseph R. McCarthy (R-Wis.), along with Gov. Frank A. Barrett and Rep. William Henry Harrison (R-Wyo.).

Most of those stricken—officially estimated at about 200—were affected three to eight hours after the baked ham dinner.

DEFENSE HEAD STRICKEN
SALEM — The state civilian defense director, Jack A. Hayes, was in fair condition Monday after suffering a heart attack while working in his yard Sunday.

The hospital said he rested well during the night.

DRUNK DRIVING CHARGE

L. C. Parker, Roseburg, T. L. DeBolt, Winchester, Victims Of Tragedies

Mrs. M. J. Gilpin Faces Charge Of 2nd Degree Murder, Saying She Stabbed Parker In Quarrel

Two men who attended the dance at Tenmile Saturday night are dead from knife wounds.

The victims were named by police and District Attorney Robert Stults as L. C. Parker, 40, Roseburg and Thomas Raymond DeBolt, 30, Winchester. Neither case had any bearing on the other, police emphasized.

The two deaths brings the total to three through violence within less than a week's time in the Roseburg vicinity.

Mrs. Mary Jewell Gilpin, 30, of 325 W. Washington St., admitted stabbing Parker shortly after midnight at her home. District Attorney Robert M. Stults said.

Held for questioning in connection with the fatal stabbing of DeBolt are three Sutherlin persons, Mr. and Mrs. Charley Jefferson Lemmons, and Orville Myers. DeBolt died at Community Hospital about 10 o'clock Sunday night from wounds received sometime between midnight and 1 a.m. Sunday.

A complaint charging 2nd degree murder was filed today against Mrs. Gilpin, Stults said.

The stabbing of Parker, who was a mechanic at a local garage, took place about 12:45 a.m. Sunday during a heated argument at the Gilpin home, according to a signed statement Mrs. Gilpin had given the district attorney, city and state police.

The argument began after she, Parker and an unidentified man had gone to a dance at Tenmile, Mrs. Gilpin said in her statement. The quarrel reportedly was over her dancing with other men.

Later the three started home, but Mrs. Gilpin, according to her statement, and the other man got

Thomas S. Bouse, accused of the bathtub drowning of his wife Ethel Lucille, 40, last Wednesday, was released from Douglas County Hospital today.

He was taken to the Douglas County Jail, and was scheduled for arraignment on a first degree murder charge today in District Court.

out somewhere between Brockway and Winston, taking a taxi to Roseburg. Parker drove back alone.

Parker and Mrs. Gilpin encountered each other again at her home, and the argument continued, she said in her statement.

She then got hold of a hunting knife and stabbed Parker once in the chest, she admitted under questioning.

She left the house and flagged a passing motorist, Wayne Tripp of Roseburg, telling him of the stabbing. Tripp phoned police from a service station. City police also had been called by neighbors after they heard the quarrel.

Mrs. Gilpin's two children, Zack Bill, 11, and Gayle, 13, were in the house at the time of the fight, officers said.

Blood spots indicated the stabbing took place at the rear of the kitchen, according to the police.

The death was due to loss of blood, according to Dr. Homer Harris, director of the Oregon State Crime Detection Laboratory, who performed an autopsy. Parker was dead on arrival at Community Hospital at 1:05 a.m. Sunday.

Parker is the father of six children. The location of five of them was not known. The sixth lives at Drain.

The body was removed to the Roseburg Funeral Home.

Sheriff's deputies and state police are continuing their investigation of the DeBolt case.

Husband, Wife Quarrel
The three persons, arrested by state and Sutherlin police and sheriff's deputies, were held as material witnesses only. Deputy Sheriff Ira Byrd said complaints may be filed today.

According to investigating sheriff's deputies and state police, the stabbing of DeBolt took place on the road to the Tenmile Dance Hall after Mrs. DeBolt refused to

Dad's Gun Kills Deer Hunter

KLAMATH FALLS — A 23-year-old Klamath Falls deer hunter was killed Sunday by a bullet from his father's gun on Little Aspen Butte, 16 miles northwest of here.

Richard Andrew Moore, the victim, was hunting with his father, Vernon Moore, and Raymond Beauchamp, also of Klamath Falls. Deputy Sheriff Willard Ward said the father told him the three were in heavy brush in rugged country and had taken up agreed positions. The father, spotting a deer through his field glasses, fired.

Richard had wandered from his position into the line of fire and the bullet struck him in the throat. He died in about 30 minutes.

Young Moore was the fifth deer hunter to die this year. Two died of heart attacks, one died in a fall and one was fatally wounded.
