'Blood Money' To Chinese Reds Draws Charge

WASHINGTON (AP) - Treasury law enforcement officers that they have beaten down Communist extortion of "blood money" from Chinese in this country - but at a cost of many lives. An enforcement official said the indictment yesterday in San Francisco of the Min San Trading Company and its manager, Tom Hancock, charged on 17 counts of violating foreign assets control regulations by sending \$161,843 through Hong Kong to Red China, would be followed by a number of other similar cases.

Lebanon Hospital 1,000th On U.S. Aid, Dedicated

LEBANON (AP) - The surgeon general of the U. S. Public Health Service Sunday dedicated the Lebanon Community Hospital, the 1,000th hospital project completed in the nation with federal aid. Dr. Leonard A. Scheele, the surgeon general, told a gathering of 270 the most important feature of the national hospital program "is that once a hospital is built, the government has not a single string attached to it, although the construction grant may have covered as much as three-fourths of the cost."

3-Year Contract Let For New Jet Bombers

SEATTLE (AP) - A letter contract calling for nearly three years continued production of B47 medium jet bombers has been received from the Air Force, Boeing Airplane Company announced today. At current rate of production this could mean the Air Force will take delivery of upwards of 1,500 more B47s. The new contract extends Stratofort operations at Wichita, Kan., to mid 1955.

MEDFORD, Mass. (AP) - The man who helped organize America's scientific effort for World War II said Saturday this nation has no push-button weapons that give it overwhelming military supremacy. "True, there are new weapons, but... remember that no weapon can permanently remain an instrument to our advantage alone," Dr. Vannevar Bush said in an address prepared for delivery at the centennial celebration of Tufts College.

Plastic Valve Used In Heart Disease Surgery

WASHINGTON (AP) - A tiny plastic ball is moving back and forth near the heart of a Washington housewife today - marking a possible new chapter in heart disease surgery. The 30-year-old unidentified woman is equipped with a plastic valve of the aorta, the main trunkline of blood from the heart. This is the first surgical attack on record against a heart condition that accounts for about 10 to 15 per cent of deaths from heart disease, the nation's number one killer disease.

CHICAGO (AP) - Sigmund "Sam" Engle, the old fellow who wooed and won an uncounted number of women, was sued for divorce Friday by the lady he once termed his "only true love." The suit was filed in superior court by Mrs. Pauline Leanne Engle. It listed the defendant this way: "Carl Arthur Leanne, Jr., otherwise known as Sigmund Z. Engle, Sam Engle and Number 29157."
