Milk Bill Issue Interest Grows Statement Of Safeway Draws Favor Grocers Say They'd Meet Safeway Cut

The Affiliated Milk Campaign Committee, composed of representatives of many consumer groups throughout the State, expressed jubilation at two announcements of immediate milk price reductions in the event what they call the "fair milk law" is approved and the milk control act is repealed in next Tuesday's general election.

J. L. Sinner, president of Sunny Brook Farms, a major Portland milk distributor, Wednesday made an unqualified promise of lower milk prices if the new milk law is approved by the voters.

Safeway has also published a pledge that it will immediately reduce milk prices in the Portland and Salem markets, with other communities to follow as soon as possible.

Claim Knockout Blow

The pledge from Sunny Brook Farms and Safeway could prove a knockout blow to the opponents of the proposed new milk law, declared D. R. Dimick, Roseburg, member of the State Committee of the Affiliated Milk Campaign Committee.

"We men and women who have fought many years for a better milk law," he said.

Death Mystery Investigation Continues

Georgia Lang Is Last Seen With 2 Men

Police Now Quizzing Acquaintances Of Slain Girl To Obtain Clues

Police have established that Georgia Lucille Lang was last seen alive in the company of two men, one of them dressed in a sailor's uniform, District Attorney Robert M. Stults said today.

State police have been investigating the girl's death following discovery of her nude and decomposed body Thursday north of Oakland.

The body was definitely identified as that of the missing 19-year-old girl through examination of the teeth by her dentist.

The district attorney said the last report police have had of the girl was about 6:30 p.m. April 9, the night she vanished. Mr. and Mrs. Everett E. Perry, Winston, who had known the girl, reported talking to her on the street. She was alone then. Later, while the Perrys were sitting in a restaurant, they saw Miss Lang walk by with the two men, officers learned.

Examines Body

Dr. Homer Harris, director of the state crime detection laboratory, returned to Portland Friday afternoon after examining the body. Stults said he would make laboratory tests to determine whether a concussion brought the death.

He made no report on how long the girl had been dead, but police assumed she had been killed the night she disappeared.

The district attorney also disclosed that Miss Lang's clothing had apparently been moved several times before police found a dress hanging on an apple tree and other parts of the clothing scattered about. Police received reports that the dress had first been seen on the ground near a fence. The manner in which the dress had faded gave support to the report, Stults said.

Police also had reports that a pair of men's pants were found in the area. Officers, however, did not find them in a thorough search Thursday.

Investigators were running through a list of "a dozen or more" names of boy friends of the dead girl.

"We're checking everyone who knew her," Stults said. "The names were being furnished by relatives and friends of Miss Lang."

Cloverdale Sues North Roseburg Sanitary District

The North Roseburg Sanitary District was named defendant in two Circuit Court suits, one of them asking \$200,000 damages for loss of value of Cloverdale Park interests as a result of the district's refusal to accept sewage from Cloverdale.

Cloverdale Water Co. is plaintiff in one suit, while the other was filed by Pacific Development Co., which holds a 40 per cent stock interest in the Cloverdale property.

The Pacific Development Co. says its property holdings decreased \$200,000 because the sewage has backed up into Cloverdale's sewer mains as a result of the district's refusal.

On Nov. 5, 1951, the company's complaint alleges, the district "without warning refused to service or accept sewage" from the Cloverdale system.

The Cloverdale Water Company's complaint asked \$60,000 compensation for the Cloverdale sewer system taken over by the district when Cloverdale was annexed July 24, 1951.

The complaint alleges the district took over possession of the sewer system without condemnation proceedings and without compensation.

Log Hauler Dies From Injuries

Earl Floyd Wilson, 28-year-old Oakland logger, died Friday in a Roseburg hospital from injuries suffered when he was crushed by a log which rolled off a truck onto him.

The self-employed logger was injured at the Sunrise Lumber Co. mill, Wilbur, Friday morning.

Wilson was born in Myrtle Point Dec. 17, 1922. He had been a resident of Oakland for the past six years. He had lived in Oregon all his life, with the exception of service with Co. B, 1302 Engineers in Africa and Europe during World War II.

Surviving are his widow, Thelma; two daughters, Joanne, and Martha Ann; his mother, Mrs. Grace Burch, Myrtle Point; three brothers, Thomas, Manley and Harry, all of Springfield; four sisters, Mrs. Margaret Whorey, Springfield, Mrs. Maxine Crump, Portland, and Mrs. Lois Baehler, Powers, and Mrs. Hazel Rice, Redmond.

Funeral services will be held at 3:30 p.m. Monday in the Community Church in Oakland with Dr. Morris Roach, Roseburg First Presbyterian Church, and Dr. Homer Noble, Oakland Presbyterian Church, officiating.

Interment will follow in the IOOF Cemetery in Oakland. Stearns Mortuary, Oakland, is in charge of arrangements.

Guards Mop Up After Prison Riot

Ohio State Inmates Fire Buildings In Attempt To Escape

COLUMBUS, O. (AP) — Ohio penitentiary officials — mopping up after a six-hour million-dollar Halloween riot by 2,000 convicts who didn't like their food — made ready Saturday to move 200 prisoners to other Ohio prisons.

Warden Ralph W. Alvis said the transfer was necessary to meet the emergency created by the destruction or serious damage of eight prison buildings, including the commissary, mess hall and kitchen.

The warden faced a problem in feeding the more than 4,000 convicts. He solved it temporarily by arranging to give them sandwiches for breakfast.

The warden asked Gen. Albert Henderson, the Ohio adjutant general, to hold his 600 Ohio National Guardsmen on stand-by alert to meet any new threat on Friday night's rioting.

Furnishings Wrecked

Furnishings and equipment, even in cellblocks, were beaten into wreckage.

A quick-shooting guard slightly wounded a state highway patrolman along the side of the head. The patrolman had not been given clearance to climb the wall.

No one else was injured. No prisoner escaped. No guard hostage was taken.

Milling convicts, spurred to anger by the needling of ring-leaders, threatened for a time to attempt a mass escape over the prison's 30-foot wall. Thirty-five grim guards, armed with sub-machine guns, stood their ground. Somehow the escape attempt, if it was in the convicts' minds, never jelled.

Quickly the state and city marshaled forces, pouring 250 guards and officers into the flaming prison compound. Six hundred Ohio National Guardsmen, rounded up from Central and Southern Ohio,

Candidate Claims 'Dirty Politics' In Harvey Article

Charge that an article by Paul W. Harvey, Jr., Associated Press writer, constitutes a "new low in dirty politics on the Oregon level," is made in a statement issued today by Walter A. Swanson, Democratic candidate for congressman from the Fourth Congressional district.

Swanson states his intention of legal action against newspapers in which the article was published. The candidate's statement is as follows:

"I have this morning read the column in The Oregonian of Saturday, Nov. 1, under the byline of Paul Harvey Jr., staff writer for the Associated Press. This is obviously a new low in dirty politics on the Oregon level. It is an attempt to divide the Democratic party in Lane County and assure a victory for Mr. Ellsworth in the 4th Congressional District.

"I was warned that a 'Halloween' prank was to be played on my campaign on Tuesday of this week, and to prepare myself. My informant by phone was vague as to the source of his information. I was led to believe that it was to start from some Democratic employees of the Republican owned Register Guard, daily paper in

18 Patients Die In Nursing Home Fire; 36 Hurt

HILLSBORO, Mo. (AP) — Eighteen elderly patients died last night as fire roared through a three-story nursing home here.

Most of the dead were trapped on the third floor of the stone structure. Other bodies were found a floor below.

A nurse first discovered the blaze about 5:45 p.m. as sparks and smoke came from a ceiling of the first floor between the main building and an annex.

The fire spread quickly up stairways and along corridors as attendants tried to get the 85 residents, several of them invalids, out of the building.

Hillsboro Fire Chief Richard King said the blaze apparently began in the men's wash room on the first floor. He made no damage estimate on the main building, which he called a total loss.

At least 36 other residents were reported injured. They were taken in ambulances to hospitals in the St. Louis area. Those not hurt were moved to rest homes in the area.

Mrs. Mary Carron, 81, Crystal City, Mo., said she was sitting in a chair toward the rear of the second floor of the main building, saying her rosary, when she noticed dense smoke.

Coal Miners Sign Contract For Pay Hike

John L. Lewis Gets \$1.90 An Hour, Subject To Approval Of WSB

WASHINGTON (AP) — John L. Lewis and hard coal operators signed a new contract Saturday raising the wages of 65,000 anthracite miners \$1.90 a day effective Nov. 16.

The new contract is subject to approval by the Wage Stabilization Board which recently chopped 50 cents off a similar agreement reached by Lewis and the soft coal industry.

The new hard coal contract was announced by Thomas Kennedy, vice president of the United Mine Workers, and Edward G. Fox who led the operators' negotiating team.

They told newsmen that all money benefits in the new contract, with the exception of increased payments to the union's welfare fund, have been applied to the wage structure and not to fringe benefits.

The agreement was worked out in a session which lasted until nearly midnight last night.

The WSB after studying the soft coal contract ruled that only \$1.50 of the increase was permissible under anti-inflation policy.

The decision, now under appeal, touched off a strike which ended only after President Truman asked Lewis to call it off. The miners were called back to work with the understanding they would get the other 40 cents of their daily wage boost demand, if and when the WSB approved.

The hard coal industry, concentrated in eastern Pennsylvania, has avoided a strike. An interim agreement gives the union a boost from 30 cents to 50 cents a ton in the employer-paid royalty to the UMW's anthracite welfare fund.

Plane Wreckage Found; Three Occupants Perish

BEND, Ore. (AP) — Wreckage of a light plane was found south of here at dawn Saturday and state Police said its three occupants were dead.

The plane had been hunted since dusk Friday when the Redmond airport failed to raise it by radio to answer a query on the weather.

The pilot was identified by police as R. G. Fimetel of Berkeley, Calif. Officer Ray Hafstad said passengers were listed as John N. Earl of Walnut Creek, Calif., and C. H. Morgan of Pasco, Wash.

Candidates Make Swing Through East

Peace, Prosperity, Korea, Communism, Corruption Issues

Dwight Eisenhower and Adlai Stevenson sprinted toward Tuesday's finish line Saturday like long-distance runners "kicking" in the stretch, pounding at peace and prosperity, Korea, communism and corruption.

Gov. Stevenson, the Democratic nominee, swung from New York into Ohio, Indiana and his own Illinois—states with a total of 110 electoral votes. It takes 266 to be elected president.

Gen. Eisenhower, the Republican candidate, made the same trip, but in reverse and by plane instead of whistle stopping train.

Eisenhower makes a television appearance Saturday night from New York, where Stevenson spoke Friday night, and Stevenson speaks Saturday night at Chicago stadium where Eisenhower talked Friday night.

Activity Quickens

As they shifted arenas, activity quickened in both camps and, from both sides, there were predictions of victory—some cautious, some confident.

President Truman, who an aide said is now sure the Democrats will win, headed through Indiana and Illinois to St. Louis for his climactic speech of the campaign.

Truman said Saturday, in a speech prepared for Terre Haute, that GOP vice-presidential nominee Richard Nixon's \$18,000 expense fund was raised by a "millionaires club" which thought his votes in the Senate were "worth a little subsidy."

Truman said he left it to the voters to judge whether the fund was "ethical or not."

Nixon defended the fund in a dramatic radio-television appearance more than a month ago, saying it was used to finance expenses he felt should not be charged to the taxpayers. The California senator said none of the contributors sought any favors from him.

Demands Income Report

Almost daily recently, Democratic National Chairman Stephen A. Mitchell has been demanding that Nixon make public his income tax returns, as the other major candidates have done.

A prediction of a Republican victory came from Sen. Robert Taft, who lost the GOP presidential nomination to Eisenhower and then joined the general's campaign. Taft, speaking Saturday in Toledo and Sandusky, told newsmen in Cleveland Friday he thinks Eisenhower will win—"perhaps by a large vote."

Nixon and Sen. John Sparkman of Alabama, his Democratic opponent for the vice-presidency, pinned their speeches Friday to the issue of Korea. They took verbal potshots at each other's running mates.

Eisenhower, in his Chicago speech Friday night, put Korea at the top of his list of key issues. He said he had no "magic military wand" but intended nevertheless to go to Korea if elected.

Nameplate Use Unauthorized, Misleading In Advertisement

Use of the nameplate of The News-Review in an advertisement by the Affiliated Milk Committees of Oregon on page 2 of the second section of today's edition is unauthorized and misleading.

The advertisement cleverly avoids placing The News-Review in the position of endorsing the Milk Production and Marketing bill, but conveys the implication that this newspaper, by favoring milk "reform" also favors the bill.

The News-Review has made no recommendation either for or against the bill. It has been the effort of The News-Review to explain the bill objectively. The News-Review has been criticized because it defended "motives" of Safeway in fighting for the principle of competition. That matter, however, had no bearing upon the issues of the bill itself, but was erroneously construed by some opponents of the milk bill to indicate endorsement. Perhaps we should have equally commended the fight of the industry to fight for its principles, but that fact seemed too obvious for mention.

The News-Review, we repeat, has made no recommendation either for or against the milk bill and does not do so. The use of our nameplate was not authorized and is misleading.
