Reizenstein dates back to the turn of the century. Born in Iowa City, Iowa, Feb. 7, 1880, he came with his parents to Oregon City as an infant. He was 14 years of age when he moved to Roseburg.

He obtained his education in the Roseburg schools and the pioneer Dilworth Academy, a private school operated by the Rev. Mr. R. B. Dilworth. The school was located on property now occupied by The First Christian Church, opposite the county courthouse.

Reizenstein served as a postal clerk under two Roseburg postmasters, W. H. Fisher and William A. Frater. In 1900 he began work as a reporter with The Roseburg Review, published by Lee Wimberly.

Following the election of President Woodrow Wilson, Reizenstein was appointed postmaster at Roseburg, serving in that capacity for nine years. It was during that period The Evening News and The Roseburg Review were consolidated into The Roseburg News-Review. Reizenstein reentered newspaper work after leaving the post office and has been with The News-Review continuously for the past 27 years.

Ten years ago he started his "Levity, Fact, Rant" editorial feature, one of the most widely quoted paragraph editorials originating in Oregon.

He was married June 6, 1914, to Hilda McCurdy, who retired a few years ago after long service as librarian of the Roseburg Public Library. Mr. and Mrs. Reizenstein make their home on Fowler Street.

N. Y. City Faces Bus Strike Threat

NEW YORK (AP) — Millions of New Yorkers resigned themselves today to the prospect that the biggest bus strike in the city's history would start at midnight.

The New Year's Eve walkout of eight privately owned bus systems has been set by the CIO Transport Workers Union in a wage-hour dispute.

The eight companies take in about 3 1/2 million fares a day, and are separate from the vast city-owned subway, elevated and bus system.

The board of estimate, in proposing arbitration, declared it would not alter its opposition to an increase in bus rates, which generally are 10 cents. The companies have listed a fare hike as one means of meeting the union's demands.

The main issue in the dispute between the union and the private companies is the union's demand that the 44-to-48-hour week be cut to 40. In addition to the hours cut — with no reduction in take-home pay — the union demands a pay increase of 25 cents an hour. Current pay ranges from \$1.66 to \$1.73 an hour.

Fate Of Doomed Spies May Reach Ike's Hands

NEW YORK (AP) — The fate of the doomed atom spies Julius and Ethel Rosenberg possibly may rest eventually with Gen. Dwight D. Eisenhower as president.

Or an appeal for executive clemency may be decided by President Truman before he leaves office.

The New York City couple is scheduled to die in the electric chair the week of Jan. 11. Eisenhower does not take office until Jan. 20.

Ole G. Nelson Funeral Dated

He later resided in Washington then came to Winlock, Oregon, in 1915. He moved several years ago to Myrtle Creek, where he made his home until moving to Roseburg 20 months ago.

Surviving are the widow, Clara Frances Nelson, Roseburg; a son, Norman A. Nelson, Los Angeles; three daughters, Mrs. Olga Skarr, Thief River Falls, Minn.; Mrs. M. C. Olsen, Hopkins, Minn.; and Mrs. Ella West, Sacramento. He also leaves three sisters.

Funeral services will be concluded at the IOOF cemetery in Myrtle Creek.

Policemen In Bad Shape, Examination Reveals

LOUISVILLE, Ky. (AP) — A physical checkup of policemen here recently disclosed that 14 per cent were physically incapable of performing satisfactory police duty. Safety Director James E. Thornberry reports.

Of the 438 policemen examined, 184 were overweight, 116 had unsatisfactory blood pressure, 87 had below-par vision, 25 were wholly or partially color blind and 79 had defective hearing.

Thornberry blamed low police pensions for the high percentage of unqualified officers. Of the 62 men termed unsatisfactory, 46 had already reached the age of 51, which is in the retirement bracket.

Senator Morse Spurns Bid To G.O.P. Caucus

WASHINGTON (AP) — Sen. Wayne Morse of Oregon has rejected an invitation to attend an organization meeting of Republican Senators Friday.

Morse said he would not attend because "that conference is for Republicans. I'll have to hold my own caucus and keep my own counsel."

Wilson Duo Soon To Know Fate

PORTLAND, (AP) — The fate of Utah and Turman Wilson, brothers under sentence to hang early Saturday in Washington's state penitentiary, may be decided within a few hours or be held in abeyance until Friday, Governor Langlie said Tuesday.

The brothers now are living out their fourth stay of execution since they first were condemned in the summer of 1950 for the kidnap death of JoAnn Dewey of Meadowdale, Wash., near Vancouver.

Their last stay was granted in August to give a committee time to study the case and make a recommendation to the governor. The report has been submitted to the governor but Langlie said he had not finished his study of it. He said he might make the report public.

He has received a flood of appeals for clemency for the brothers and one petition, purportedly bearing 14,000 signatures, was due to reach his desk in Olympia sometime Wednesday.

parents and since the course of study is based on a nine-month period, it is the recommendation of the County Department of Education that such lost time be made up," Barneburg's letter states. "It appears necessary that we should obtain full value for every dollar spent and that the school program be planned accordingly."

"Regardless of the cause, if we're holding school for the kids we'd better make it up," Barneburg says. The statute Barneburg feels is being misused is Chapter 236 Oregon Laws of 1949.

Barneburg isn't asking districts to make up the days lost over the last four years. But "from now on let's make them up," he concludes.

he had talked to Eisenhower about the matter — and to Benson by telephone — and that he had decided not to oppose confirmation. Young said both the general and Benson had assured him they are for price support at 90 per cent of parity through 1954, as provided under the present law.

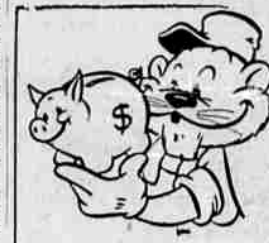
The senator said Eisenhower has "an open mind" as to how the matter should be handled after that, and that Benson had promised to study the problem.

Taft Predicts Harmony — Taft said he believed Eisenhower's main purpose in arranging the meeting was to assure the Senate leaders of his wholehearted cooperation, adding he had "every expectation" Eisenhower and Congress will work together harmoniously.

Taft said the conferees went over the whole field of possible legislation, including whether wage-price controls should be continued beyond April 30, when the present law expires. He added there had been no conclusions and "no indication of policy as yet" regarding controls.
