

Rotarians Tell Of Convention Thursday Noon

Five Roseburg Rotarians gave reports on the recent convention of Rotary International in Seattle when the local club met for its weekly session Thursday noon at the Hotel Umpqua.

President Percy Croft, newly elected President Roland West, John Runyan, Cliff Norris and Walt Malory reported on different aspects of the annual session.

Croft reported on speeches by Rotary's president and a Canadian newspaper editor and talks by exchange students sponsored by the club's foundation. West told of visiting Navy ships, of a meeting with various club presidents and presidents-elect, and of a meeting of jewelers.

Runyan told of a "Northwest Cavalcade," a sectional dinner and of entertainment by the Eugene Gleeman. Norris reported on a speech by Sec. of State and Rotarian John Foster Dulles. Malory told of the international aspect of the convention. Fifty-three counties were represented by 8,000 delegates.

Before the members made their reports, Bill Carstens was welcomed as the junior member of the Roseburg club. Jim Powers presented him with a pin which had belonged to Carstens' father, the late Henry T. Carstens.

School Board Member and Rotarian Harold Hoyt made a short appeal to members for support of the district budget which will be voted on next Monday. He termed the new proposal a "maintenance" budget, stripped of all allocations for modernization and future expansion of school facilities.

children. The district may join with one of the following: Roseburg, Glide, Myrtle Creek, Dillard.

The situation came about when all four districts refused to accept tuition students from the small farming district. One 14-year-old girl this year stayed out of school because she had no place to go.

Adding to the complication, Roberts Creek had steadfastly refused to consolidate with one of the larger districts.

Because the district contains assessed property valuation of only \$170,000, addition of the district also was unattractive to the larger districts.

The Glide School Board still has to act on the proposal offered by Evans. The board meets Monday night. Chairman of the board, Howard Hatfield, was present at the hearing.

About 20 persons, the majority of the Roberts Creek voters, also appeared.

County School Supt. Kenneth Barneburg said after the hearing that the Roberts Creek petition for consolidation with Glide already has been filed. He said the Glide petition should soon be ready.

Commercial and non-commercial floats will vie Saturday at 10 a. m. for a sweepstakes trophy in the annual parade. Cash prizes will be awarded the three top floats in each of the divisions. The posse, several saddle clubs and bands will fill out the procession.

Sunday morning, a cowboy breakfast is set at the fairgrounds under the sponsoring hands of the posse auxiliary. Breakfast will be served between 7 and 11 a. m.

At 1 p. m. Sunday, all Douglas County owners of registered saddle horses have been invited to display their stock in the arena in front of the fairgrounds grandstand.

The posse again this year is offering a \$3,500 purse to rodeo performers. In each of six events, \$500 will be split among winners and runners-up. The extra \$500 will be divided equally among the first place winners in bareback riding, saddle bronc riding, bull-dogging, calf roping and bull-riding. The other event, in which no extra prize will be offered, is team roping.

Entry fees, in addition, will be split among winners.

the area after a call from Dillard that Murphy was in the area and was armed. Murphy's wife, Esther, who is housekeeper at the Paul B. Hult residence at Dillard, was afraid her husband was dangerous, Baird said.

Murphy received a mental hearing before County Judge Carl C. Hill, doctors and attorneys Monday in Roseburg. At that time, the man was put on probation on condition he go to his son Marvin's home in Yakima, Wash.

Murphy was told, Judge Hill said, that he would be committed to the state hospital if he returned here. Murphy agreed to leave, the judge said.

Wednesday, Murphy returned from Eugene with Mr. and Mrs. Ed Jobe, who did not know of the hearing. They also did not know Murphy was armed until they reached Roseburg. They notified Mrs. Murphy that her husband was at the Peterson residence.

Dist. Atty. Robert M. Stults said Friday morning he was investigating the advisability of holding an inquest in connection with the death. At that time, no decision had been made.

Murphy was born at Bertha, Minn., on Oct. 28, 1908. He was a member of the Moose Lodge at Yakima, the Teamsters Union 524 at Yakima and Lumber & Sawmill Workers Union 2940 at Roseburg.

Survivors include his wife, Esther; his father, Charles Murphy at Crosby, Minn.; a son, Marvin at Yakima; a daughter, Mrs. Mildred Arent of Seattle; two stepchildren, Mrs. Betty Mazor of Detroit, Mich., and Donald Prickett at Yakima; three brothers, Lawrence of Carlos, Minn., Harold of Minneapolis and Lester living in California; two sisters, and three grandchildren.

The body will be shipped to Yakima for funeral services and interment. The Chapel of the Roses, Roseburg Funeral Home, is in charge of local arrangements.

Sharp Increases Noted In Highway Traveling

SALEM (AP) — Automatic traffic counters at 14 points in Oregon recorded sharp increases in motor travel during May as compared with last year, the secretary of state's office reported Thursday.

A continued increase is expected through the summer.

Highest gain was at the recorder west of The Dalles on Highway 30's water grade route where volume last month was 54.7 per cent higher than for May, 1953.

Marked increases were also noted on Highways 99-W north of Monroe, 97 near Bend, 101 south of Reedsport, 58 near Oakridge, 22 east of Gates, 30 at Troutdale, 26 near Gresham.

Glendale Lets Contract For Earth-Fill Dam

The City of Glendale has let a contract for the construction of an additional earth-fill storage dam across Section Creek above the city and the digging out of a reservoir behind it, reports Glendale correspondent Mrs. G. B. Fox. The reservoir is expected to have a holding capacity of approximately 500,000 gallons of water. Cost will run between \$400 and \$450, according to the price of pipe which will be required for the job, officials say. Day and Mehl, contractors, will do the job.

Guatemalan Revolt Against Reds Seen As Exiles Mass Along Border Of Honduras

TEGUCIGALPA, Honduras (AP)—A possible move to mobilize pro-Arbenz forces in case of a revolt. Dispatches from Guatemala said 100,000 laborers were expected to parade through the streets of Guatemala City.

Here in the Honduran capital, armed khaki-clad men—apparently recruits for the exile resistance movement directed from here by Carlos Castillo Armas—continued to leave the city, presumably for the border.

A two-engine transport plane with drawn curtains airlifted a dozen men out of Tegucigalpa last night. The group carried side arms and lugged a radio and several wooden crates aboard.

Reports from censorship-blanketed Guatemala said authorities there were reading a massive public demonstration today. Ostensibly this was to show solid support for the government, but observers here also interpreted it as

Crescent City Man Dies From Accident Injuries

A Crescent City, Calif., man, injured in an accident last Saturday, today became Douglas County's 13th highway fatality of the year.

Alfred Bettencourt, 40, died at Myrtle Creek Hospital of injuries received when a tractor fell off a truck on Highway 99 about a mile north of Myrtle Creek.

Coroner L. L. Powers said death was due to a compound multiple skull fracture. Death came at 6:30 this morning.

Bettencourt was traveling with his wife and a hitchhiker, James Route of New Orleans, La., when the mishap occurred. Mrs. Bettencourt was not hurt. Route received a leg injury.

Seriously injured was Roy Morgan of Riddle. He received chest and shoulder injuries when the falling tractor clipped his car and sent it out of control. The tractor landed directly on the Bettencourt car.

State police said the D-2 Caterpillar fell off the Interstate Tractor and Equipment Co. truck when a binder chain broke. The truck was driven by Paul E. Redifer of Roseburg.

Bettencourt's body was to be removed to Crescent City Funeral Home for services. Ganz Mortuary, Myrtle Creek, was in charge of local arrangements.

Indian Theater Bills CinemaScope

Douglas County's first CinemaScope is scheduled in Roseburg.

It will be introduced here with the first film ever made in the new type of movie-making-making, "The Robe."

CinemaScope with full four-channel stereophonic sound will run at the Indian Theater for a full week.

The announcement comes on the heels of a report from the management of the new outdoor theater, the Starline, south of Roseburg that it will have facilities for the CinemaScope showing also.

The Indian Theater management, countering the Starline Theater statement, said that "only in an indoor theater" can "all the lifelike quality and power" be captured.

CinemaScope in full four-channel stereophonic sound will be shown on a curved widescreen. The Indian management states the sound angle has been solved by placing 13 loud speakers in the theater. Ten of these speakers have been installed in the auditorium itself and three more in the main sound channel behind the screen. Thus, if a charioteer and his horses come galloping out of the screen, the chariot sound will fade away behind the audience as it would in real life.

CinemaScope with full four-channel stereophonic sound is a process it has taken 10 years to perfect. It took another two years to film "The Robe."

Oregon Check Passers Held In Washington

MONTESSANO, Wash. (AP)—Three men wanted in five states on check-writing charges were in police custody Friday, thanks to the alertness of a store employe and a rookie policeman, plus the cooperation of Aberdeen newsmen.

Although the story started to develop two weeks ago, Police Chief Matt Sullivan noted Thursday in a statement praising the press that it was not made public until the men could be caught.

Sullivan said two brothers, Everett, 28, and Allen Overholser, 31, Newport, Ore., were held here, and Arthur Bilyeau, the third man, at Portland, as a result of the cooperative effort. The Overholser brothers were arrested June 4 and Bilyeau this week.
