

Planned Crippled Children's Center Holds 3 Purposes In Care, Research, Training

The purpose of the mammoth rehabilitation hospital center to be built at Glide is seen as threefold by those who have been working towards its realization.

According to George Campbell, Portland, of the Oregon Society for Crippled Children and Adults, it will encompass actual patient care, research and training.

Need for such a center has long been felt, Campbell said. As added proof, he points to the proposed rehabilitation program of President Dwight D. Eisenhower. The President in a message to Congress cited the fact that at least 200,000 Americans yearly are not getting the rehabilitation care they need. The reason, the President noted, was lack of adequate facilities.

"That number of 200,000," Camp-

bell stresses, "increases the same amount each year." And he calls it a figure that is fast reaching prodigious proportions.

Campbell and E. G. High, district representative for the Oregon society, give these primary purposes for the new center:

1. Actual Care. The most important of the three, they say. The work will be with individuals of all ages. It will include care of cerebral palsy victims, those with multiple sclerosis, muscular dystrophy, polio. They emphasize rehabilitative care will cover almost any physical malady.

2. Research. It is the plan now to bring in the finest staff members available. And money will be no barrier since the financing of the hospital by the field force of the nation's largest health and accident insurance company is assured. The men believe that the staff members and younger surgeons training with them will be constantly engaged in a variety of research projects.

3. Training Of Administrators. Campbell says that the lack of administrators to handle the business end of rehabilitation centers is appalling. Through the new Douglas County center he hopes that many capable individuals will receive administration training. Ultimate goal he adds, will be the establishment of countless smaller centers throughout the world.

All of these important points must wait, of course, until the hospital center is erected, Campbell says. But he adds that the future work of the Harry K. Coffey Memorial Hospital for Crippled Children and Adults staggers the imagination.

"This is an undertaking so vast," he says, "that I can think of no sure way of telling anyone just how really big it is."

Campbell praised the efforts of the many citizens who have worked to make the hospital center more than "just a plan on paper." Most of all he spoke of the individual efforts of High who has worked on the project for 14 years.

Lumber Walkout Picture Unchanged

The Northwest's lumber strike continued unchanged Thursday with a couple of small negotiation sessions at hand in the wake of total failure in large sessions.

At Eugene Thursday, as at Portland the day before, an effort of the Federal Mediation Service to lead an employer group and the unions toward a settlement got nowhere.

The Willamette Valley Lumber and Sawmill Workers were in the Eugene session. The AFL, as had the CIO the day before, proposed arbitration. The Willamette Valley operators, as had the employer group at Portland, said no and proposed that the unions negotiate strictly on a local basis. The AFL, as had the CIO, said no. Mediator George Walker of Portland said he had arranged a meeting at Prineville Thursday for the Ochoce Lumber Co. and its employees and one at Redmond for Friday between the Ponderosa Lumber Sales Co. and its employees.

Chinese Refuse American Protest Of Air Incident

LONDON (AP) — Red China has refused even to accept a second American protest against the shooting down of a British airliner off Hainan last month, diplomatic officials said Thursday. Three Americans were among 10 persons killed in the attack.

(In Washington, the State Department said that Britain has notified it that Red China has "rejected" the American protest. Refusal to accept it would amount to rejection.)

The U. S. State Department disclosed July 29 that the Peiping regime had contemptuously turned down American protests on both that incident and a subsequent fighter attack on two American rescue planes in which the attackers were shot down.

The protests were relayed by British Charge D'Affaires Humphrey Trevelyan. The Chinese would not accept them from his hand. Informants here said Trevelyan had sought anew to deliver Washington's protest, but the Communists refused for the second time even to consider it.

The United States does not recognize Red China and has no diplomatic dealings with the Peiping government.

U. S. Secretary of State Dulles said Tuesday the Chinese had put themselves in the wrong by refusing the protests.

Contents of the latest American note were not disclosed by Dulles. He made it plain, however, the note took up the point made by the Chinese in their broadcasts that the Hainan incident had nothing to do with the United States since the airplane was British.

Convicted Murderer Admits Oregon Thefts

BLOOMFIELD, Iowa (AP) — One of two men found guilty of first degree murder in the death of a Iowa farmer confessed a long series of burglaries and petty crimes, some in Oregon, in a statement in district court here Wednesday.

He is William G. Karston, 29, Hamilton, Ill. He and his half-brother, Almer Anderson, 22, South St. Paul, were to be sentenced Thursday for the robbery-killing of Wendell W. Jones last week.

His statement was read at a pre-sentence hearing. Among things he admitted were burglaries of three Seaside business places and a Hammond supermarket, from which he said he obtained \$400 to \$500, and being frightened away from the planned robbery of a Newport freight terminal. He said these things all took place in 1953.

BLM Sales Bid Over Appraisals

A Bureau of Land Management sale of approximately 20 million board feet of Douglas County timber brought roughly 30 per cent more than appraisal values in Roseburg Wednesday.

Bad Vladimiroff, timber management assistant, said the five tracts were sold at a total price of \$388,178.20.

The first tract, located about 10 miles east of Glide, contained 7,883,000 board feet appraised at \$108,633.60. It sold to the North Umpqua Timber Co., Roseburg, for \$152,638.60. H. G. Powell, who bid on every tract, was the other bidder. Douglas fir was appraised at \$13 and sold at \$20.

Woolley Lumber Co., Drain, paid \$130,548.20 for 7,975,000 board feet on a tract between Elkton and Drain. It was appraised at \$129,789.50. H. G. Powell was again the other bidder. Douglas fir sold at 10 cents a thousand above the appraised price of \$16.90.

The third tract of 2,296,000 board feet located in the Camas Valley area went to Trico Lumber Co. for \$69,697.10. Douglas fir in this tract went at an amazing \$20 per thousand over the appraised price. A total of 26 bids ran the appraised price of \$11.40 up to \$34.50 per thousand. Total appraised price was \$29,390. Other bidders were: Stebbinger Lumber Co., Sun Studs, K. A. Spears and H. G. Powell.

The only sealed sale drew eight bids. Total volume on the tract in the Myrtle Creek area was 97,000 board feet appraised at \$13,253. It sold to Round Prairie Lumber Co. for \$21,386.80. Douglas fir was appraised at \$11.20 and sold at \$21.

Other bidders were: Sun Studs, Trico, Stomar Lumber Co., Skeels Logging Co., Heath Bros., Marona Logging Co. and Powell.

The last tract, in the vicinity of Yellow Creek east of Tyee, included 986,000 board feet appraised at 7,180.60. It sold to Trico for \$14,065.50. Taking part in the 26 bids made were C. H. Davidson and Powell. Douglas fir appraised at \$7.30 sold at \$14.25 per thousand.

Pioneer Family Member Passes

A member of a Riddle pioneer family, Mrs. Hattie Thompson, about 73, died Thursday morning at Forest Glen Hospital, Canyonville, according to Mrs. W. E. Best, Riddle correspondent.

Mrs. Thompson, whose name was Logsdon prior to marriage, was hospitalized in June with a broken hip. Her husband, Lewis, died about three years ago.

Among the survivors are a son, Elzie Ash of Grants Pass, a brother, C. E. Logsdon of Riddle, recently a resident of Roseburg; and a sister in Chicago, Ill.

Funeral arrangements will be announced later by Ganz Mortuary, Myrtle Creek.

Oregon's Idle At High Level

Job Compensations Largest For July

SALEM (AP) — Oregon's unemployment total continues near record summer levels, with the State Unemployment Compensation Commission announcing Wednesday that its July payments of \$1,008,812 were the largest for July in history.

The commission estimated 37,500 persons are hunting for jobs, plus 25,000 others who are idle because of labor disputes.

The estimate of 37,500 unemployed has been exceeded only once before at this time of year. That was in 1949.

The total was 36,900 a month ago, and 24,900 last year.

Unemployment edged higher in the Portland area, and around Astoria, Coos Bay, Bend, Eugene, Salem, The Dalles and Tillamook.

The commission said bean and other late harvests would ease the picture in other areas later this month.

The July benefit total of \$1,008,812 compared with the previous July high mark of \$831,104 in 1946.

About half of last month's benefits were paid to residents of the Portland area, while Eugene was in second place.

Workers in labor disputes can't draw benefits, so only about 20 per cent of last month's payments went to employees in the lumber industry.

Weekly claims are running almost 50 per cent ahead of a year ago, and about the same as those in the summer of 1949.

She has made stops at both Los Angeles and Whittier, Calif., to visit cousins. When she arrived at the DeGroots, she found still another, Mrs. DeGroot's sister, Mrs. J. W. Brown, of San Manuel, Ariz.

Miss Finsson will sail for home Sept. 6 from New York City.

Oakland Approves Protection Pact

Oakland City Council members have approved a contract providing the Martin Bros. Box Co. with fire protection, reports News-Review Correspondent Edith Dunn.

The Oakland firm will pay \$100 each year as a stand-by fee, Mrs. Dunn says. They will pay \$20 for each call and \$20 for each hour spent fighting fire.

Council members also have discussed the matter of improving a city street with state funds. Selection of Fifth Street, from Locust to Spruce Streets, was made, according to Mrs. Dunn.

In other action concerning Stearns Park, the council okayed the city's proposed installation of water and lights at the park. The county will put in tables, barbecue pits and sanitary facilities, Mrs. Dunn said.

Nationalists Claim Transfer Of Red Army

TAIPEH, Formosa (AP) — A former Chinese Nationalist news agency said today a Communist army has been shifted to China's coastal Fukien Province opposite Formosa.

There was no official confirmation of the report distributed by the Interior Ministry's Tatu News Agency. It said the information came from underground contacts on the Red-held mainland.

The U. S. 7th Fleet guards Formosa from attack and top officials in Washington reportedly agree privately that the United States would go to war in the event of a major Red attack.
