Elegant Duchess Of Kent To Make Visit To America

LONDON (AP)—The elegant Duchess of Kent, "Aunt Marina" to Britain's Queen Elizabeth II, this month achieves a lifelong ambition—her first American visit. With her 17-year-old daughter, Princess Alexandra, she flies Saturday for Quebec and will remain in Canada until Sept. 14, when the pair will go to New York. They leave New York by ship Sept. 22 for home.

The duchess always has been a great traveler. At 47, she still is high on the lists of the world's best-dressed women.

In her clothes, in her travels and in friendships unusual for British royalty, the duchess has sought to hide the pangs of a broken heart.

She came to England in 1934, the fiancée of Prince George, younger son of King George V. The prince had wooed his slender Greek princess at a Balkan house party. The goddess called it a royal love match—and this time they were right.

Their Westminster Abbey wedding was a fairy tale affair. The young prince and his bride, the Duke and Duchess of Kent, seemed supremely happy. Soon a family came along—two boys and a girl. And then came World War II. On Aug. 25, 1942, with his younger son barely 7 weeks old, the Duke of Kent was killed on active service with the Royal Air Force.

For months Marina pined alone. Finally old Queen Mary gave her a talking to. The widowed duchess emerged from her mourning to take an ever-growing share of royal responsibility and an ever-

warmer place in British hearts. After the war, she made frequent trips to her two sisters in Germany. At the same time she began to renew acquaintance with her dead husband's friends—people like Noel Coward, Sir Laurence Olivier and Vivien Leigh, and conductor Sir Malcolm Sargent, grand-uncle of British music.

She lives simply. She is far from rich. Sometimes she does her own shopping at the local village store.
