

Diem Defeats Ex-Emperor In South Viet Nam; Union With N. Sector Faces Snag

SAIGON, South Viet Nam (AP) — Premier Ngo Dinh Diem, landslide winner in a popularity plebiscite over absentee chief of state Bao Dai, will proclaim South Viet Nam a republic and himself its first president, it was reported today.

Diem, one of Asia's most resolute anti-Communists, dug Bao Dai's political grave with a referendum Sunday in which the Vietnamese overwhelmingly rejected the playboy Emperor and chose the Premier chief of state.

Authoritative sources said Diem would proclaim Wednesday a holiday, announce the official election returns, and in the presence of the Cabinet, diplomats and a large throng preside at the formal birth of the republic with himself as president.

He will remain premier as well until after the election of the first National Assembly, expected before the end of this year.

For the first time in modern history the Vietnamese were given the chance to vote in a national election and nearly five million turned out. No major violence was reported anywhere.

By U.S., Britain Another referendum probably will be held next month to approve the constitution.

The U.S. State Department has already said it will recognize the election outcome. Britain and France are believed certain to do likewise.

But new trouble between the Western Big Three and the Soviet Union loomed as a result. The overwhelming vote of confidence in Diem appeared to rule out any possibility of uniting elections in North and South Viet Nam next July, provided by the Geneva armistice and vigorously opposed by Diem as long as the Communist North cannot guarantee free and unfettered voting.

Sherry Fong On Trial Second Time For Murder

PORTLAND (AP) — Sherry Fong, 24, Monday went on trial for the second time. She is charged with first degree murder in the death of Diane Hank, a Portland high school girl.

In the first trial both she and her husband, Wayne Fong, were convicted. But Circuit Judge Alfred P. Dobson set aside the verdict on grounds that the jury had not given the case adequate consideration.

A new trial was ordered and their attorney asked that the two be tried separately. Wayne Fong is to stand trial later.

Miss Hank, 16, disappeared after spending the night of Jan. 6, 1954, at the Fong home. Her body, trussed in blankets, was found in a roadside ditch in Southwestern Washington the following month.

Three-County Group Boosts Bank Credits

United States Shows Big Foreign Aid Drop

WASHINGTON (AP) — United States net foreign aid dropped 760 million dollars in the 12 months ended last June 30. The total net foreign aid spending figure was 4 1/2 billion dollars.

Reporting this Sunday night, the Commerce Department attributed the decrease to a 28 per cent decline in military aid. Most of this drop affected Western European countries.

Non-military aid reversed a five-year downward trend and increased by 23 per cent during the 12 months.

Salem Aviator Escapes Injury In Plane Crash

SALEM (AP) — Harry Ried, Salem, escaped uninjured Sunday when he crash-landed his light plane in a mint field a few miles north of here.

He said the plane's engine failed as he was coming in for a landing at the Salem airport after a flying trip from Newberg. He tried to land on the new Salem Expressway but the rudder of the plane was torn off when he struck a power line.

He glided the plane half a mile and landed safely, although the plane overturned when it hit a ditch in the field.

Saar's Rejection Of Europeanizing Poses Grave Crisis

SAARBRUECKEN, Saar (AP) — French Premier Faure and German Chancellor Adenauer moved swiftly Monday to counter a crisis brewing between their two nations as a result of the Saar's 2 to 1 rejection of the plan to Europeanize the rich industrial valley.

Faure and Adenauer exchanged telegrams expressing their conviction that the outcome of the Saar plebiscite Sunday must not be allowed to upset relations between France and West Germany.

But already the vote had toppled the Saar's pro-French premier and heightened demands

State Demands Death For Bomb Case Widow

McMINNVILLE (AP) — The State of Oregon Monday will demand death in the gas chamber for Mrs. Marjorie Smith, 34-year-old mother of two children.

She is on trial for first degree murder here, accused of murdering her husband, Kermit Smith, Dist. Atty. William Langley said the prosecution in its opening statement will call for the maximum penalty.

Victor L. Wolf, 45, a handyman whose wife lived in a rooming house owned by Mrs. Smith, has admitted he wired a bomb in Smith's car last April 21. The car was blown apart in a Portland golf course parking lot when Smith touched the starter button.

Wolf, who has confessed in court, said he committed the slaying at Mrs. Smith's urging and because he was her "love slave." He said they planned to collect Smith's \$2,000 life insurance and start life anew in Alaska.

Mrs. Smith, who is pleading innocent, has denied all this. Her attorneys have characterized Wolf as "an unfortunate person who apparently dreamed that Mrs. Smith wanted to have her husband done away with."

Jury: 9 Men, 3 Women The trial is being held in this little Willamette Valley town of about 6,000 because Mrs. Smith's attorneys said their client could not get a fair trial in nearby Portland where the case has received extensive newspaper coverage.

Current Judge Arlie Walker is trying the case before a jury of nine men and three women. Some 53 prospective jurors were excused, more than half of them because they opposed the death sentence.

Throughout the selection of the jury last Thursday and Friday, Mrs. Smith was generally calm, showing only occasional nervousness.

Her grandmother, Mrs. Anna Witterin, 82, of Portland, said she planned to attend the trial and "stand by" her granddaughter.
