Mixed Reactions To Results Attained At Conference Expressed By Participants

WASHINGTON (AP)—Oregon, Washington and Alaska participants in the White House Conference on Education headed home Friday with individual reactions ranging from "disillusioned" to strong support.

The disappointment was registered by an Alaskan who said he felt the same conclusions could have been reached by any two persons sitting down together for an hour.

"Instead," he continued, "we've gassed for three days and spent 1 1/2 million dollars. Where is our sense of values?"

The delegate asked that he not be identified, but added:

"I'm not bitter—just disillusioned."

Other participants were more hopeful. Nearly all expressed confidence the conference would result in an increased national awareness in education's problems.

Thomas L. Scanlon of Portland, Ore., the director of research and education for the Oregon State Federation of Labor, said it would do much to clarify public thinking which previously because of "so much talk has been generally confused."

Scanlon said his only criticism would be the lack of opportunity for participants to discuss in open session the recommendations reached in roundtable discussions.

T. J. Cole, superintendent of schools in Sitka, Alaska, said he thought publicity resulting from the conference would create discussion of school problems at the city and state level.

He particularly emphasized the benefit he expects to accrue from participation in the conference by noneducators.

"People like ourselves (professional school people) have been crying, yapping and howling for years about our problems with no effect," he declared. "When the people back home realize that two-thirds of the conference participants are noneducators and leaders in their field, it will give us a better selling point."

Harold Shefelman of Seattle—attorney, member of the State Board of Education and chairman of the state's Little Hoover Commission—said the "major accomplishment" had been to "familiarize people with the problems and the realization that these problems exist everywhere."

He said it was "unquestionably the best organized and most efficiently run" large meeting he has attended. He praised the "earnestness" of the participants and said he felt the conference "accomplished all anyone had the right to expect of a meeting of 2,000 persons."

Douglas School Choses Musical Play 'Oklahoma'

Mrs. McLaughlin first contacted the New York City law firm representing Richard Rodgers and Oscar Hammerstein II Sept. 2. She received official authorization a few days ago. The school will pay a royalty for the show.

Casting will start as soon as the music arrives. Mrs. McLaughlin said. She expects to announce the cast before Christmas.

Tickets will go on sale well in advance of the performance to take care of expected requests, she added. A March 1 performance of "Oklahoma" will be given if ticket demand requires it.

Dramatics in the play will be directed by Miss Laura Grubbs, drama instructor at the school. The orchestral accompaniment will be arranged and conducted by hand Director Jim Everly.

Miss Helen McGuire, Douglas senior, will direct dancing. Last year Douglas High School's musical production was "Sweethearts."

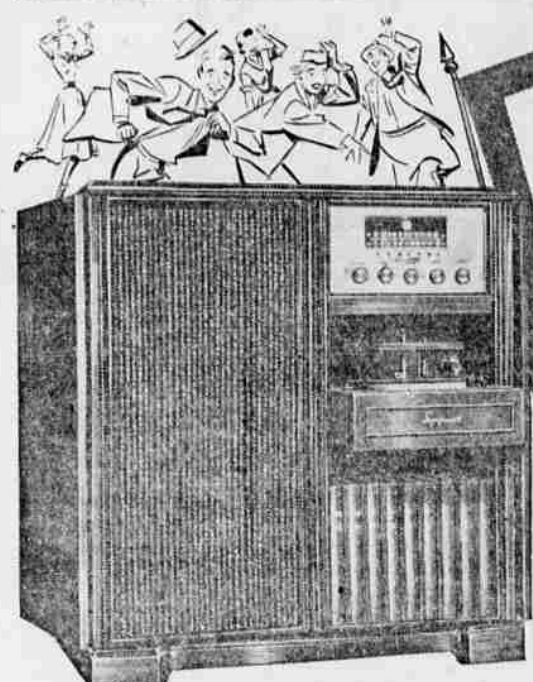
