

Responsibility To All State U. S. Senator's Major Duty, Governor Patterson Asserts

Personal Political Theories Secondary, Statement Of His Declared Candidacy Stresses

SALEM (AP) — Republican Gov. Paul Patterson of Oregon announced Saturday he would run for the U. S. Senate seat held by Democrat Wayne Morse.

Patterson, who inherited the governorship Dec. 17, 1952, when ex-Gov. Douglas McKay was appointed secretary of the Interior, is a staunch supporter of President Eisenhower.

Morse also will seek re-election. He was elected in 1944 and 1950 as a Republican, but became a Democrat after the election of President Eisenhower.

Patterson's statement said: "I will be a candidate for the Republican nomination for United States senator.

"The issues in this campaign are clear. There are fundamental differences between my political philosophy and that of Sen. Wayne Morse.

"A United States senator must be responsible to all of the people of his state, regardless of their political affiliations or their economic interests.

"He must never abandon that responsibility to further his personal political theories. Oregon must be represented in the United States Senate by one whose actions faithfully and consistently reflect the beliefs of the majority of her citizens. I will direct my energies to that end.

"The people of Oregon have elected me governor. This is my job. My duties are demanding and time consuming. I shall use the time and energy remaining to take directly to the people my beliefs, my stand on issues, and my record of service to Oregon."

In the May 18 Republican primary, Patterson will oppose State Rep. Elmer Deetz, Canby dairyman, who launched the successful effort to repeal the 21-year-old state law which allowed the state to fix milk prices and set production quotas for dairy producers.

This law was defeated by the people in 1934. Patterson, however, is an overwhelming favorite to beat Deetz.

Patterson has been pressured by many Republican leaders to run against Morse. Some of these leaders regard him as the only hope the GOP has of defeating Morse.

So far, Morse has no opposition in the Democratic primary.

Patterson and Morse, despite being bitter political foes, have several things in common. Each is 55 years old. They are lawyers and members of the Congregational Church, and each has a wife and three children. Each has a keen mind, and they are skilled debaters.

After being graduated from the University of Oregon law school in 1928, Patterson settled in the rural town of Hillsboro to practice law. He served four seasons in the State Senate from 1945 to 1951. In the latter year, he was Senate president, placing him first in line of succession to the governorship.

After inheriting the office from McKay, Patterson served two years before seeking election to a four-year term. This was the first time he ever ran for statewide office.

Successful Legislator

In the 1954 primary, he easily won the nomination, being Secretary of State Earl T. Newberry 140,211 to 51,991.

In the general election, Patterson scored another easy win, beating Joseph K. Carson Jr., Democratic former mayor of Portland, 222,522 to 144,179. In that election, Oregon, for the first time in 40 years, elected a Democrat to the U. S. Senate—Richard L. Neuberger.

He has had good success with the Republican-controlled Legislature. The 1955 Legislature passed his proposals for higher state income taxes, higher unemployment benefits, and creation of a water resources board to referee disputes over uses of water.

Morse first was elected by a 95,000-vote margin in 1944. In 1950, he was re-elected by 269,000 votes.

The big issue of the campaign will be the Eisenhower-McKay policy of building power dams in partnership between government agencies and power companies.

Patterson favors this policy, but Morse bitterly opposes it.

If Patterson is elected to the Senate, State Senate President Elmo Smith, John Day weekly newspaper publisher, would succeed him, serving the remaining two years of the term.

The deadline for filing candidacies is March 9.

tion requesting the water company to take steps to fluorinate the water. But Oregon Water Corp. refused to do so without authority of an ordinance. Legality has been questioned ever since.

The Douglas County Medical Assn. went on record early in 1952 urging that the water supply have fluoride added to it. In April 1955, the Umpqua District Dental Society did the same.

Among other proponents is the State Board of Health. Some time ago, the state health officer reported, "To curtail one of the most prevalent diseases of man, dental caries, the Oregon State Board of Health strongly urges each community with a fluoride-deficient water supply" to fluorinate its water.

Russia's Phony 'Friendship' Bid Rejected

WASHINGTON (AP)—President Eisenhower Saturday turned down in effect, a Soviet proposal for a 20-year United States-Russia friendship treaty but left the door open for further talks between the two countries.

The White House made public Soviet Premier Bulganin's message to the President earlier this week, Eisenhower's reply and the draft of a friendship treaty which the Soviet premier had enclosed.

Bulganin proposed that the United States and Russia agree "in conformity with the provisions of the charter of the United Nations to settle all their international disputes by peaceful means."

Eisenhower said in reply that "the present state of international tension" has been brought about by the Russians and "was not prevented by the words of the (United Nations Charter)."

"How can we hope that the present situation would be cured merely by repeating these words (of the charter) in a bilateral form?" The President asked Bulganin.

He went on to say: "I wonder whether again going through a treaty-making procedure, and this time on a bilateral basis only, might indeed work against the cause of peace by causing the illusion that a stroke of a pen had achieved a result which in fact can be obtained only by a change of spirit."

Actions Demanded

Eisenhower then called on the Soviets to show by their actions that they really want peace.

Specifically, Eisenhower urged Bulganin to join the West in "prompt measures to re-unify Germany in freedom within the framework of security and to carry out such other steps as to bring about the Eisenhower 'open sky' program of mutual aerial inspection of armaments."

In these and other ways, the President said, the United States is "prepared at a moment to move in a spirit of conciliation."

"May I hope," Eisenhower told the Soviet leader, "from your letter that you, too, are dedicated to the great end I shall look forward to receiving a further expression of your views."

mants say Eisenhower and Eden will discuss every problem of common interest in the world.

1. Eden would like to relax trade controls and expand commerce with Red China and the Communist bloc generally. Eisenhower is described as strongly opposed.

2. Eden would like to bring the long struggle over seating Red China in the United Nations to an end, although he may not press the issue forcefully since this is an election year here. Eisenhower is on record as strongly opposed to Red China's U. N. membership.

3. Eden wants American support in his argument with Saudi Arabia over the Bahraini oasis and surrounding land which may produce oil. Eisenhower had resisted becoming deeply involved. The United States has a huge investment in oil lands which Saudi Arabia controls.

4. Eden would like to see some kind of agreement to "restrict and regularize" tests of atomic weapons. Eisenhower does not foresee the possibility of such agreement, although Dulles said recently that the United States also would like to have it. He said no formula which would surely work had been found.

West Coast Phone Co. Plans Big Bond Sale

PORTLAND (AP)—The West Coast Telephone Co. plans to sell five million dollars worth of bonds and stock to finance new construction in the Pacific Northwest.

Ray Dalton, Everett, Wash., vice president, said the company has asked Oregon and Washington authorities for permission to sell \$3,500,000 of first mortgage bonds and \$1,500,000 of \$1.24 dividend series preferred stock.

Dalton said more financing would come later.

He said the firm plans \$4,939,000 in construction for Washington, \$3,128,000 for Oregon, and \$142,000 for California.

Morse Launches Attack On Natural Gas Bill

WASHINGTON (AP)—Sen. Morse (D-Ore.) Monday described a controversial natural gas bill as a "producer raid on consumer pocket books" and said that, unfortunately, there is no prospect of its passage.

President Eisenhower will veto it.

He said former President Truman "saved the gas consumers of the nation" when he vetoed a similar bill in 1950 but that "there is no such prospect for a presidential veto if it should become necessary."

Morse's Senate speech marked the start of a three-week debate on a bill that would exempt natural gas producers from direct federal regulation.

The legislation, in slightly different form, squeaked through the House last year by a 209-203 vote.

PARSIPPANY — TROY HILLS, N. J. (AP)—Investigators questioned relatives today in a continued effort to learn why William Bauer, 48, killed six members of his family with a shotgun and then took his own life.

Morris County Prosecutor John D. Collins said that, to all intents, the case of the shooting rampage by the 48-year-old chughoer is closed on a verdict of homicide and suicide.

Bauer, a civil engineer described by neighbors as a kindly and devoted family man, used a 12-gauge shotgun Friday to slay his wife, two children, his wife's two parents, his own mother, and finally himself. The family had been preparing to go to Florida for a two-week vacation.

Bomber, 4 Men Aboard, Missing In Snow Area

SAN BERNARDINO, Calif. (AP)—A missing B28 light bomber carrying four men from Goodfellow AFB, San Angelo, Texas, was still sought Monday in the snow-covered San Bernardino Mountains.

The plane was en route to Norton AFB here last Thursday when it reportedly had only 30 minutes of gasoline left. Ranchers soon afterward reported hearing a crash.

Crews searched the Ivanpah Mountains along the California-Nevada line, 150 miles northeast of here, after an air pilot reported seeing part of an "SOS" light signal flashing in that area Friday night.

No trace of the plane was found there however.
